THE WITNESS PROVIDED RING CAMERA FOOTAGE IN WHICH THE DEFENDANT IS SEEN ON YESTERDAYS DATE AT APPROXIMATELY 9:06 PM, GRAB THE VICTIM (HER 3 YEAR OLD SON) WITH BOTH HANDS, LIFT HIM FROM THE GROUND AND THROW HIM TO THE FLOOR. 

WHILE EXITING THE CAMERA VIEW. A SECOND RING CAMERA VIDEO TAKEN AT APPROXIMATELY 09:44 PM, SHOWS DEFENDANT PUSH VICTIM IN THE CHEST CAUSING THE VICTIM TO FALL BACK AND HIT THE FLOOR. IN A POST MIRANDA RECORDED INTERVIEW, DEFENDANT IS SHOWN THE RING CAMERA FOOTAGE AND ADMITS TO BEING THE PERSON IN THE VIDEO. DEFENDANT DISCLOSES THE REASON WHY SHE PUSHED HER SON WAS PUNISHMENT FOR INSISTING ON GOING TO THE PLAYGROUND. DEFENDANT WENT ON TO SAY THAT THE SON WAS BEING DIFFICULT AND UNCOOPERATIVE. I OBSERVED REDNESS ON THE VICTIMS RIGHT CHEEK AND RIGHT FOREHEAD ALONG WITH BRUISING ON HIS RIGHT FOREARM AND LEFT KNEE. SCRATCHES WERE ALSO OBSERVED ON HIS STOMACH AND ON HIS BACK. VICTIM LATER DISCLOSED TO OFC. PINERO THAT THE DEFENDANT HAD SCRATCHED HIM. PICTURES OF THE INJURIES WERE TAKEN AND IMPOUNDED. DEPARTMENT OF CHILDREN AND FAMILIES (DCF) WAS CONTACTED AND ASSUMED INVESTIGATION UNDER CASE 2023-343034-01. DEFENDANT WAS TRANSPORTED TO TGK.
