AMENDMENT NO. 1 TO AGREEMENT NO. 47725A BETWEEN THE LOS ANGELES DEPARTMENT OF WATER AND POWER AND PAUL HASTINGS, LLC

This Amendment No. 1 (Amendment) to Agreement No. 47725A (Agreement) is made and entered into by and between the City of Los Angeles, a municipal corporation acting by and through the Los Angeles Department of Water and Power (LADWP) and Paul Hastings, LLC (Paul Hastings) who are referred to under this Amendment as "Party" and collectively as the "Parties."

WHEREAS, on May 24, 2022, LADWP approved the Agreement under the Board of Water and Power Commissioners authority for Paul Hastings to provide specialized legal services to assist LADWP in advice and representation in the matter "*Antwon Jones v. City of Los Angeles*" and related matters, and ancillary cases for a term of two years with one one-year optional renewal period for an amount not to exceed \$750,000; and

WHEREAS, the Parties are amending the Agreement for the purpose of increasing the Agreement amount by \$1,500,000, from \$750,000 to \$2,250,000; and

NOW, THEREFORE, BE IT RESOLVED that for good value and consideration including mutual exchange of promises, the Parties agree to amend the Agreement as follows:

1) Subsection V.A. <u>Appropriation of Funds</u> previously read as:

"The Los Angeles Department of Water and Power has appropriated Seven Hundred Fifty Thousand dollars (\$750,000) for this Agreement..."

Subsection V.A. Appropriation of Funds is hereby amended as follows:

"The Los Angeles Department of Water and Power has appropriated Two Million Two Hundred Fifty Thousand dollars (\$2,250,000) for this Agreement..."

Except as herein amended above, and as previously amended, all other terms and conditions of the Agreement shall remain in full force and effect and are incorporated herein as if fully set forth.

This Amendment may be executed in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same. The parties further agree that facsimile signatures or signatures scanned into .pdf (or signatures in another electronic format designated by LADWP) and sent by e-mail shall be deemed original signatures.
