## INDICTMENT

The Grand Jury charges:
COUNT ONE: (18 U.S.C. § 1366(a) - Destruction of an Energy Facility)
On or about December 8, 2022, in the Northern District of California, the defendant,
PETER KARASEV,
did knowingly and willfully damage the property of an energy facility, that is, a PG\&E transformer, located at or near 5361 Thornwood Drive in San Jose, California, and attempted to cause and caused a significant interruption and impairment of a function of that energy facility, all in violation of Title 18, United States Code, Section 1366(a).

COUNT TWO: (18 U.S.C. § 1366(a) - Destruction of an Energy Facility)
On or about January 5, 2023, in the Northern District of California, the defendant,

## PETER KARASEV,

did knowingly and willfully damage the property of an energy facility, that is, a PG\&E transformer, located at or near 6105 Snell Avenue in San Jose, California, and attempted to cause and caused a significant interruption and impairment of a function of that energy facility, all in violation of Title 18, United States Code, Section 1366(a).

COUNT THREE: (18 U.S.C. § 844(h) - Use of Fire or an Explosive to Commit a Federal Felony)
On or about January 5, 2023, in the Northern District of California, the defendant, PETER KARASEV,
knowingly used fire and an explosive to commit a felony which may be prosecuted in a court of the United States, namely, the destruction of an energy facility in violation of Title 18, United States Code, Section 1366(a), as charged in Count Two of this Indictment.

All in violation of Title 18, United States Code, Section 844(h).
FORFEITURE ALLEGATION: (18 U.S.C. §§ 844(c), 981(a)(1)(C), and 982(a)(2)(B) and 28 U.S.C. § 2461(c))

The allegations contained in this Indictment are re-alleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Sections 844(c), 981(a)(1)(C), and 982(a)(2)(B), and Title 28, United States Code, Section 2461(c).

Upon conviction of the offenses set forth in Counts One and Two of this Indictment, the defendant,

## PETER KARASEV,

shall forfeit to the United States of America, pursuant to Title 18, United States Code, Section 981(a)(1)(C) and Title 28, United States Code, Section 2461(c), any property, real or personal, which constitutes or is derived from proceeds traceable to the offenses.

Upon conviction of the offense set forth in Count Three of this Indictment, the defendant, PETER KARASEV,
shall forfeit to the United States of America, pursuant to Title 18, United States Code, Section 982(a)(2)(B), any property constituting, or derived from, proceeds obtained, directly or indirectly, as a result of such violation(s), and pursuant to Title 18, United States Code, Section 844(c) and Title 28,

United States Code, Section 2461(c), any explosive materials involved or used or intended to be used in the violation.

If any of the property described above, as a result of any act or omission of the defendant:
a. cannot be located upon exercise of due diligence;
b. has been transferred or sold to, or deposited with, a third party;
c. has been placed beyond the jurisdiction of the court;
d. has been substantially diminished in value; or
e. has been commingled with other property which cannot be divided without difficulty,
the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 28, United States Code, Section 2461(c).

All pursuant to Title 18, United States Code, Sections 844(c), 981(a)(1)(C), and 982(a)(2)(B), Title 28, United States Code, Section 2461(c), and Federal Rule of Criminal Procedure 32.2.
