
Upon arrival, two adult females were on the front porch. [REDACTED] could not calm down and was having difficulty breathing. William Shields was in the residence upstairs laying on the ground drinking a glass of water. William was extremely intoxicated. While EMS spoke with [REDACTED] I spoke with [REDACTED] who stated she was in her room eating. Once she was done she brought her plate to the kitchen where [REDACTED] and William were arguing about dinner. [REDACTED] was trying to put her plate int he sinks and William would not allow her to do so. He got up in her face and began yelling. [REDACTED] was hit in the cheek. [REDACTED] did not see what William hit her with but she began to have pain to the cheek.

William used both his hands grab ahold of [REDACTED] by her throat causing pain and making it difficult for her to breath. The fight then went to the ground where she stated he wrapped her up with his legs and using all his weight making it difficult to breath. [REDACTED] believes had she not defended herself and got a way she would of went unconscious.

Both [REDACTED] and [REDACTED] were seen by EMS. [REDACTED] had pain to her left cheek and a scratch on her left arm. She requested to be transported to BMH by EMS for Medical treatment. [REDACTED] stayed at the residence and stated that this has been going on for a year. They still live together but have separate bedrooms. [REDACTED] has [REDACTED] stay with them so she can care for [REDACTED] due to her current health conditions. [REDACTED] [REDACTED] [REDACTED] [REDACTED] stated that William had been drinking all day and has threatened her several times.
