Basis for Jurisdiction

This action is brought pursuant to 50 U.S.C § 3146(f) - Allegation; improper withholding of records; judicial review. The court has jurisdiction over this action pursuant to 28 U.S.C. § 1391(c).

Statement of Facts

In November 2019 the Plaintiff reported a child pornography video to the Department of Justice (DOJ) and also, believing that the video might have been connected to a terrorist group, the Plaintiff also reported it to the Central Intelligence Agency (CIA). Because of the Plaintiff's tip, the CIA and DOJ placed the Plaintiff into a classified mind-control program.

The Plaintiff is unable to sue the United States for violating his rights in the mind-control program, because the Plaintiff's lawsuits get thrown out by judges and called frivolous. All of the records proving that the Plaintiff was in the mind-control program are classified. The Plaintiff tried to uncover these classified records by submitting Freedom of Information Act (FOIA) and Privacy Act (PA) requests to multiple different U.S. Intelligence Agencies, so that he could prove that they have an illegal mind-control program and sue the United States.

The Plaintiff sent multiple different requests to the Office of the Director of National Intelligence (ODNI), CIA, National Reconnaissance Office (NRO), and the National Security Agency (NSA), to try and uncover the mind-control program. All of the Plaintiff's requests were denied.

The Plaintiff alleges that the United States is improperly withholding records that would prove that they were breaking the law and violating his rights. The United States is withholding records, by making them classified, to avoid being held legally accountable for violating the Plaintiff's rights.

Plea for Relief

The Plaintiff is asking the court to order the United States to hand over all records on the mind-control program that he was placed into.


