Violent crime is rising across the United States and law enforcement has worked diligently to find ways to curb the violence. Many cities have spent the last decade developing and perfecting the impact of Real-Time Crime Centers (RTCC) on violent crime. RTCC's are designed to staff personnel who have real-time access to CCTV, live CAD calls, Live911, LPR (license plate reader) data, UAS, and many other tools to help identify and apprehend violent criminals before, or as crime occurs. To provide an effective level of service to its citizens and ensure violent crime is curtailed, the early development stage of a RTCC is recommended. Spokane County's Regional Intelligence Group 9 (RIG9) will provide regional support to its law enforcement partners using Technology and Intelligence-Led Policing strategies.

Benefits of this project include Real-Time Intelligence, Quick Identification & Apprehension of Criminals, Video Evidence Enhancing Prosecution, Assists with Proper Resource Allocation/Management, Return on Investment Savings through Enhanced Efficiency & Lowered Violence, Crime Prevention/Crime Reduction, and Increasing the Community Perception of Public Safety in Spokane County.

There are currently over 200 Real-Time Crime Centers utilized by various agencies throughout the United States, in addition to other formal and informal intelligence centers (National Real-Time Crime Center Association).
