My 2014 and 2016 annual reports inadvertently omitted reimbursements from: (i) the University of California, Berkeley School of Law for expenses to attend a panel discussion in October 2014, and (ii) the Aspen Institute for expenses to attend a Justice and Society seminar in July 2016. In addition, my 2014 annual report inadvertently omitted my salary of \$1,765 from George Washington University for teaching a Federal Sentencing Seminar.

Some of my previously filed reports inadvertently omitted from Part I the following positions: Montrose Christian School, School Board Member (2011), National Institute of Corrections, Advisory Board (2011 – 2013), Council for Excellence, Board of Directors (2015 – 2017), Historical Society of the District of Columbia Circuit, Board of Directors (2015 – 2021). In addition, some of my previously filed reports inadvertently omitted from Part IIIB self-employed consulting income that my spouse periodically receives from consulting on medical malpractice cases. Finally, 529 Plans that are controlled by my daughters' grandparents and not reported to us were inadvertently omitted from Section VII of my previously filed reports.
