Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

ON SUNDAY, DECEMBER 10, 2023, DAVID HAGAL RESPONDED TO THE FRANKLIN LAKES POLICE DEPARTMENT AND REPORTED THAT HE MURDERED HIS FATHER AT THEIR RESIDENCE LOCATED AT [REDACTED] HADDON PLACE, FRANKLIN LAKES, NEW JERSEY. HAGAL WAS SUBSEQUENTLY INTERVIEWED AND ADMITTED TO BLUDGEONING HIS FATHER MULTIPLE TIMES WITH A METAL PIPE, STABBING HIS FATHER MULTIPLE TIMES WITH A KITCHEN KNIFE, AND ULTIMATELY DROWNING HIS FATHER IN A BUCKET OF WATER. HAGAL STATED THAT THE MURDER OCCURRED IN THE SECOND FLOOR BEDROOM AND BATHROOM WHICH WAS LATER CONFIRMED DURING A COURT AUTHORIZED SEARCH WARRANT OF THE PREMISES. DURING THE SEARCH, LAW ENFORCEMENT LOCATED A METAL PIPE AND KITCHEN KNIFE, BOTH CONTAINING SUSPECTED BLOOD, INSIDE OF THE UPSTAIRS BATHROOM.
