Dear Mr. Angelo,

You have contacted the FOIA Public Liaison at the Department of State. The FOIA Public Liaison assists requesters in reducing delays, increasing transparency and the understanding of the status of requests, and assists in the resolution of disputes of their Freedom of Information Act Requests.

I researched your request, F-2019-05476, and can verify that it is currently in process. Upon reviewing the case notes, I see that your request is in the review stage. Please note that Estimated Dates of Completion (EDC) are subject to change and are "strictly" estimates and not intended to be used as "actual" dates of completion, due to various extenuating factors. I am hopeful though, based on reviewing your case, that your request may be at least partially completed prior to the EDC of August 2025.

I apologize for the delayed response, but please be aware that the Department's FOIA program is extremely burdened. Over the past decade, public awareness of FOIA has increased, especially through the release of records online where they can be quickly disseminated throughout the world. During this same time, the number of FOIA requests submitted to federal government agencies has continued to increase, and the number of electronic records identified in response to these requests has grown exponentially. The Department has received thousands of requests annually throughout this period, and the Department's FOIA resources have been overburdened as a result. This burden is evident in the Department's FOIA caseload, which is significantly higher than it was a decade ago. At the end of Fiscal Year (FY) 2020, the Department's backlog was 13,710 requests. At the end of FY 2023, the backlog was over 21,500 requests. This increase in the backlog can be attributed to the marked increase in the number of requests received year-over-year (in FY 2020, the Department received 9,010 requests; in FY 2023, this number increased to over 15,600 requests) and the significant constraints imposed on the FOIA program during the COVID-19 pandemic. Today, the Department has nearly 24,000 pending FOIA requests.
