I searched Viet America Society on the Dun & Bradstreet website as required by CPO to determine its risk rating. D&B gave this organization a supplier risk evaluation rating of 8 (out of 10); 10 is the highest risk.

Also, the address provided by VAS, 17801 Santa Anita Cir in Fountain Valley is a personal residence (as found on Google maps).

The addresses on the following forms don't match:

- 1. Secretary of State Statement of Information (Form SI 100) 11752 Beach Blvd, Stanton appears to be a closed down Seafood Palace
- 2. Secretary of State Articles of Incorporation of a Nonprofit Public Benefit Corporation (Form ARTS-PB 501C3) 17801 Santa Anita Cir, Fountain Valley is a personal residence

I have serious concerns about issuing a contract to this organization that appears to be a home based business and can't verify their non-profit status. Have they been approved by the Secretary of State's office as a non-profit?
