
#### **LOCATION MAP**

The Brightline-Stuart station location is in the heart of historic downtown Stuart in Martin County, Florida. The station is centered between the Miami and Orlando stations, each of which is a 90-minute ride away. The station location is approximately 30 miles north of the West Palm Beach station, which is a brisk half-hour by train. The station is easily accessible from I-95, Florida's Turnpike, and the internal local roadway network. Brightline-Stuart passengers will be walking distance of an award-winning downtown and within minutes of Stuart's pristine beaches, oceanfront resorts, and internationally acclaimed slice of paradise.



#### STUART NAMED #1 "HAPPIEST SEASIDE TOWN" BY COASTAL LIVING

The Martin County Office of Tourism and Marketing is pleased to announce that Stuart has been selected as #1 in *Coastal Living's* fifth-annual, top-ten list of "America's Happiest Seaside Towns." This is the first time Florida has won the prestigious number one spot.



#### **PROPERTY MAP**

The Brightline-Stuart station location includes a 2.35-acre parcel along the FEC rail corridor, just south of Southeast Ocean Boulevard. Currently a surface parking lot, the station site will be deeded to the City of Stuart for station leasing, permitting, and development activities. The site is fully serviced with utilities in place from the City of Stuart and Florida Power & Light.

#### **FUTURE LAND USE & COMMUNITY REDEVELOPMENT**

The City of Stuart has long identified the proposed subject site as the ideal location for a passenger rail station. Originally designed as a historic Flagler railroad town, Stuart has maintained its commitment to the restoration of passenger rail service on the FEC Railway ~ with a downtown Stuart station ~ throughout its planning history. Since the 1990s, the City has detailed this commitment in its Comprehensive Plan, specifically highlighting the subject site for a downtown rail station and assigning a "Downtown" future land use. The site is also in Stuart's Community Redevelopment Area (CRA), which enables the City to use CRA funds through the CRA "Real Estate Development Accelerator" program to help support the development of the station.

#### **REAL ESTATE DEVELOPMENT ACCELERATOR (REDA) PILOT PROGRAM**



- Allows public-private partnerships using Tax Increment Financing (TIF) to leverage private real estate investment opportunities.
- Accelerates redevelopment by attracting large-scale development projects that are catalysts for additional private investment in the CRA.











#### **EXISTING ZONING & ENTITLEMENT INFORMATION**

The station site has been assigned a zoning designation of "Urban General" in the City of Stuart. To accelerate the station development process, the City of Stuart has already initiated preliminary entitlement actions, which are anticipated to be completed in early 2024. Subsequently, zoning approvals for the station building and associated parking garage can be approved administratively through a streamlined process.








#### **TRACK SPACING DIAGRAM**

The Brightline-Stuart site has been carefully evaluated to confirm compliance with the RFP site criteria relevant to track dimensions and adjacency. As illustrated in the map to the right, and pursuant to the drawing provided in Exhibit A of the RFP, the Brightline-Stuart site is:

- Located directly adjacent to and contiguous with the Florida East Coast Railway Right-of-Way (ROW)
- Allows construction of a platform length of at least 500'
- Allows construction of at least 1000' clear capacity track length within ROW directly adjacent to property
- Allows outer limits of track work (on both north and south side) at least 100' away from grade crossings






#### **SITE ACCESS**

The Brightline-Stuart station location is conveniently accessible from the existing roadway network surrounding the site. Vehicles traveling north and south along US-1, I-95, Florida's Turnpike, and beach access roadways have easy options to access the station and parking garage. The entire downtown area has been developed with a "complete streets" design, with on-street parking, shaded sidewalks, and detailed wayfinding signage. The station is adjacent to Stuart's transportation hub that includes local bus service, electric car charging, and Stuart's free downtown tram. The downtown roadway network will be further improved with the construction of a new double-track FEC railroad bridge that will replace the aging single track St. Lucie River Railroad Bridge.





#### **SITE ACCESS**



#### LOCAL ACCESS

The Brightline-Stuart station location is conveniently located in Stuart's central business district, easily accessed by a variety of transportation modes. Stuart's roadway grid provides multiple access points to the station for personal cars and rideshare. The City has already engaged FDOT to secure a rideshare service development grant to offset the cost of station-related trips when service begins. Stuart's free downtown tram service will meet arriving passengers at the station to shuttle them to local hotels and destinations. The downtown street network is pedestrian-friendly, well-landscaped, and offers an easy walk from the station throughout the downtown. For adventure-seekers, water taxis are also available within minutes of the station, hallmarking the Sailfish Capital's charm and destination quality.







#### **SITE CONDITIONS**

The existing site is currently utilized as a surface parking lot with landscaping, drainage, and utilities. The site is directly abutting the FEC Railway corridor along its entire western property line.

Utility providers include the City of Stuart (water, wastewater, and stormwater) and Florida Power & Light.





#### **CONCEPTUAL SITE DIAGRAM**

To illustrate the subject site's capacity to meet the RFP criteria, a conceptual site diagram has been developed utilizing the Brightline-Boca Raton station as a model. The subject site can easily accommodate a roughly 9,000-SF station building with a covered walkway connecting to a 38,000-SF parking structure (that could accommodate up to 450 parking spaces). The diagram suggests a sizable "station square" could enhance the rider experience and help delineate a two-lane station access driveway with 10 spaces for drop-off, ride-share, and other connecting vehicles. As indicated in the diagram, if deemed appropriate, the garage could also accommodate ground-floor commercial/restaurant space with an entry plaza for outdoor seating. Additionally, the diagram illustrates a platform capacity of 860 feet in length as well as a 5,000-SF area for station support facilities (e.g., storage, utility, "back of house").








The Brightline-Stuart station area is one of the strongest sustained development markets in Florida. As Florida's population has expanded, especially post-COVID, Stuart-area property values and investment have skyrocketed. The arrival of Brightline-Stuart will unlock countless opportunities for Brightline to partner with downtown property owners and investors in the robust Stuart development scene.






#### **RIDERSHIP BASE IS EXPANDING**



#### **SELECT HOME SALES 2018-2023**

For decades, and especially in the past five years, Florida's real estate values have outpaced the nation, and this trend is exceptionally true surrounding the Brightline-Stuart station. As capital investment has shifted from across the U.S. into Florida, the Stuart area has become a highly desirable location for domestic and in-state migration. The escalating real estate market bodes well for the potential Brightline ridership base, as higher home prices are consistently correlated with available discretionary income. Maps in this section illustrate the 5-year trend of residential real estate sales of \$400,000 and above, with darker colors highlighting sales exceeding \$1 million. The Brightline-Stuart station is in the epicenter of this investment trend.




#### **STATION-AREA POPULATION**

#### **DEVELOPMENT PROXIMITY**

The Brightline-Stuart station location is wellpositioned to draw sustained ridership from an affluent demographic consistent with a premium rail service. Utilizing TravelTime. com, the maps in this section illustrate the areas within 30 - 45 minute drive times of the Brightline-Stuart station.

Within 30 minutes, the Stuart station is accessible to all of Martin County, southern St. Lucie County (including Port St. Lucie, Tradition, and St. Lucie West), and northern Palm Beach County (including those areas north of Indiantown Road such as Tequesta, Jupiter, and Jupiter Farms).

Within 45 minutes, the Stuart station is accessible from northern St. Lucie County (including all of Hutchinson Island and Fort Pierce) and additional areas of northern Palm Beach County (including areas north of Donald Ross Road such as Juno Beach and Palm Beach Gardens).



#### **STATION-AREA POPULATION**

#### **BRIGHTLINE CORRIDOR DENSITY**

The Brightline-Stuart station is perfectly positioned at the midpoint between the Orlando and Miami stations and within Stuart's long-established, successful downtown. For the region's population, the Stuart location is remarkably accessible for Martin, St. Lucie, and northern Palm Beach county residents traveling from I-95, Florida's Turnpike, or the local roadway network. The population pattern is historically clustered around the FEC Railway along the coast. The popularity of Florida's beaches and historic downtowns continue that trend today, and the population density map to the right illustrates that pattern. Clearly, the Stuart station is central in the growing area north of Palm Beach County. The Brightline-Stuart station, in the heart of the downtown, can easily capture all of Martin County's ridership and the more populated parts of St. Lucie County. Going forward, planned roadway and bridge improvements on the horizon will make it even easier for riders across the Treasure Coast to access the station.





#### **INCOME CHARACTERISTICS**

The Brightline-Stuart station area has some of the highest income per capita households in Florida. Martin County routinely ranks among the wealthiest counties in Florida, which translates into strong potential ridership surrounding the Brightline-Stuart station location.



#### **INBOUND VISITORS**

Stuart's allure as a top destination for domestic and international travelers has been rapidly expanding, especially as post-COVID travel patterns have become established. Visitor data indicates Martin County attracts more than 5.5 million visitors annually. Within Florida, the Stuart area draws 1.1 million visitors per year from South Florida and more than a half-million from the Orlando area. Nearly 700,000 visitors travel to the area annually from outside Florida. The Brightline-Stuart station is a perfect complement to the growing visitor market. To further fuel Stuart's tourism success, an \$800,000 Brightline marketing collaborative has already been funded to develop Brightline-specific itineraries (day trips, weekend getaways, and longer vacations) as well as marketing collateral, digital and social media, and \$200,000 in ticket purchases.





#### BRIGHTLINE-STUART

#### **POTENTIAL COMMUTER RIDERSHIP**

The Brightline-Stuart station location offers an unparalleled opportunity to capture commuter traffic between the northern Treasure Coast counties and Palm Beach County. The dominant commuter flow is southbound, with nearly 30,000 commuters traveling daily from Martin and St. Lucie counties into Palm Beach County. The Brightline-Stuart station can easily capture commuters looking to avoid the highways and "Ride Brighter" to West Palm Beach in just 30 minutes. In the northbound direction, nearly 5,000 Palm Beach County commuters travel daily into Martin County, where the majority of jobs are located within 15 minutes of downtown Stuart. Martin County's Business Development Board, Chambers of Commerce, and Economic Council are strong supporters of the Brightline-Stuart station and eager to promote the service to their members and employees.









#### RAILWAY BRIDGE IMPROVEMENTS

The landmark \$218 million St. Lucie River Railroad Bridge project provides a valuable and immediate example of the successful, collaborative approach envisioned for the Brightline-Stuart station project. This remarkable transportation improvement has resulted from an unparalleled partnership among Brightline, Florida East Coast Railway, City of Stuart, Martin County, Florida Department of Transportation (FDOT), the Federal Government, elected officials, and the Stuart-area community. The replacement of the aging bridge will improve roadway and marine traffic flows throughout the Brightline-Stuart station area, improving safety, alleviating traffic congestion, and facilitating access to the heart of Downtown Stuart.

The timing of the bridge replacement project is especially important for the Brightline-Stuart station, as completion of the bridge replacement would be nearly concurrent with the potential opening of the station. In December 2023, the project received a \$130.5 million Mega Grant through the U.S. Department of Transportation, with matching funding anticipated from the FDOT and additional federal grant sources. This is the type of collaboration and partnership that will hallmark the development of the Brightline-Stuart station.




### FISHING IN "THE SAILFISH CAPITAL OF THE WORLD"

#### **FINANCIAL TERMS**

The site proposed for the train station, drop-off area, and parking garage (consisting of three individual parcels) is currently owned by Martin County. Once the Brightline-Stuart location has been selected, per the terms of the Martin County/City of Stuart Interlocal Agreement (approved December of 2023), the County will deed the property to the City of Stuart, who will be the sole entity for all subsequent station-related leasing, permitting, and development activities. The City intends to lease the property to Brightline at a rate of \$1.00 per year for a maximum period of 80 years (in 20- or 40-year terms with renewals at Brightline's option).

While the entire proposal (station, track work, parking garage, site work, utilities, etc.) should be considered one interconnected "Brightline-Stuart project," it is anticipated the costs will be apportioned as follows:

Cost estimates for this proposal have been developed based upon the Brightline-Boca Raton station example, and it is hoped that with a more detailed site layout and building design, as well as station development experience, actual construction costs may be lower.

It is proposed that project funds would be provided directly to Brightline, who would be the lead entity responsible for all permitting, engineering, design, and construction activities. This will ensure efficient project execution and coordination with railroad operations and other improvements such as the new St. Lucie River Railroad Bridge.

Also per the Interlocal Agreement, the County and the City have already begun to pursue federal and state grants that would help offset the costs of the Brightline-Stuart project. It is anticipated the recipient entity will administer grants received, and grant proceeds would be apportioned among Brightline, the County, and the City based on each party's financial contribution toward the project, with the intent of maximizing grant support of the entire project.

Regarding operations and maintenance, it is proposed that the lease agreement would assign all revenue generated on the station site (e.g., train ticket sales, parking charges, ancillary commercial rents) to Brightline and vest operations and maintenance responsibility with Brightline. This will ensure that Brightline has the flexibility to maintain the site and structures in a manner consistent with other operations and avoid any disruptions.

Additionally, the Martin County Tourist Development Council has authorized \$800,000 for a Brightline Cooperative Marketing Fund for the first three years of service to the Brightline-Stuart station. This funding includes an initial ridership commitment of up to \$200,000 in ticket purchases with the balance of funds available for cooperative marketing activities. It is anticipated that as the project advances, additional private sector parties will come forward to secure bulk ticket purchase arrangements for tourism activities, travel companies, industries and employers with multiple locations along the Brightline system including Stuart (such as aerospace and legal), and event organizers.

## **PROCESS TO TRANSACT**

Following the selection of the Brightline-Stuart proposal, per the City/County Interlocal Agreement (approved in December 2023), Martin County will deed the station property to the City of Stuart. From that point forward, the City will be the sole party for all transactions related to the development of the Brightline-Stuart project, which includes the station, track work, parking garage, and related improvements as appropriate.

The Brightline-Stuart contract (between Brightline and the City of Stuart) will require approval by the Stuart City Commission at one public meeting. The City Commission typically meets twice a month, and the contract will be scheduled for consideration at the earliest available meeting following agreement on terms.

Subsequent project approvals (e.g., site plan, building permits) will be processed though the City on an expedited basis. Necessary preliminary entitlement work is already underway to shorten the development review timeframe and accelerate the delivery of the station.

#### **INTERLOCAL AGREEMENT REGARDING JOINT PROPOSAL TO BRIGHTLINE TRAINS LLC** FOR A TRAIN STATION AND PARKING GARAGE

This INTERLOCAL AGREEMENT ("Agreement"), dated December 12, 2023, is made by and among MARTIN COUNTY, Florida, a political subdivision of the State of Florida, 2401 S.E. Monterey Road, Stuart, FL 34996 (the "COUNTY"); and the CITY OF STUART, a municipal corporation of the State of Florida, 121 S.W. Flagler Avenue, Stuart, Florida 34994 (the "CITY").

#### WITNESSETH:

WHEREAS, Section 163.01 Fla. Stat. (2002), known as the Florida Interlocal Cooperation Act of 1969, provides a method for government entities to cooperate with each other on a basis of mutual advantage to provide services and facilities in a manner that will accord best with the factors influencing the needs and development of local communities; and

WHEREAS, on November 25, 2018, the COUNTY entered into a settlement agreement with Brightline wherein the COUNTY was subject to the potential payment of 50% of the construction costs for a train station built in Martin County by Brightline within 5 years of commencement of Brightline's passenger revenue train service. The CITY was not a party to the settlement agreement; and

WHEREAS, Brightline issued a Request for Proposals for a Train Station including parking, i.e. the Treasure Coast Station Location Project No. 2023-TC-RFP, (hereinafter "RFP") to be located in Martin or St. Lucie County with a December 22, 2023 deadline; and

WHEREAS, the CITY and the COUNTY have agreed to submit a joint proposal to Brightline for a Train Station, Parking Garage, railroad infrastructure, and other infrastructure necessary for compliance with development regulations (hereinafter "Project") to be located on property currently owned by the COUNTY located within the municipal boundaries of the CITY and as more particularly described in Exhibit "A" which is attached hereto and incorporated herein; and

WHEREAS, the CITY and COUNTY have agreed to jointly seek Federal, State and other grants for the Project; and

WHEREAS, the COUNTY retained, at its sole cost and expense, Treasure Coast Regional Planning Council to prepare a proposal for the Project on behalf of the CITY and COUNTY for the Brightline RFP.

WHEREAS, the COUNTY and CITY, recognizing the importance of efficient transportation infrastructure and the need to enhance public accessibility, have acknowledged that a collaborative effort in the establishment and maintenance of a train station and parking garage would result in significant public benefits, improving the quality of life for residents and fostering economic development within the community.

NOW THEREFORE, in consideration of the mutual benefits, the parties do hereby agree as follows:

When applying for any grant(s) from federal, state and/or other granting agencies, the CITY and COUNTY shall ensure that all eligible components of the Project are included in the application(s), and they will make reasonable efforts to file any grant application(s) jointly

7. This Agreement shall become effective upon execution by both parties and filing with the






