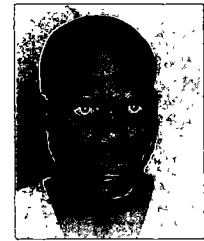

Before me this date personally appeared **ENCINA, TAMARA (17429)** who being first duly sworn deposes and says that on **16** day of **December**, (year) **2023** at **555 SE 1ST AV, FORT LAUDERDALE, FL 33301** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

**On December 16, 2023, at approximately 4:24 PM, BSO Main Jail Deputies responded to 7th floor bravo unit 3 in regards to an unresponsive inmate, later identified as [REDACTED] Deputy Hernandez located [REDACTED] unresponsive on the floor inside cell 3, and bleeding from his mouth while conducting his checks. [REDACTED]'s cellmate, offender Kevin Barnes, was detained and removed from the cell pending further investigation. [REDACTED] was transported to Broward General Hospital in critical condition by Fort**

**Probable Cause Affidavit**

Before me this date personally appeared ENCINA, TAMARA (17429) who being first duly sworn deposes and says that on 16 day of December, (year) 2023 at 555 SE 1ST AV, FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Lauderdale Fire Rescue.

At approximately 6:00 PM, Violent Crimes Detective Petrofsky and I were notified and responded to further investigate.

At approximately 6:35 PM, I arrived at the hospital and met with Doctor Stringefellow who stated that [REDACTED] suffered a left fractured rib, fractured sternum and pulmanery bruising. [REDACTED] was on a ventilater, unresponsive and in critical condition.

At approximately 6:50 PM, I arrived at the Broward Main Jail (555 SE 1st Avenue, Ft. Lauderdale) where I met with BSO Sgt. Williams who explained that there was a surveillance camera directly in front of cell 3 that captured the incident. With his assistance, I reviewed the surveillance footage of the incident. On December 16, 2023, at approximately 4:21 PM, I observed inmate Barnes walking in cell 3. He then walked off to the left side where the toilet is positioned and out of view of the cameras. I did not observe Barnes nor [REDACTED] for the next several minutes. At approximately 4:24 PM, I observed Barnes choke holding [REDACTED] from behind. Barnes held [REDACTED] from behind in this position. Barnes is observed kneeling down still in the same position with only his head in view. Barnes remained in this position for approximately two minutes until approximately 4:26 PM, at which point Barnes let him go and walked away. Barnes paced around the cell for the next ten minutes. During this time, at no point did I observe [REDACTED] on video. At approximately 4:36 PM, I observed Barnes walk to the front door and make a stomp like maneauver with his feet toward the ground where he had Greffard in the choke hold position. Barnes continued to pace around his cell for the next several minutes. At approximately 4:43 PM, I observed BSO Deputy Hernandez walking up the stairs

**Probable Cause Affidavit**

Before me this date personally appeared ENCINA, TAMARA (17429) who being first duly sworn deposes and says that on 16 day of December, (year) 2023 at 555 SE 1ST AV, FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

toward cell 3. He then walked to the front door and looked downward inside the cell. The door to cell 3 opened and Deputy Hernandez located [REDACTED] laying on the the floor against the wall. Additional personel arrived, including nurses, and they began resusitation efforts on [REDACTED]. At approximately 5:17 PM, he was transported to Broward General Hospital by Fort Lauderdale Fire Rescue. It should be noted at no point did Barnes attempt to notify deputies of the victim's condition or attempt to get the victim medical assistance in the almost 20 minutes that elapsed after he choked the victim.

At approximately 8:00 PM, I met with offender Barnes at the jail for an interview. I read Barnes his Miranda Rights and I asked him if he understood them. Barnes stated that he did understand his rights. I repeated to him that he did not have to speak to me if he did not want to. He again stated that he understood. I then asked him if he wanted to tell me what happened. Post-Miranda, in summary, Barnes stated that he was cell mates with victim, [REDACTED]. Barnes explained that he did not agree with [REDACTED]'s lifestyle because he was "gay" and that upset him. Barnes explained that [REDACTED] kicked him first and then Barnes struck him with his closed fists. Barnes admitted that he placed him in a choke hold and later kicked him to see if he was alive. Barnes acknowledged what a choke hold maneuver is and what it can do. Barnes explained that it stops one from breathing. During our conversation, Barnes stated that he was upset at [REDACTED] because he smelled and never cleaned himself. Barnes admitted that he woke [REDACTED] up from his sleep this afternoon and began insulting him and telling him that he needed to clean up and brush his teeth. [REDACTED] then got upset and stood up. Barnes stated he then "turned up", meaning he struck and beat [REDACTED]. Barnes stated that while he was choking and beating [REDACTED] he realized he may and could take his life. At that moment, he chose to

Based on Barnes' Post Miranda confession and surveillance video of the incident, probable cause was developed to arrest Barnes for F.S. 782.051-2 (Attempted Murder) and F.S. 775.085 (Evidencing prejudice while committing offense) due to the fact that he admitted he committed said crime in part because the victim was "gay". This affidavit was submitted to the main jail where Barnes was in custody.


