ON APRIL 16, 2018, BEHAVIORAL SERVICES DIVISION RECEIVED A REFERRAL CALL FROM STRATEGIC INTELLIGENCE DIVISION, IN REFERENCE TO MASON TURNER. IT WAS REPORTED THAT A CONCERNED CITIZEN ALERTED THE FBI, IN REFERENCE TO ALLEGED THREATS MADE BY MASON. ACCORDING TO THE REPORTED FBI INCIDENT SUMMARY, IT TRANSCRIBED THE FOLLOWING (NOT VERBATIM): TRUMP IS A CORRUPT INDIVIDUAL, AND THAT HE SHOULD BE REMOVED FROM OFFICE. MASON BELIEVES POTUS TRUMP IS HIS FATHER, AND HE FORCES MASON TO TAKE DRUGS IN ORDER TO REMAIN SILENT. REPEATEDLY MENTIONED HOW MUCH HE HATES TRUMP AND HE AND OTHERS MUST DO SOMETHING TO GET RID OF HIM. HE BELIEVES VICE PRESIDENT PENCE IS THE TRUE PRESIDENT. IN ADDITION, THERE WERE MULTIPLE EMAILS AND STATEMENTS FROM MASON WHICH MOSTLY CONTAINED A NUMBER OF RAMBLING PARANOID COMMENTS ABOUT PRESIDENT TRUMP AND VICE PRESIDENT PENCE.

THIS INFORMATION WAS FORWARDED TO THE LOCAL FBI BRANCH WHO CONTACTED JUPITER POLICE DEPARTMENT. JUPITER PD OFFICERS, SGT. COUNIHAN, OFC. EROCOLANO

AND OFC. FERGUSON RESPONDED TO MASON'S RESIDENCE, LOCATED 175 WANDERING TRAIL, IN JUPITER TO MAKE CONTACT WITH MASON. UPON THEIR ARRIVAL, THEY SAW MASON OUTDOORS WITH HIS DOGS. MASON REQUESTED TO PUT THE DOGS INSIDE THE HOME, BUT ONCE INSIDE HE LOCKED THE DOOR BEHIND HIM PREVENTING OFFICER FROM ENTERING THE HOME. MASON'S MOTHER, BEVERLY TURNER WAS CONTACTED TO RESPOND ON SCENE TO ALLOW LAW ENFORCEMENT ACCESS TO THE RESIDENCE. WHEN BEVERLY ARRIVED ON SCENE SHE GAVE LAW ENFORCEMENT PERMISSION TO ENTER HER HOME WHERE THEY MADE CONTACT WITH MASON AND DETAINED HIM. SECRET SERVICE AGENT DEER AND AGENT MORELAND RESPONDED ON SCENE AND BEVERLY GAVE LEGAL WRITING AUTHORIZATION FOR THEM TO CONDUCT A SWEEP OF THE HOME FOR WEAPONS, WHICH YIELD NEGATIVE RESULTS.

I (INVESTIGATION DUPLANTIS) RESPONDED ON SCENE AND RECEIVED ADDITIONAL INFORMATION FROM BOTH AGENTS AND OFFICERS. I LEARNED THAT THERE WERE SOME CONCERNS DUE TO THE REPORTED COMPLAINT GENERATED BY A CONCERNED CITIZEN ABOUT MASON. I MET WITH MASON'S MOTHER, BEVERLY TURNER WHO STATED THE FOLLOWING: MASON WAS BACK TO HIS SAME PARANOIA AND STRANGE BEHAVIORS. SINCE MASON WAS RELEASE FROM JFK NORTH MENTAL HEALTH FACILITY, HE HAS BEEN STAYING UP LATE AT NIGHT AND HE BARELY SLEEPS OR EATS. MASON REFUSES TO RECEIVE ASSISTANCE FROM ANY MENTAL HEALTH PROVIDER AND REFUSES MENTAL HEALTH SERVICES REQUESTED BY JFK NORTH. MASON ALSO REFUSES TO TAKE ANY PRESCRIBED MEDICATION. BEVERLY STATED THE ONLY POSITIVE THING THAT SHE HAD NOTICED ABOUT MASON IS THAT HE IS NOW SHOWERING DAILY. I SPOKE WITH MASON AND INQUIRED ABOUT HIS INTERNET USAGE AND MENTAL STATE. MASON STATED THAT SOMEONE ELSE HAD PENETRATED HIS EMAIL ACCOUNT AND HE BARELY USED HIS COMPUTER TODAY. MASON ALSO STATED THAT HE WAS NOT TAKING HIS PRESCRIBED MEDICATION AND HE WAS LEGALLY NOT OBLIGATED TO TAKE MEDICATION. MASON SAID THAT HE HAD NO COMMENTS ABOUT TRUMP, BUT PREFERRED PENCE OVER TRUMP. MASON WOULD NOT ELABORATE ABOUT THE ALLEGED COMPLAINT AGAINST HIM AND DENIED POSTING OR EMAILING ANYONE.

BASED ON ALL ABOVE INFORMATION I OBTAINED FROM LAW ENFORCEMENT, STATEMENTS BY BOTH BEVERLY AND MASON TURNER, COUPLED WITH MASON REFUSAL TO TAKE PRESCRIBED MEDICATION, MASON MET BAKER ACT CRITERIA AND WITHOUT CARE OR PROPER TREATMENT, MASON MAY LIKELY SUFFER FROM NEGLECT AND/OR REFUSE TO CARE FOR HIMSELF. I PROVIDED AGENT DEER AND OFFICER FERGUSON WITH THE CASE NUMBER AND MY BUSINESS CARD.

I CONTACTED DISTRICT 3 VIA RADIO FOR A DEPUTY TO TRANSPORT. DEPUTY WINTER RESPONDED ON SCENE AND TRANSPORTED MASON TO JEROME GOLDEN. AGENT DEER AND AGENT MORELAND ALSO DROVE TO JEROME GOLDEN TO CONDUCT AN INTERVIEW WITH MASON. THIS CONCLUDED MY INVOLVEMENT AT THIS TIME AND THIS CASE IS DOCUMENTED FOR INFORMATION PURPOSES ONLY.
