Alex, [REDACTED] I have not been nearly as engaged as either of you on RR so apologies if what follows is wide of the mark, inaccurate or just dim. My simplistic assessment of the situation starts with a summary of where we are on RR from [REDACTED]

'The Radical Road footpath remains closed. All rock risk areas / zones within the Park are inspected by geo-technical consultant Engineers as defined in the annual inspection programme as agreed with Fairhurst. Internal discussions between HES and Fairhurst are on-going regarding the potential to allow limited managed access to lower risk areas- South Quarry etc. This is currently being assessed and would require the current exclusion fencing to be relocated accordingly. An Options Appraisal has been carried out to identify potential longer -term intervention options.'

[REDACTED] Much of the homework on this has been done. You will recall the Options Appraisal that went to SMT (as was) in Apr 21 [PIC224-ESS-NOT-20210301-X-V01draftSCragRRMOA](#). The notes from that meeting follow:

[REDACTED] *Head of Conservation (Edinburgh and Stirling) joined the meeting to brief SMT on rock risk management and compliance in Holyrood Park.*

The natural process of rock decay is accelerating due to climate change. Measures, such as the closure of the Radical Road, have been taken to protect the public, but a number of practical factors make this challenging to enforce. Given the risk to the public and HES staff, a number of possible further interventions are outlined in the paper, tailored to various levels of organisational risk appetite.

Agreeing that inaction was not appropriate, [REDACTED]

Members noted that there will be a level of contention associated with any intervention; communications around risk awareness will be key, with formal

consultation required in some form.

Having reviewed the presented options, SMT agreed that further analysis should be carried out on creating permanent barriers to the path, as well as full and partial enmeshment options. Given the significant risk posed, final recommendations will be presented to the Board in due course. In the interim, the Radical Road should remain closed.'

As far as I am aware, final recommendations have yet to be presented to the Board. So what to do? I suggest that the Options Appraisal should be reviewed/refreshed and we then make a decision on which option we intend to progress. The immediate challenge is who should lead in HES. I am very reluctant that Ops takes this on until we have a Geo-Tech Engineer in post (hopefully achieved by Easter) [REDACTED] is struggling with staff resource. So this points to Apr 24 as a target date to get things moving. There is also a significant financial challenge. [REDACTED]
