WAS ADVISED THAT DETECTIVE C KUNKLEMAN WITH THE LIMA POLICE DEPARTMENT IN OHIO HAD RECEIVED INFORMATION VIA LEGAL PROCESS THAT THE MISSING JUVENILES "WORLD OF WARCRAFT" ACCOUNT (MAN ACTIVE IP ADDRESS OF 76.29.147.230. THE LEGAL PROCESS ALSO IDENTIFIED 31 YEAR-OLD THOMAS EBERSOLE (WORLD OF WARCRAFT USERNAME SALT WARRIOR #11554) WAS ACTIVE AT THE SAME IP ADDRESS ON THE SAME DAY. THE LEGAL PROCESS FURTHER WENT ON TO PROVIDE THE ADDRESS OF 2390 SW SHOREWOOD DR, DUNNELLON, FL IN MARION COUNTY AS THE ADDRESS FOR THE ACCOUNT. THIS IS THE REGISTERED ADDRESS OF THOMAS EBERSOLE, WHO WILL HEREAFTER BE IDENTIFIED AS "THE DEFENDANT."

DETECTIVE KNUKLEMAN ADVISED THE FEDERAL AGENTS THAT THE VICTIM'S MOTHER (HER LEGAL CUSTODIAN) DID NOT GIVE ANYONE PERMISSION TO HAVE CUSTODY OF THE CHILD VICTIM.

UPON RESPONDING TO THE AFOREMENTIONED LOCATION WITH THE AFOREMENTIONED FEDERAL AGENTS, WE MADE CONTACT WITH THE DEFENDANT AT THE FRONT DOOR OF HIS RESIDENCE. HE INITIALLY DENIED KNOWING OF ANYONE BY THE VICTIM'S NAME BUT ULTIMATELY HUNG HIS HEAD AND TOLD US THAT HE WOULD BE RIGHT BACK. HE RETURNED TO THE DOORWAY WITH THE VICTIM, WHO WAS FRUSTRATED BUT COOPERATIVE, STATING SHE HAD REQUESTED THE DEFENDANT DO THIS. THE TWO WERE SEPARATED AND DURING A POST MIRANDA ELICITATION OF THE DEFENDANT HE ADMITTED TO DRIVING IN HIS 2019 NISSAN TWO DOOR TO PICK THE VICTIM UP FROM OHIO.

INITIALLY THE DEFENDANT ADVISED THAT HIS RELATIONSHIP WITH THE VICTIM WAS ONLY AS FRIENDS. HE LATER ADMITTED TO HAVING A ROMANTIC RELATIONSHIP WITH HER. HE STATED THEY HAD SPOKEN, VIDEO CALLED, AND TEXT MESSAGED THE VICTIM UTILIZING THE APPLICATION "DISCORD" AND ALLOWED ME TO VIEW AND PRESERVE MESSAGES THAT WERE BETWEEN THE TWO OF THEM. IN THESE MESSAGES. THE DEFENDANT SENDS A PICTURE OF HIS CAR THAT HE PICKED THE VICTIM UP IN, TELLING HER IT WOULD BE HER CAR STATING "ALL YOURS DARLING." THE DEFENDANT AND CHILD VICTIM REFER TO EACH OTHER THROUGH THE COURSE OF THE MESSAGES BY SEVERAL PET NAMES SUCH AS DARLIN, BABYGIRL, BEAUTIFUL, BABE, LITTLE WOLF, HUN AND MY HOT TIER DH TANK. STATEMENTS OF LLYT (LOVE LOVE YOU TOO), LLY (LOVE YOU LOTS \*NOT A STANDARD ACRONYM\*), ILY (I LOVE YOU), ILYSM (I LOVE YOU SO MUCH) WERE MADE SEVERAL TIMES. HE ADMITTED TO KISSING HER IN THE CAR AND "NOT MUCH" IN HIS HOUSE. THREE BRUISES ON THE DEFENDANTS NECK WERE LOCATED AND IDENTIFIED BY HIM AS "HICKIES" CAUSED BY THE VICTIM WHILE THEY KISSED. THE DEFENDANT MADE ADMISSIONS TO HAVING A ROMANTIC RELATIONSHIP AND ULTIMATELY PLANNING TO HIDE THE VICTIM INSIDE OF HIS RESIDENCE AND HAVE HER BECOME HIS WIFE.

THE EDITED MESSAGE THE DEFENDANT REPLIES "I THINK YOU -- -- LOOK HOT?" THIS CORROBORATES THE STATEMENT MADE BY THE DEFENDANT THAT THE VICTIM HAD SENT HIM A PICTURE WHILE SHE WAS IN THE BATHROOM. AT 8:54 AM ON THE SAME DATE THE DEFENDANT TELLS THE VICTIM "ILYT (I LOVE YOU TOO) BEAUTIFUL I CAN'T WAIT TO MEET YOU <3 I HOPE YOU GET SOME REST TOO I'LL TTYL (TALK TO YOU LATER) MY LOVE." AT 7:29 PM THE DEFENDANT SAYS "I LEAVE SOON" TO WHICH THE VICTIM REPLIES "CRIMES!" IN REPLY, THE DEFENDANT STATES "SHOULD I NOT? XD" TO WHICH THE VICTIM SAYS "I'M JUST SAYING CRIMES LOL \*LAUGHING EMOJI\*." THE DEFENDANT THEN STATES "LMFAO RAWRRR I COME GET YOU." AT 9:19 PM, THE DEFENDANT SAYS "856 MILES TO GO... 12 HOURS LOL... ALMOST OUT OF FL."

IN ADDITION TO THE DEFENDANT ADMITTING HE KNEW THE VICTIM WAS 16 DURING OUR ELICITATION OF HIM, IN THE MESSAGES BETWEEN THE TWO, THE VICTIM MAKES COMMENTS ABOUT HER MOTHER BEING A LIGHT SLEEPER AND HER MOTHER'S HISTORY OF TAKING THE VICTIM'S PHONE TO SEE WHO SHE IS TEXTING. ADDITIONALLY, WHILE DRIVING THE DEFENDANT TELLS THE VICTIM THAT HE WAS THINKING ABOUT "CONTINGENCIES" SAYING HE "DON'T WANNA TEXT IT" AND HE WAS "PARANOID ABOUT THE TEXT CHAIN."

THE DEFENDANT MAINTAINED HIS POSITION THAT NO UNLAWFUL TOUCHING, OR UNLAWFUL SEXUAL ACTIVITY HAD TAKEN PLACE BUT ALSO CHANGED HIS NARRATIVE IN REFERENCE TO THE NATURE OF HIS RELATIONSHIP WITH THE VICTIM MULTIPLE TIMES. HOWEVER, THE VICTIM STATED AT ONE POINT DURING THE TEXT MESSAGES THAT SHE WAS GOING TO "BITE" THE DEFENDANT, THIS WAS CORROBORATED BY THE "HICKIES" ON THE DEFENDANT ATTRIBUTED TO THE VICTIM. IN MY BEST JUDGMENT, THIS ACT OF PASSIONATE KISSING THAT INCLUDED, BY THE DEFENDANT'S OWN ACCOUNT, THE 16 YEAR OLD CHILD VICTIM PUTTING HER TONGUE INSIDE OF THE 31 YEAR-OLD DEFENDANT'S MOUTH AND BITING THE DEFENDANT'S NECK LEAVING BRUISES, CONSTITUTES A LASCIVIOUS ACT AS THESE OVERTLY-SEXUAL ACTS ARE NOT IN ACCORDANCE WITH NORMAL BEHAVIOR BETWEEN CHILDREN AND ADULTS.

BASED ON THE ABOVE INFORMATION, IN MY BEST JUDGMENT, THE DEFENDANT, WITHOUT LAWFUL AUTHORITY, KNOWINGLY TOOK THE VICTIM FROM THE CUSTODY OF HER LEGAL GUARDIAN. IN THIS TAKING, HE LEFT AND RETURNED TO MARION COUNTY. WHILE HE MADE THE CLAIM THAT HE HAD FEAR FOR THE VICTIM'S WELLBEING BECAUSE OF DOMESTIC ISSUES WITH HER MOTHER, HE CLARIFIED HE WOULD NOT HAVE NOTIFIED AND HAD NO INTENT TO NOTIFY LAW ENFORCEMENT THAT HE HAD TAKEN CUSTODY OF THE VICTIM. HE ARTICULATED NO EFFORT TO GET HER ANY SERVICES OR RESOURCES IN AN ATTEMPT TO ASSIST HER OTHER THAN HARBORING HER IN HIS HOME WHILE ENGAGING IN A ROMANTIC RELATIONSHIP WITH HER. FURTHERMORE, BY NATURE OF BEING MARRIED AND/OR ROMANTICALLY INTIMATE; THE RELATIONSHIP THAT EXISTED WOULD HAVE ULTIMATELY HAVE HAD TO INCLUDE SEXUAL ACTIVITY. THEREFORE THE DEFENDANTS ACT OF UTILIZING THE ON-LINE SERVICE "DISCORD" TO ENGAGE IN A RELATIONSHIP THAT

ALL OF THIS INFORMATION WAS CORROBORATED BY THE DISCORD CHAT MESSAGES, THE NATURE OF THEIR CONVERSATION, THE MANNER IN WHICH THEY SPOKE, AND THE DEFENDANT'S STATEMENTS OF LOVE AND PHYSICAL AFFECTION TOWARDS THE CHILD VICTIM.

THE DEFENDANT IS NOT AN AGENT OF THE DEPARTMENT OF CHILDREN AND FAMILIES NOR. IS HE AN AUTHORIZED AGENT OF THE DEPARTMENT.
