   Plaintiff resides in the Western District of the State of Oklahoma.

- 4. Plaintiff is the requester of the records which defendant is now withholding. Plaintiff has requested this information for use in investigation of illegal activity of defendant.
- 5. Defendant, Health and Human Services is an executive department of the United States of America.

## FACTUAL ALLEGATIONS, CAUSE OF ACTION AND CLAIMS FOR RELIEF FIRST CLAIM FOR RELIEF

- 9. Plaintiff incorporate paragraphs 1 through 8 of the petition as if fully stated herein.
- 10. Defendants are agencies of the United States and has possession of the documents that plaintiff seeks.
- 11. By letter dated July 27, 2015, plaintiff requested access to "The record of the number of diagnostic radiologists and diagnostic radiology groups, broken down as to the record of the number of individual diagnostic radiologist and diagnostic radiology groups per each state of the United States for 2009, 2010, 2011, 2012, 2013, 2014 and 2015 to the date of this request, subjected to medical record reviews of selected Part A and Part B claims where there has been a significant increase in billing and payment for high cost diagnostic radiology claims where there has been good cause for reopening the claim with the number of diagnostic radiologists and diagnostic radiology groups further broken down into the number of diagnostic radiologists and diagnostic radiologists and the number of diagnostic radiologists and diagnostic radiology groups that resulted in payment adjustments and the number of diagnostic radiologists and diagnostic radiology groups that resulted in no payment adjustments."

A copy of this letter together with certified mail return receipt is attached as Exhibit 1. 1 12. Defendants refused to respond to the demand for production under the 2 Freedom of Information Act 5 U.S.C. § 552 within 20 days of receipt of the 3 demand. 4 13. Plaintiff has a right of access to the requested information under 5 U.S.C. 5 § 552(a)(3), and there is no legal basis for defendant's denial of such access. 6 PRAYER FOR RELIEF 7 WHEREFORE, Plaintiff requests the following relief: 8 1. Order defendants to provide access to the requested documents; 9 2. Expedite this proceeding as provided for in 28 U.S.C. § 1657; 10 3. Award plaintiff costs and reasonable attorneys fees in this action, as 11 provided in 5 U.S.C. § 552(a)(4)(E); 12 4.
