Dear Mr. Whitney:

This letter responds to your Freedom of Information Act (FOIA) appeal dated March 29, 2023, related to your initial request, dated June 21, 2021, to U.S. Army Special Operations Command (USASOC) requesting, "...the accident investigation for the parachute accident that killed SFC Ethan Carpenter. The accident occurred on 03/15/2019. The accident occurred at the Parachute Training and Testing Facility at Pinal Airpark, AZ." USASOC partially denied your request. You appealed asserting that there was additional material that was clearly missing from the documentation and there was no explanation for why it was withheld.

After reviewing the matters you submitted in your appeal, I am remanding your case to USASOC for further processing of the responsive documents.

If you believe USASOC's response to this remand violates the FOIA, you may once again appeal to this office.

This letter constitutes final action on behalf of the General Counsel, designated by the Secretary of the Army to consider appeals under the FOIA. You may, if you so desire, seek judicial review of this determination in the federal court system in accordance with the FOIA, 5 U.S.C. § 552(a)(4)(B).
