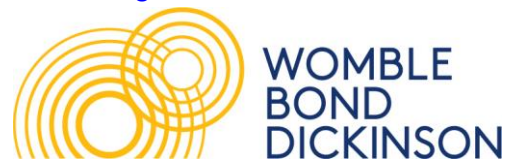

I represent ATECH, Inc. ("ATECH"), a manufacturer of aircraft arresting systems in Huntsville, Alabama. On December 7, 2022, you provided a redacted "clearly releasable" copy of the SmartArrest test report in response to ATECH's FOIA Request No. 2022-01470-F.

I write now to request the full version of the SmartArrest test report with only such redactions as are permitted by a specific FOIA exemption.
