**Subject:** RE: ATECH FOIA Request Feb. 16, 2023

Ms. Winn:

Thank you for your December 27th email, which unfortunately compels a response to clarify and correct the record in this matter.

First and foremost, your December 18th email was a denial of ATECH's request, from which we filed a timely appeal of the denial. The appeal itself was denied today with no additional regulatory or factual support.

The appeal was predicated on a long and continuous effort to seek the release of an unredacted version of the previously requested and released redacted report. Significantly, those efforts included email communications to you on February 16, 2023; February 22, 2023; March 1, 2023; March 21, 2023, November 17, and December 14, 2023. All emails were sent to this same address. Additionally, the responses received to our numerous communications were inconsistent and arbitrary, and necessarily suggest a capricious basis for the refusal to provide the report. In particular, the basis for your December 18th denial was based on Exemption 5 (which does not apply, as explained in ATECH's appeal). On December 26th, you incorrectly averred that the information requested was owned by the Navy -- which had previously been determined not to be the case -- and on that basis asserted that ATECH had to file a new FOIA request with the Navy. This morning, December 27th, you incorrectly asserted that ATECH's appeal is untimely – even though it was filed within three days of your denial. Later the same day, you asserted that the Air Force did not receive the initial February request – even though it has been the focus of our exchanges for the past two weeks and in all the afore referenced email exchanges.

To further clarify the record for appeal, there was no appeal for Request 2022-01470-F, which was a request for a clearly releasable version. Rather, ATECH sent the February 16, 2023 FOIA request as a new request for the full version of the report. You received the February 16, 2023 FOIA request and denied it on December 18, 2023 asserting FOIA exemption 5. You did not assert at the time of the December 18th denial that you had not received the February request. ATECH had the right to appeal that denial, and did so on December 21, 2023. You denied the appeal this morning.

ATECH has followed the Air Force's FOIA procedures and submitted its FOIA request through the proper channel. ATECH received a denial, filed a timely appeal of the denial, and received a denial of the appeal today. While ATECH would welcome production of the unredacted report, ATECH is not procedurally required to do anything further at this point to exhaust its administrative remedies within the Air Force.

Ms. Winn and Ms. Trinh:

Please confirm whether ATECH's administrative appeal is being denied by the USAF FOIA Appeal Authority.

Respectfully, Ms. Winn is incorrect about the report and the data being owned by the Navy. This issue is addressed in our appeal letter. When ATECH submitted a FOIA request to the Navy for test reports, the Navy asserted that the information is owned by the Air Force. The SmartArrest testing was an Air Force test effort conducted by the AAS Program Office at Robins AFB, and it was the Air Force that ordered and paid for the testing. The Air Force owns the data and report. The title of the redacted copy of the report is "USAF Smart Arrest Deadline Test Program." ATECH is not required to pursue further FOIA requests through the Navy for this Air Force document.

Ms. Winn and I previously exchanged e-mails on November 8, 2022 about this same issue before the Air Force provided the redacted version of the SmartArrest test report. At that time, I provided Ms. Winn with a copy of the attached FOIA response from the Navy which explains the USAF's ownership of the data.

Please advise as to the status of the appeal.
