**RE: Letter Amendment for C003796 Valet Parking Services**

Dear Mr. Jonathan Baron,

After review by the Office of the New York State Comptroller, the following changes shall be incorporated into the subject Contract via this Letter Amendment. These changes supersede the terms and conditions in the Contract.

1. Section 1 of the Contract is hereby deleted in its entirety and replaced with the following language:

“The term of this Agreement shall be for a period of three (3) years commencing upon December 01, 2023 through and including November 30, 2026. The parties may, via a written amendment signed by both parties, renew this Agreement for up to two (2) one-year periods. For the Contract and its subsequent renewals to be effective, the contract and subsequent renewals shall each require the approval of the New York State Attorney General and Office of the State Comptroller.”

2. The Not to Exceed Contract Value set forth in Section 3 of the Contract is hereby deleted and replaced with the following language:

**“THIS IS A NOT TO EXCEED CONTRACT VALUE OF SEVEN MILLION EIGHTY-FIVE THOUSAND FIVE HUNDRED SIXTY-EIGHT DOLLARS AND THIRTY-SIX CENTS (\$7,085,568.36)”**


