**COMPLAINT FOR DECLARATORY AND INJUNCTIVE RELIEF**

## INTRODUCTION

1. Students for Justice in Palestine at the University of Florida (“UF SJP”) brings this First Amendment challenge to the Florida State University System’s October 24, 2023 memorandum (“Deactivation Order” or “Order”) ordering the deactivation of Students for Justice in Palestine (“SJP”) chapters in the Florida State University System.
2. The Deactivation Order is a Florida State University System directive promulgated by Chancellor Ray Rodrigues, in consultation with Governor Ron DeSantis, and subject to implementation by the University of Florida.
3. The Deactivation Order advances unsubstantiated claims that Florida’s SJP chapters have violated the state’s material support for terrorism statute, Fla. Stat. § 775.33(3) (2019). The Order bases this serious and stigmatizing allegation solely on statements published by National Students for Justice in Palestine group (“NSJP”), an independent organization, in a document called the “Day of Resistance Toolkit.”
4. The Deactivation Order provides no basis for attributing the speech of NSJP to the Florida SJP chapters, including UF SJP. According to the Deactivation Order, UF SJP’s only alleged offense is its affiliation with NSJP—which is constitutionally protected. UF SJP has no formal relationship with NSJP other than sharing the “Students for Justice in Palestine” name—a name that

affirms UF SJP's solidarity with Palestine, and with other SJP chapters throughout the country.

5. Moreover, independent political advocacy—no matter its viewpoint—is fully protected by the First Amendment. Florida's material support statute recognizes as much by explicitly excluding independent advocacy from its ambit. Like the federal material support statute, Florida's law applies only to advocacy conducted in coordination with, or at the direction of, a designated foreign terrorist organization. But in alleging that NSJP's toolkit is evidence of material support, the Order does not cite any evidence of any such coordination or direction.

6. “Nowhere is free speech more important than in our leading institutions of higher learning.” *Speech First, Inc. v. Cartwright*, 32 F.4th 1110, 1128 (11th Cir. 2022). The Supreme Court has long recognized that “[t]he college classroom with its surrounding environs is peculiarly the ‘marketplace of ideas.’” *Healy v. James*, 408 U.S. 169, 180 (1972). And the right of students to associate and speak through college organizations is a fundamental precursor to their political and ideological expression. As such, the Supreme Court has made clear that “[t]here can be no doubt that denial of official recognition, without justification, to college organizations burdens or abridges [their] associational right.” *Id.* at 181.

7. In promulgating the Deactivation Order, Chancellor Rodrigues and Governor DeSantis violated that constitutional command. By ordering the deactivation of UF SJP on the basis of its constitutionally protected association with an independent group engaged in constitutionally protected speech, the Order stifles UF SJP's pro-Palestinian advocacy on campus at a time when the Palestine–Israel conflict is a matter of vital public discourse and concern.

8. If allowed to take effect, the Deactivation Order will deprive UF SJP and its members of the resources, platforms, and modes of recruitment that enable it to exist and engage in its mission.

9. Even before going into effect, the Deactivation Order has placed UF SJP's access to funding and resources in limbo, and deters current and prospective UF SJP members from participating in its activities for fear of becoming embroiled in a group subject to university sanctions. Instead of securely advancing its mission to advocate for the rights of Palestinians, UF SJP now finds its very existence in jeopardy.

10. The Deactivation Order is unconstitutional for two reasons. It violates UF SJP's First Amendment freedoms by punishing it for its protected speech and association, including its association with NSJP. And it runs afoul of the First Amendment's protection against viewpoint-based restrictions on speech and

association. For each of these reasons, the Court should declare that the Deactivation Order is unconstitutional, and enjoin it.

### **PARTIES**

11. Plaintiff UF SJP is a student organization formally registered in accordance with University of Florida requirements. The organization’s purpose is to engage in human rights advocacy and promote public awareness in its community for a just and reasonable solution to the Palestine–Israel conflict. While its members share certain common political viewpoints with NSJP and other SJP chapters around the country, UF SJP is a distinct organization with no formal relationship to NSJP or other SJP chapters. UF SJP is one of two SJP chapters referenced in the Deactivation Order instructing campuses in the Florida State University System to disband any student organization bearing the name “Students for Justice in Palestine.”

12. Defendant Raymond Rodrigues is the Chancellor of the State University System of the State of Florida. The Chancellor of the State University System is appointed by the Board of Governors, and has authority to promulgate the Board’s System-wide policies. Defendant Rodrigues promulgated the Deactivation Order in conjunction with Governor Ron DeSantis. Defendant Rodrigues is sued in his official capacity as Chancellor of the State University System.

13. Defendant Ronald DeSantis is the Governor of Florida. Defendant DeSantis promulgated the Deactivation Order in conjunction with Defendant Rodrigues and has claimed credit for it. Defendant DeSantis is sued in his official capacity as Governor of Florida.

14. Defendant Benjamin Sasse is the President of the University of Florida. Under art. II, § 1 of the Constitution of the University of Florida, the President is “the chief executive officer of the University and shall exercise general supervision over all its activities.” The Deactivation Order instructs Defendant Sasse to deactivate UF SJP. Defendant Sasse is sued in his official capacity as President of the University of Florida.

15. Defendants Timothy M. Cerio, Manny Diaz, Jr., Aubrey Edge, Patricia Frost, Edward Haddock, Jack Hitchcock, Ken Jones, Brian Lamb, Darlene Luccio Jordan, Alan Levine, Charles H. Lydecker, Craig Mateer, Jose Oliva, Amanda J. Phalin, and Eric Silagy are sued in their official capacities as members of the Board of Governors of the State University System of Florida. The Board of Governors is the governing Body of the State University System, responsible for operating, regulating, and managing the public university system in Florida.

16. Defendants Morteza Hosseini, David L. Brandon, Richard P. Cole, Christopher T. Corr, Olivia E. Green, James W. Heavener, Daniel T. O’Keefe, Rahul Patel, Marsha D. Powers, Fred S. Ridley, Danaya C. Wright, Patrick O.

Zalupski, and Anita G. Zucker are sued in their official capacities as members of the University of Florida Board of Trustees. The Board of Trustees is a corporate body established by Florida law that serves as the governing body of the University of Florida, which is part of the State University System of Florida. The members of the Board of Trustees set policy for the university and are responsible for implementing and maintaining high-quality education consistent with the University of Florida's mission.

### **JURISDICTION AND VENUE**

17. This Court has subject matter jurisdiction under 28 U.S.C. §§ 1331 and 1343 because this action arises under the First and Fourteenth Amendments to the United States Constitution, and under 42 U.S.C. § 1983.

18. Venue in this district is proper pursuant to 28 U.S.C. § 1391(b) and 1391(e).

### **FACTUAL ALLEGATIONS**

#### **First Amendment-Protected Student Activism on College Campuses, Including the University of Florida**

19. Throughout American history, students have participated in and benefited from the marketplace of ideas on college campuses, particularly with respect to pressing and divisive social and political issues. The student-led Free Speech Movement, which arose on college campuses during the Civil Rights

Movement, drew nationwide attention and expanded alongside the movements to demand gender equality and to protest U.S. involvement in the Vietnam War.

20. Particularly since World War II, the central role played by the U.S. government and American institutions on the world stage has led U.S.-based student movements to regularly weigh in on matters of international concern. Student groups in the State of Florida are no exception. In the 1980s, for example, University of Florida student groups staged a 40-day sleep-in and protest on campus to express their opposition to apartheid in South Africa.

21. Against this backdrop, the University of Florida has recognized the fundamental importance of the First Amendment on its campus. In 2019, the Florida College System Council of Presidents explained: “[I]t is not the proper role of our institutions to attempt to shield individuals from ideas and opinions they find unwelcome . . . . [C]oncerns about civility and mutual respect can never be used as a justification for closing off discussion of ideas, however offensive or disagreeable those ideas may be to some members of our communities.”<sup>1</sup>

**Benefits Available to Registered Student Organizations  
at the University of Florida**

22. The University of Florida allows students to create, formally register, and join student organizations, with over 1,000 student organizations currently operating on its campus.

23. On campus, student organizations give students an opportunity to build community around shared interests in professional goals, religious and cultural beliefs, political and social activism, and sports. Recognizing that extracurricular involvement is essential to the University of Florida experience, the University actively encourages students to participate in registered student organizations.

24. Once registered, student organizations and their members may access a variety of university resources exclusive to registered groups, including access to large meeting and event spaces, participation in campus-wide recruitment events, training and leadership development, and funding for activities.

25. One such resource is the GatorConnect portal, an online platform where students may browse a current list of organizations and a calendar of past and upcoming events. Only registered student organizations may publish information on the GatorConnect portal, and the portal lists only events hosted by registered student organizations. To apply for permits needed to host large events on campus, registered student organizations must use the GatorConnect portal.

26. These university-sponsored resources enable student organizations to support and grow their memberships, and to fulfill their organizational missions by hosting programming for the campus community.

**University of Florida Policies Regarding Student Organization  
Conduct and Deactivation**

27. The University of Florida has a number of policies that govern the conduct of student organizations on campus and the deactivation of those groups.

28. University of Florida Policy Number 16-003 sets out requirements for registered student organizations. This policy empowers the University to take actions against student organizations that fail to comply with “any . . . University regulation or policy” including: “[s]uspension or restriction of student and/or organizational access to university benefits and/or resources,” and “[d]enial and/or deactivation of registered student organization status (even if the organization was approved).”

29. Student Honor Code and Student Conduct Code Regulation Number 4.040 stipulates that student organizations are required to abide by the Student Honor Code and the Student Conduct Code. The University is obligated to address any alleged violations of these codes “independently of any criminal or civil court process.”

30. Under the regulation, student organizations accused of violating the Code of Conduct are explicitly afforded procedural rights before they are punished

by the University. Among other rights, students and their organizations are entitled to: “[n]otice of Charges resulting from an alleged violation of the Student Honor Code or the Student Conduct Code;” “[a] Hearing to determine responsibility of any alleged violations of the Student Honor Code or the Student Conduct Code;” and an opportunity to “[a]ppeal a decision of a Hearing Body.”

31. Defendants have not alleged that UF SJP violated the Student Conduct Code, the Student Honor Code, or any other university regulations or policies.

32. Defendants have not initiated any of the prescribed procedures to determine whether UF SJP should be subject to discipline.

### **The University of Florida Students for Justice in Palestine Chapter**

#### **The Formation, Mission, and Activism of UF SJP**

33. In 2001, Students at the University of California, Berkeley founded the first SJP chapter. Today, there are more than 200 SJP chapters nationwide.

34. Since at least 2009, University of Florida students have maintained a UF SJP chapter in good standing with status as a registered student organization. Since then, UF SJP is and has been in good standing with all university requirements for registered student organizations.

35. UF SJP was founded as a human rights advocacy organization in response to the failure of modern society to produce a just and reasonable solution

to the Palestine–Israel conflict. It aims to promote international law, human rights, and justice for all people affected by this conflict.

36. UF SJP includes a diverse membership of people from all faiths and nationalities who believe in the attainability of peace. Its membership and activities change with each academic year. Currently, the chapter has four board members, and numerous active members.

37. UF SJP engages in a wide range of campus advocacy in service of its mission. It has previously hosted teach-ins on the boycott, divest, and sanctions movement; vigils for Palestinians killed by the Israeli military; social events to celebrate Palestinian culture and food; and film festivals showcasing Palestinian voices and stories.

38. The organization has also engaged in political and social advocacy on other significant public issues. It has issued statements in support of Black Lives Matter; boycotted the University food court for its association with prison labor contractors; and, together with other student organizations, protested Florida’s “Don’t Say Gay” Bill.

39. The University of Florida’s designated resources for registered student organizations are fundamental to UF SJP’s operation, organizing, and existence on campus.

40. Currently, UF SJP's sole source of funding is from the University's Student Government, which makes funding available only to registered student groups. Losing this funding would significantly undermine UF SJP's activism. The group would not be able to afford to invite speakers to campus, print promotional materials for events and recruitment, or provide food at events. For example, in March 2023, UF SJP hosted a Palestinian embroidery class, using school funds to purchase the necessary supplies for students in attendance and provide an honorarium for the event's speaker. Without university financial support, events like this would be difficult for UF SJP to mount.

41. UF SJP regularly books on-campus meeting and event spaces, another privilege reserved for registered student organizations. Having these spaces is critical to building community and hosting events. Past UF SJP teach-ins and meetings have drawn more than one hundred students. Because its members do not have access to off-campus spaces of similar capacities, the only way for UF SJP to host such large gatherings is by booking university rooms.

42. UF SJP utilizes GatorConnect features available only to registered student organizations to book spaces and to add its events to the University-wide calendar. The GatorConnect calendar is an effective way to reach students not already affiliated with UF SJP who are interested in learning more about the group's activism.

43. UF SJP's organizing depends on university resources. Without these resources, the organization would be unable to effectively organize and fulfill its mission.

UF SJP's Loose and Informal Affiliation with NSJP

44. NSJP was established in 2011, well after the creation of the first SJP chapter in Berkeley in 2001, and after the UF SJP chapter's own founding.

45. NSJP "seeks to empower, unify, and support student organizers as they push forward demands for Palestinian liberation & self-determination on their campuses."<sup>2</sup>

46. UF SJP is affiliated with, but fully autonomous from, both NSJP and other SJP chapters around the country. Article I of UF SJP's own Constitution states: "NSJP is not an umbrella organization of which we are a subordinate organization. Rather, NSJP serves as a coalition and networking group for SJPs and other like-minded groups on college campuses across the nation."

47. UF SJP has no financial relationship with NSJP. It does not pay dues to NSJP, nor does it receive funds from NSJP.

48. The vast majority of UF SJP's communication with NSJP has come through mass emails sent by NSJP to SJP chapters around the country.

49. NSJP's mass communications to SJP chapters, including UF SJP, have largely concerned trainings, advocacy templates, and notices about annual conferences. UF SJP views NSJP's materials as a resource, and may sometimes use templates or consult educational materials, but NSJP's resources do not dictate the content or messaging of UF SJP's independent advocacy. UF SJP makes its own independent decisions about its views and advocacy.

50. Ultimately, UF SJP's actions and principles are defined by the University of Florida students in their organization on their campus—and no one else.

#### UF SJP's Activism in Response to Current Events

51. On October 7, 2023, Hamas launched an attack it called Operation al-Aqsa Flood on Israeli soil, killing approximately 1,200 people, the majority of whom were Israeli civilians and more than 30 of whom were children. Hamas also took approximately 240 civilian and Israeli military hostages.

52. In response, the Israeli government launched an intense military operation in the Gaza Strip and a crackdown on Palestinians living in the West Bank. The Israeli military has dropped thousands of bombs in the Gaza Strip, severely limited humanitarian aid from entering the Strip, and at times imposed a communications blockade for Palestinians living there.

53. The Israeli government's military response has killed more than 11,000 Palestinians in the Gaza Strip, the majority of whom are civilians and more than 4,600 of whom are children, and injured more than 28,000 people. The response has also caused the displacement of more than 1.7 million people.

54. The humanitarian catastrophe in Gaza and the U.S. government's support for the Israeli government have triggered widespread protests and calls for a ceasefire around the world, including here in the United States. Students and student organizations, like UF SJP, are at the heart of this movement.

55. UF SJP board members were devastated by both the tragedy in Israel and the Israeli government's response in Gaza. They were and are consumed by what the next days and weeks might hold for civilians, particularly Palestinian civilians in Gaza. Despite being overwhelmed, UF SJP felt that its campus activism was needed now more than ever, and it organized and mobilized quickly.

56. On October 8, UF SJP board members convened to discuss how they could generate support for Palestinian human rights in Gaza. They considered hosting a teach-in to educate other students about the history of the Palestine-Israel conflict and UF SJP's criticisms of the Israeli government.

57. On October 10, NSJP sent a mass email to SJP chapters around the country, including ours, with a link to a document called the "Day of Resistance Toolkit." The toolkit offered messaging resources and a guide to organizing in



light of the unfolding events in the region. UF SJP was not involved in or consulted about the conception or drafting of NSJP's toolkit.

58. Also on October 10, UF SJP issued its own statement on its social media account "mourn[ing] the loss of innocent Palestinian and Israeli civilian life." The statement made clear that "the killing of any life is always undignified and heartbreaking," and asserted that "the root of violence, apartheid, and occupation under Israel's far-right government must end for peace." The statement concluded: "We hope that no more lives, Israeli or Palestinian, are lost. We pray for those who are suffering."

59. Two days later, UF SJP organized a teach-in to spread awareness about the humanitarian crisis in Gaza and educate the student body on how to show support for Palestinian human rights. The teach-in had unprecedented attendance for a UF SJP event, with more than 200 students participating.

60. Frustrated by what UF SJP believed was the University administration's disregard for the Palestinian civilian deaths in Gaza and the failure to support students perceived to be Palestinian and/or Muslim on campus, UF SJP, in conjunction with other student groups, issued another public statement on October 16. The statement stressed that "[v]iolence against all innocent life is unacceptable," and encouraged the University to "condemn[] all violence, antisemitism, Islamophobia, Palestinian erasure, and anti-Palestinian sentiment."

61. On October 17, SJP issued a “call for action” on its social media account. It encouraged its followers continue to show solidarity with the people of Palestine: “organize,” “educate,” and “protest” to “END the gaza GENOCIDE.”

**Chancellor Rodrigues’ and Governor DeSantis’ Order to Deactivate UF SJP**

62. On October 24, 2023, Chancellor Ray Rodrigues sent a memorandum to State University System of Florida’s Presidents ordering them to deactivate “active National SJP Chapters.” While this Deactivation Order states that Chancellor Rodrigues issued it in “consultation with” Governor Ron DeSantis, the Governor’s spokesperson told the Tampa Bay Times that it was issued at the Governor’s direction.

63. To justify deactivation, the Order links language from two different parts of NSJP’s toolkit. In the first part, the toolkit refers to Operation Al-Aqsa Flood as “the resistance”; in the second, the toolkit states that “Palestinian students in exile are PART of this movement, not in solidarity with this movement.”

64. Based on those two statements, the Order concludes that “NSJP has affirmatively identified it is part of the Operation Al-Aqsa Flood—a terrorist led attack.” That, the Order concludes, is evidence that NSJP has provided material support to a designated foreign terrorist organization, a felony violation of Florida Statute 775.33(3).

65. Chancellor Rodrigues flagged that the “State University System of Florida has at least two institutions with” what he inaccurately characterized as “active National SJP Chapters.” University of Florida is one of these institutions.

66. The Deactivation Order does not allege that UF SJP was in any way involved in the drafting or circulation of NSJP’s toolkit. Nor does it allege that UF SJP formally adopted or endorsed NSJP’s toolkit.

67. Similarly, the Deactivation Order does not include any direct statements or materials from UF SJP. Indeed, the Order does not mention UF SJP, except insofar as it notes that the chapter exists.

68. Although the memorandum ordered State University of Florida System presidents to deactivate SJP chapters on their campuses, it does not identify any violation of any law or university policy by either of the SJP chapters subject to deactivation.

69. The Order also does not cite any evidence to suggest that the statements contained in NSJP’s toolkit were anything other than NSJP’s own independent political advocacy.

70. Nevertheless, the Order issued a clear directive: “[b]ased on” NSJP’s “support of terrorism, in consultation with Governor DeSantis, the student chapters must be deactivated.”

71. The Deactivation Order referenced the possibility that student SJP chapters could “form another organization that complies with Florida state statutes and university policies,” though it did not specify what measures newly formed organizations would need to take in order to comply.

72. Two weeks later, while on stage for a G.O.P. presidential debate, Governor DeSantis celebrated and claimed credit for SJP deactivation in his state: “I already acted in Florida. We had a group Students for Justice in Palestine. They said they are common cause with Hamas. They said we’re not just in solidarity. This is what we are. We deactivated them. We’re not going to use state tax dollars to fund jihad, no way.”

**The Deactivation Order’s Harmful Consequences for UF SJP**

73. The Deactivation Order, bearing the imprimatur of the State of Florida’s highest executive and education officials, demands immediate disbandment of UF SJP and references a state felony statute. Once the Order has been carried out, UF SJP will cease to exist, and its members’ First Amendment rights will have been irreparably infringed.

74. Even now, the Deactivation Order casts a significant chill on UF SJP’s activities, causing its Board and members to think twice before organizing and advocating for Palestine. The prospect of disbandment and potential investigation, including felony investigation, has cast a pall of uncertainty and

anxiety over current board members' efforts to put on new events and deterred prospective members from associating with UF SJP.

75. The Deactivation Order leaves open the possibility that UF SJP and its members can avoid the harms of disbandment if they associate under a different name.

76. On November 9, Chancellor Rodrigues publicly indicated that University officials will “seek an express affirmation” from local Students for Justice in Palestine chapters in Florida that “they reject violence,” “reject they are a part of the Hamas movement,” and “will follow the law.”

77. These ultimatums place UF SJP in an untenable position. UF SJP's constitution already makes its independent and lawful mission clear. It will in addition face government pressure to express a particular viewpoint in a particular way—by disavowing beliefs and associations it has never claimed to hold—to protect itself from the imminent threat of disbandment. Even if UF SJP were to comply with these demands, that would only open the door to further ultimatums constraining its constitutionally protected expression and association.

78. Although UF SJP is still organizing for Palestinian rights, the looming threat of deactivation hampers its activism. UF SJP board members fear that at any moment the University will deny them access to critical school funds, resources,

and facilities that are fundamental to the survival and operation of their organization.

79. Similarly, board members worry that derecognition will fundamentally disrupt their ability to sustain their growing momentum for their advocacy. Since October 7, UF SJP has gained 663 Instagram followers, with its advocacy statements now reaching over 9,000 accounts on Instagram. While the group's events typically drew 10 attendees, one recent event drew an overflowing crowd at a large lecture hall on campus. Without the ability to book campus facilities or communicate with their new supporters, UF SJP will not be able to retain or engage with this increasing support for Palestinian rights on campus.

80. Ultimately, the Deactivation Order directly hampers UF SJP's ability to organize at a time when the group views it as critically necessary because the situation in Palestine is rapidly deteriorating. Rather than focusing on their advocacy, UF SJP students are forced to redirect time and resources towards vindicating their own constitutional rights.

## **CAUSE OF ACTION**

### **First Claim for Relief**

#### **42 U.S.C. § 1983 (First Amendment to the U. S. Constitution)**

81. All students on public university campuses have the First Amendment right to speak and associate through the formation of student organizations.

82. The First Amendment binds the State of Florida pursuant to the incorporation doctrine of the Fourteenth Amendment. In all of the following paragraphs, references to the First Amendment include the First Amendment as applied to the states through the Fourteenth Amendment.

83. The Deactivation Order denies UF SJP members the right to collectively speak and associate.

84. The Deactivation Order unconstitutionally censors and penalizes UF SJP on the basis of its First Amendment protected association with NSJP.

85. The Deactivation Order unconstitutionally censors and penalizes UF SJP on the basis of the content and viewpoint of NSJP's speech.

86. The Deactivation Order unconstitutionally censors and penalizes UF SJP on the basis of its imputed viewpoint. In particular, the Deactivation Order singles out SJP chapters in Florida for disbandment because of the views expressed in NSJP's toolkit.

87. Viewpoint-based discrimination is presumptively unconstitutional in any setting. Its dangers are magnified in the university setting, because they interfere with long-recognized academic freedom principles.

88. Even if the University of Florida's registered student organization system constitutes only a limited public forum, Defendants may not deny UF SJP

access to that forum on the basis of its viewpoint, its imputed viewpoint, or the viewpoint of its affiliates.

**PRAYER FOR RELIEF**

**WHEREFORE**, in light of the foregoing facts and arguments, Plaintiff respectfully request that this Court:

- A. Issue preliminary and permanent injunctive relief restraining Defendant and its employees, agents, and successors in office from enforcing the Deactivation Order;
- B. Declare the Deactivation Order unconstitutional under the First Amendment to the United States Constitution;
- C. Award Plaintiff's costs of suit and reasonable attorneys' fees and other expenses under 42 U.S.C. § 1998; and
- D. Grant such additional relief as the interests of justice may require.

RE: Deactivation of National Students for Justice in Palestine

---

During a holy Jewish holiday, the recognized terrorist organization, Hamas, launched an unprovoked attack on Israel—among those killed were babies, women, and elderly. To date, approximately 1,400 Israelis<sup>i</sup> have been killed, including 31 American citizens.<sup>ii</sup> Governor DeSantis, our State University System and the Florida College System have condemned these attacks.

Hamas is responsible for this attack and claims it as “Operation Al-Aqsa Flood.”<sup>iii</sup> In the wake of this terror, military leaders of Hamas have called for the mobilization of Palestinians in support of the Operation.<sup>iv</sup>

In response, and leading up to a “Day of Resistance,” the National Students for Justice in Palestine (National SJP) released a “toolkit” which refers to Operation Al-Aqsa Flood as “the resistance” and unequivocally states: “Palestinian students in exile are PART of this movement, not in solidarity with this movement.”<sup>v</sup>

It is a felony under Florida law to “knowingly provide material support . . . to a designated foreign terrorist organization. . .” § 775.33(3), Fla. Stat. (2019). Here, National SJP has affirmatively identified it is part of the Operation Al-Aqsa Flood—a terrorist led attack.

The State University System of Florida has at least two institutions with active National SJP Chapters.

These chapters exist under the headship of the National Students for Justice in Palestine, who distributed a toolkit identifying themselves as part of the Operation Al-Aqsa Flood. **Based on the National SJP’s support of terrorism, in consultation with Governor DeSantis, the student chapters must be deactivated.** These two student chapters may form another organization that complies with Florida state statutes and university policies. The two institutions should grant these two chapters a waiver for the fall deadlines, should reapplication take place.

Promoting excellent educational quality while providing a safe environment for all students is paramount.

The State University System will continue working with the Executive Office of the Governor and SUS's Board of Governors to ensure we are all using all tools at our disposal to crack down on campus demonstrations that delve beyond protected First Amendment speech into harmful support for terrorist groups. These measures could include necessary adverse employment actions and suspensions for school officials.

# Constitution of Students for Justice in Palestine University of Florida

## ARTICLE I. NAME OF ORGANIZATION

The name of this organization is Students for Justice in Palestine. This organization will also utilize the acronym SJP in publicity materials and correspondence. SJP is affiliated with National Students for Justice in Palestine (NSJP) operating in the United States. The website for NSJP is <http://sjpnational.org/>. However, NSJP is not an umbrella organization of which we are a subordinate organization. Rather, NSJP serves as a coalition and networking group for SJPs and other like-minded groups on college campuses across the nation.

## ARTICLE II. PURPOSE STATEMENT

In stark recognition of the failure of modern society to produce a just and reasonable solution to the Palestine-Israel conflict, Students for Justice in Palestine is founded at the University of Florida as a human rights advocacy organization in order to promote public awareness and activism in our community.

In pursuit of this goal we aim to promote international law, human rights, and justice for all people affected by this conflict. We are directed at incorporating a diverse membership of people from all faiths and nationalities who believe in the attainability of peace.

## ARTICLE III. COMPLIANCE STATEMENT

Upon approval by the Department of Student Activities and Involvement, Students for Justice in Palestine shall be a registered student organization at the University of Florida. Students for Justice in Palestine shall comply with all local, state and federal laws, as well as all University of Florida regulations, policies, and procedures. Such compliance includes but is not limited to the University's regulations related to Non-Discrimination, Sexual Harassment (including sexual misconduct, dating violence, domestic violence, and stalking), Hazing, Commercial Activity, and Student Leader Eligibility.

## ARTICLE IV. UNIVERSITY REGULATIONS

### Section A. Non-Discrimination

Students for Justice in Palestine agrees that it will not discriminate on the basis of race, creed, color, religion, age, disability, sex, sexual orientation, gender identity and expression, marital status, national origin, political opinions or affiliations, genetic information and veteran status as protected under the Vietnam Era Veterans' Readjustment Assistance Act.

### Section B. Sexual Harassment

Students for Justice in Palestine agrees that it will not engage in any activity that is unwelcome conduct of sexual nature that creates a hostile environment.

### Section C. Hazing

Students for Justice in Palestine agrees that it will not initiate, support, or encourage any events or situations that recklessly, by design, or intentionally endanger the mental or physical health or safety of a student for any purpose including but not limited to initiation or admission into or affiliation with any student group or organization.

### Section D. Responsibility to Report

If this organization becomes aware of any such conduct described in this article, Students for Justice in Palestine will report it immediately to Student Activities and Involvement, the Director of Student Conduct and Conflict Resolution, or the University's Title IX Coordinator.

## ARTICLE V. MEMBERSHIP

Membership in this organization is open to all enrolled students at the University of Florida. Non-enrolled students, spouses, faculty, and staff may be associate members; however, they may not vote or hold office. All members and associate members are free to leave and disassociate without fear of retribution, retaliation, or harassment.

## ARTICLE VI. OFFICERS

Section A: The elected officers of Students for Justice in Palestine shall be President, Vice President External, Vice President Internal, Treasurer, Secretary, Historian, and Webmaster.

Part 1: The President will be responsible for the following:

- Properly delegating tasks to the board and general members so that events run smoothly
- Confirming speaker/entertainer contracts
- Communicating with Classic Fare and other event services
- Leading executive meetings and general body meetings, which includes creating agendas
- Approving SARs and helping the Treasurer manage the budget
- Being knowledgeable about the Palestinian-Israeli conflict and SJP's general stance on core issues
- Attending and making announcements at other groups' meetings

Part 2: The Vice-President External will be responsible for the following:

- Networking with other groups and finding co-sponsors
- Heading tabling and other PR activities
- Managing the Facebook group and other social networking sites, including making event pages
- Heading advertising by delegating advertising tasks to the members
- Writing press releases and submitting events into Gator Times and the What's Happening section of the newspaper
- Involving members by conveying their ideas for events or actions to the executive board

Part 3: The Vice-President Internal will be responsible for the following:

- Reducing time conflicts for events by coordinating with other groups
- Submitting event permits, including tabling permits
- Finding and keeping in contact with speakers
- Confirming that each executive member and volunteer is aware of their tasks during an event
- Tabling and assisting VP External with advertising tasks

Part 4: The Treasurer will be responsible for the following:

- Keeping a detailed account of and managing the allotted budget
- Managing receipts
- Writing SARs or approving them promptly
- Thinking of and managing fundraisers for both SJP and Palestinian charities
- Keeping detailed records of materials and what they cost to make future SARs more efficient
- Along with the President, forming and submitting a new budget to SG Finance for the next academic year

Part 5: The Secretary will be responsible for the following:

- Recording general body meeting attendance and event attendance
- Taking meeting minutes
- Sending out e-mails to SJP members in a timely fashion
- Printing and copying materials when needed
- Booking rooms for events, executive board meetings, and general body meetings
- In charge of room set up for events

Part 6: The Historian will be responsible for:

- Recording all events and meetings through photo and video
- Making sure photos and videos of events are posted on the group's social networking platforms
- Member of the Editorial Committee
- Creating or finding someone to create event flyers and posters

Part 7: The Webmaster will be responsible for:

- Maintain the website
- Assist with social media efforts
- Be responsible and knowledgeable on IT matters.

Section B: An appointed chair position of Students for Justice in Palestine is the Editorial Committee Chair

Part 1: The Editorial Committee Chair is appointed by a simple majority vote of the executive board members.

Part 2: The Editorial Committee Chair is in charge of finding members to join an editorial committee, which will coordinate to write and submit relevant opinion pieces to the university newspaper and other outlets. The committee is also in charge of developing different ideas/methods to get SJP's name and image out to the student body.



Section C: Officers shall assume their official duties at the close of the last general meeting of the academic year and shall serve for a term of one academic year and/or until their successors are elected/appointed.

Section D: Any officer of Students for Justice in Palestine may be removed from office through the following process

Part 1: A written request by at least three voting members of the organization shall be submitted to the Secretary. Written notification shall be sent to the officer to be present at the next meeting and prepared to respond to the removal request.

Part 2: A two-thirds majority is necessary to remove the officer.

Part 3: In the event of the removal of an officer, or of a vacancy, a special provision may be granted to the remaining officers to appoint an interim replacement officer until an election may be held.

## ARTICLE VII. ELECTIONS

Section A: For all elections the following criteria will be followed both for who can run and who can vote.

Part 1: An elections committee consisting of at least two people will be appointed by the E-board to both handle nominations and run the elections.

Part 2: Elections for all officers will take place annually every April. Any candidates running must have gone to at least two events and at least one general body meeting. The same criteria must be met by voting members. Someone who is running for a position cannot vote for that position. Candidates and voters are expected to follow the honor system.

Part 3: In order for a candidate to be nominated, they must send in a short application of their qualifications to the elections committee. Alternatively, they can be nominated by two voting members, in which case the candidate will be notified of their nomination and asked to accept or reject. There will also be a write-in option on the day of elections, but write-in candidates must still meet all requirements.

Section B: The following are the rules for the elections committee when running the elections.

Part 1: Voting will occur for each position by secret ballot to be distributed and collected by one of the elections committee members. Eligible voters may only select one option on the ballot. There will be separate ballots for each position.

Part 2: Unless giving a speech, candidates must leave the room during the speeches and when votes are being cast.

Part 3: There will be a vote of no confidence. If a voter does not feel that any running candidates are capable of the position for which they are running, then a voter can choose to vote 'no confidence'. This results in a -1 for each candidate towards their vote total. If they all have negative sums, then no one is elected to the position and there must be a re-election. Flexibility is given to the elections committee in this scenario.

Part 4: The required margin of victory is a plurality for all officer positions.

Section C: In the event of a tie, there will be follow-up questions that each candidate must answer, followed by a re-vote (again by secret ballot) until the tie is broken. Both candidates must leave the room while voters discuss a new question to ask both candidates for the re-vote. Each candidate must answer each question while their opponent is out of the room.

Section D: The positions of President, Vice President External, Vice President Internal, Treasurer, Secretary, and Historian must be filled. In the event that a position is not filled during the planned election in April, future elections must be planned at the discretion of the new executive board to give opportunity to interested members to fill any empty positions.

## ARTICLE VIII. FACULTY ADVISOR

The faculty advisor will provide advisory support for officers and will serve as a resource for all members of the organization. The E-board will select the advisor by consensus of all the officers. The advisor must be a faculty member at the University of Florida. The advisor is not required to attend any meetings. The term will be indefinite as long as the advisor is able to fulfill the position. In the case of replacement or should the advisor be unable to continue with their position, a new advisor will be selected by the E-board, again by consensus of all the officers.

## ARTICLE IX. FINANCE

Students for Justice in Palestine has been funded by Student Government and will continue to apply for funding every year. For this reason, SJP will not require membership dues. Any fundraising for outside revenue or for philanthropy will be managed by the treasurer and will not use SG funds in accordance with the guidelines for SG funded organizations.

## ARTICLE X. DISSOLUTION OF ORGANIZATION

In the event this organization dissolves, all monies left in the treasury, after outstanding debts and claims have been paid, shall be donated to Palestine Children's Relief Fund ([www.pcrf.net](http://www.pcrf.net)).

## ARTICLE XI. CAMPUS CLIMATE

Section A: Students for Justice in Palestine is committed to ensuring that all members feel welcomed and feel free to give their voice on the conflict. We therefore try to prevent and denounce any intimidation directed towards our members in an effort to silence them, which other SJP chapters are known to have experienced.

Section B: Although SJP is against all forms of discrimination as described in Article IV, we draw special attention to and against anti-Semitism and Islamophobia, as in addition to being morally and ethically wrong, both forms of discrimination are directly involved in the conflict and are often used to silence people's (often students') voices.

## ARTICLE XII. POLITICAL NON-AFFILIATION

Students for Justice in Palestine is not affiliated with any political parties, groups, organizations, or factions whether national or international. SJP members are not required nor encouraged to hold any specific political or economic views. As a human rights advocacy organization, our main focus is supporting the human rights of the Palestinian people and all other oppressed peoples. Should we co-sponsor events with more political organizations, this does not mean we hold the views of that organization.

## ARTICLE XIII. SUPPORT FOR DIVESTMENT ACTIONS

Given the strong views held by many when it comes to the Palestine-Israel conflict, we believe the University as well as any public institution should try to remain neutral by not directly supporting any side in the conflict. This includes not investing in companies or organizations that profit off of the occupation of the Palestinian territories and the suffering of the Palestinian people. We therefore support any actions that call for a moral accountability when dealing with the Palestine-Israel conflict.

## ARTICLE XIV. MEETINGS

Students for Justice in Palestine will hold a minimum of three general body meetings every Fall and Spring semester, but will give all effort to hold one general body meeting per month.

The executive board consisting of the officers described in Article VI will also have executive board meetings at least once every other week. Executive meetings are open to all members, and all members are encouraged to attend.

## ARTICLE XV. AMENDMENTS TO THE CONSTITUTION

Amendments to this constitution can be considered upon written request by a member and at least five supporters. The executive board will then determine whether the amendment is a minor or major change. If determined to be a minor change, a two-thirds vote of the officers is needed. If determined to be a major change, the amendment will be discussed at the next general body meeting and a two thirds vote of all present members will be needed to approve the amendment. All amendments are subject to final approval by the department of Student Activities and Involvement.

**DECLARATION OF MIKAELA BOELKINS IN SUPPORT OF  
PLAINTIFF'S MOTION FOR A PRELIMINARY INJUNCTION**

I, Mikaela Boelkins, hereby declare and state as follows:

1. My name is Mikaela Boelkins. I am over 18 years of age.
2. I have personal knowledge of the following facts and if called to testify could and would competently do so.
3. I am a sophomore student at the University of Florida studying Arabic and Linguistics. I expect to early graduate from the University of Florida in Spring 2025.
4. I have been a member of the University of Florida chapter of Students for Justice in Palestine (“UF SJP”) since enrolling at the University of Florida last fall. At the beginning of this semester, I was elected Secretary of UF SJP. I currently serve as Vice President of the organization.

5. Currently, UF SJP has four board members, and numerous active members.

6. As a board member of UF SJP, I have access to the organization's official email and Instagram accounts.

7. I have been involved in several other activities at the University of Florida, such as student government and marching band. I am also currently a board member of the Linguistics Society, which is a registered student organization at the university.

8. I care deeply about UF SJP's mission. During my gap year before enrolling at the University of Florida, I had the opportunity to study Arabic in Amman, Jordan, on a U.S. government-funded scholarship. There, I gained a deeper perspective on the experiences of Palestinian people.

9. While living in Jordan for Arabic study, I was deeply moved by the personal stories of Jordanian-Palestinian friends, many of whom had parents that were expelled during the 1948 Nakba (catastrophe, in Arabic).

10. As an Arabic major, I have learned not just about the language, but about pan-Arab culture and history. My studies have further deepened my understanding about the history of Israel and Palestine and the human rights issues faced by Palestinian people.

11. I believe that standing up for Palestine is standing up for humanity. To me, Palestinian solidarity represents the collective struggle of all peoples seeking peace and acknowledgment. I am a member of UF SJP because of these beliefs, which include liberty and justice for all.

12. I knew about the University of Florida chapter of SJP before enrolling at the University of Florida. My program in Jordan brought together students from many different universities across the United States. Many of them were involved in their schools' individual chapters of Students for Justice in Palestine. Knowing I would enroll at the University of Florida after my gap year, I looked up the SJP chapter on social media, and hoped to become a member of the student organization.

13. Even before I joined UF SJP, I knew from its presence on social media that it had been continuously involved in student-led activism in solidarity with Palestine.

14. Membership in UF SJP has enabled me and my peers to engage in meaningful political activism. As a young person and a student, being involved with UF SJP has been a crucial opportunity to make my voice heard on urgent social and human rights issues.

15. Membership in UF SJP has also enabled me to connect and work together with fellow students with a wide range of life experiences. UF SJP's



members include University of Florida students from a variety of religious, racial, and cultural backgrounds. This includes members who are Jewish, Palestinian, and Palestinian-American, among other backgrounds.

16. While I have been part of UF SJP, the organization has coordinated vigils, protests, public education, and cultural events. There is a strong culture of student engagement with Palestinian solidarity on the University of Florida campus.

17. In the last month, support for our activism has increased significantly. We used Instagram's analytics feature to confirm that since October 7, we have gained 663 followers on Instagram. Our Instagram posts now reach 9,000 accounts. While our previous events typically drew 10 attendees, one recent event attracted an overflowing crowd at a large lecture hall on campus.

18. As a board member of UF SJP, I know that the organization's activism relies on access to University of Florida resources and funding that is set aside for registered student organizations.

19. UF SJP routinely reserves space on the University of Florida campus for meetings and events. Without access to University of Florida facilities, UF SJP would not be able to hold meetings in our University of Florida community or host large-scale events that call attention to social and human rights issues in Palestine.

20. Currently, UF SJP's only source of funding is from the University of Florida's Student Government, which only offers money to registered student groups. UF SJP must apply for funding from the Student Government every semester. The organization relies on this funding to host events, print promotional materials, and sustain its membership. When UF SJP pays to bring in a speaker or provides food and other materials to event attendees, we require student government funding that is set aside for registered student organizations. For example, I attended a Palestinian embroidery class that UF SJP hosted in March 2023 to promote cultural awareness and understanding. UF SJP relied on university funds to organize that event.

21. Only registered student organizations can post information on GatorConnect, which is the University of Florida website that students access for information about student organizations and upcoming student organization events. I know that UF SJP has used GatorConnect in the past to book rooms for, and calendar, large-scale events and we will need to use it for current and future events.

22. UF SJP's constitution makes clear that our organization is a University of Florida student group, and independent of any other organization, including National Students for Justice for Palestine ("NSJP") and other SJP chapters around the country. Specifically, the UF SJP Constitution states: "NSJP

is not an umbrella organization of which we are a subordinate organization.

Rather, NSJP serves as a coalition and networking group for SJPs and other like-minded groups on college campuses across the nation.”

23. UF SJP shares the “Students for Justice in Palestine” name with NSJP and other SJP chapters throughout the country as an affirmation of solidarity with Palestine.

24. While I and other board members of UF SJP may share some values with NSJP and other SJP chapters, we have our own mission, values, and principles, and engage in activism independently of NSJP and other SJP chapters.

25. UF SJP receives no funding from NSJP and has no financial relationship with NSJP.

26. UF SJP board members have access to a shared organizational email account. Occasionally, at that account, UF SJP receives emails or other communications from NSJP. In addition, sometimes NSJP will send messages to UF SJP’s organizational Instagram account or other social media accounts.

27. Generally, communications from NSJP are mass emails to SJP chapters across the country, including UF SJP, and provide templates for social media advocacy and share information about upcoming pro-Palestine conferences or events.

28. While I have been a UF SJP board member, my fellow board members and I have not viewed communications from NSJP as instructions from an umbrella or supervisory organization. UF SJP is its own independent organization, and we decide on our own what kind of activism we want to engage in and what kind of information we want to share.

29. I am aware that UF SJP may sometimes use resources provided by NSJP, such as templates for social media posts, but we make our own independent decisions about UF SJP's views and advocacy.

30. The other UF SJP board members and I were devastated by the news of the October 7 attack, and by the Israeli government's response afterwards. We were very worried about what would happen to Palestinians in Gaza over the next days and weeks. But we all believed that we needed to organize quickly, because our solidarity was needed more than ever.

31. On October 8, UF SJP board members met to talk about how we could support Palestinian rights in Gaza in that moment. We discussed hosting a teach-in to educate other students about the history of the Palestine–Israel conflict and context that would help other students understand the current situation there, including UF SJP's criticisms of the Israeli government.

32. On October 10, 2023, NSJP sent a mass email to SJP chapters around the country, including ours, with a link to a document called the “Day of

Resistance Toolkit.” The document suggested messaging resources and action items local SJP chapters could decide to take, such as organizing campus events.

33. UF SJP was not involved in or consulted about the conception or drafting of NSJP’s toolkit.

34. As a board, we reviewed NSJP toolkit resources, but did not view them as requirements for us to use, and we did not interpret them as instructions UF SJP was bound to follow.

35. Prior to receiving the toolkit, our chapter had already planned to engage in events that would call attention to the unfolding humanitarian catastrophe in Gaza.

36. On October 10, UF SJP board members and I issued a statement on the organization’s Instagram account “mourn[ing] the loss of innocent Palestinian and Israeli civilian life.”<sup>1</sup> Our statement made clear that “the killing of any life is always undignified and heartbreaking,” and emphasized that “the root of violence, apartheid, and occupation under Israel’s far-right government must end for peace.”<sup>2</sup> Out of concerns for what the next days might hold, we ended the

statement “hop[ing] that no more lives, Israeli or Palestinian, are lost. We pray for those who are suffering.”<sup>3</sup>

37. On October 12, UF SJP organized a teach-in to spread awareness about the humanitarian crisis in Gaza and educate the student body on how to show support for Palestinian human rights. This event had more attendees than we had ever seen before, with over 200 students participating.

38. In the following days, as the humanitarian crisis in Gaza continued to worsen, UF SJP board members and I were frustrated by the University administration’s disregard for the Palestinian civilian deaths in Gaza and the failure to support students perceived to be Palestinian and/or Muslim on campus. To address these frustrations, UF SJP worked together with other student groups to draft another public statement, which UF SJP issued on its Instagram account on October 16. The statement stressed that “[v]iolence against all innocent life is unacceptable,” and encouraged the University to “condemn[] all violence, antisemitism, Islamophobia, Palestinian erasure, and anti-Palestinian sentiment.”<sup>4</sup>

39. On October 17, UF SJP board members issued a “call for action” on the organization’s social media account.<sup>5</sup> It encouraged its followers continue to show solidarity with the people of Palestine: “organize,” “educate,” and “protest” to “END the gaza GENOCIDE.”<sup>6</sup>

40. When I learned that Chancellor Rodrigues and Governor DeSantis had ordered the University of Florida to deactivate our SJP chapter, my fellow board members and I were scared and disheartened about what the order meant for our organization, values and activism. As a group of students who contribute to activism on campus and the University of Florida community, it is very daunting for my peers and I to see our state and University’s leaders calling for UF SJP’s disbandment.

41. UF SJP board members and I are afraid that at any moment, the University will disband our organization and strip us of access to the University resources that we rely on to put on events at a time when our advocacy is needed more than ever. Over the last few weeks, the human rights crisis in Gaza and the suffering of Palestinian people has only been getting worse and we urgently feel

compelled to speak up and educate our fellow students as our organization's constitution and mission requires us to do.

42. I grew up learning about how important it is for people to exercise our right to speak for what we believe in. It is deeply disappointing to see Florida's highest officials have told us they will censor our speech and advocacy for Palestinian human rights. Their actions are contrary to everything I've learned and understood about how our democracy is supposed to work.

43. After the Deactivation Order was issued, I know that multiple current and potential members of UF SJP are afraid of being punished or investigated by the University or law enforcement because of their participation in our group.

44. UF SJP has applied for student government funding this semester, as it has every semester while I have been a member of the organization. The application is still pending, and UF SJP's board members and I are concerned that the Deactivation Order will prevent us from receiving funding.

45. Despite our fear of being punished, investigated, and disbanded, other UF SJP board members and I are still determined to stand up for our morals and spread awareness in our community about the rights and cause of Palestinian people.
