I am emailing to find who has time July 10 – July 13 to help hand count mail in ballots.

I have requested from Denton Elections the "Mail In Ballots" from November 2020. Approx. 30K The mail in ballots candidate results were similar to Tarrant, which I counted in January of this year, in that Biden won over Trump in the mail in ballots, but not EV or ED.

I went to the Elections office this past week to organize the boxes of ballots. Everything looks organized for the count.

I have picked the week after the 4<sup>th</sup> of July to do this hand count July 10 – July 13.

I will schedule anyone that would like to help with their availability. However, anyone that can commit to multiple days would be very helpful. If you would like to help please let me know day(s) available and times. I will schedule between 9 am - 3 pm. 4 teams of 2 people to count ballots. Then a team (4) just to count the return envelopes we have to be sure envelopes = ballots.

We will count only the Presidential race. The mail in ballots are batched, generally with 100 ballots in the batch. Approximately 18 batches in a box. We will count by splitting the batch by race (candidates) counting, record the count, rebatch, etc

**\*\*Very important to observe of MAIL IN BALLOTS - we will observe several characteristics of the ballot –**

1. Has a fold in the paper, where it would have been placed in the envelope to mail back.
2. Is the vote on the ballot typical of down ballot, or does it have anomalies; which we will track those ballots. In Tarrant we noticed many ballots with atypical voting. Looking for signs of “harvested” ballots.
3. Observe the paper stock, is it consistent. In Tarrant we did find some paper stock that was different and made note of the boxes where we found them.

If you can help with this project that would be excellent!

Also, the great news for those of us who want to “validate machine results tapes”; starting in September we can request more recent elections to “COUNT TO VALIDATE” now that HB 5180 passed and was signed by Gov. Abbott. If anyone believes the machines can be wrong; we need to be counting after every election to “validate the results tapes and thumbdrives” from the scanners.

Developing Hand Counting Teams will be a goal of mine for “Validating” elections results. I will be training the hand counting teams in the “authorized Texas Election Code” method, I call SOS Method (Chap 65). It is the only method we can use for a candidate “recount” or ballots counted after end of election day. But for validating results we can use various methods. While we are counting in Denton in July, I will have the SOS method set up to allow counters to learn that method also.

**\*\*AND I will be tagging along the HAND COUNT ROADSHOW when time allows to show the SOS method and our STACK and COUNT methods. There are other methods too; we need to offer ALL methods of hand counting and to just get *“hand counting to be a normal thing”!***

Jill said that mellany is the expert.  
My responses are in bold.

1. It is difficult to reconcile the voters cast ballot to their home precinct.

**If it is just one more day I don't see how it could take that much longer to find the ballots. They have to look in all bags anyway.**

*I really don't understand this argument. It is not difficult in any way....it's a simple report. I'm assuming she's speaking in general...we don't have to look through bags to know this information.*

2. To support the above, Frank Phillips testified that it took two and half days with staff to pull the 36 precincts from HD-64 when there was the recount for the Hopper-Stuckey race. That

is due to having to pull the ballots from the respective precincts from the ballots cast during Early Voting. If we still had precinct, Election Day only voting, the 36 precincts would take only a matter of minutes to pull. Not days. If you saw Frank's testimony from that Commissioners Court meeting, Dianne asked him how long it would take to count the ballots from a general election and he responded 105 days. Before countywide Early Voting, elections results were usually tallied well before midnight.

**When Frank said 105 days was that to hand count each race on all ballots? When did countywide EV start?**

She's misstating what I said. The short answer is I said it took two and a half days to pull and count a race that only contained 36 precincts and 1 race. If you had to pull 400,000 ballots and count 40-50 races on each ballot and 225 precincts....do the math! How long did it take them to recount Maricopa County? Months!

I mean come on....what about the meeting a month or two ago when they were casting "ballots" to appoint precinct chairs – how long did it take them to hand count those few ballots. I heard about the fiasco!

3. Alan Vera, Harris County GOP, who did the poll watcher training for the RPT before the midterms stated that countywide polling has created many issues in Harris County. By Texas law, the poll pads are to sync within 5 minutes. The fastest time that they were able to record was 32 minutes. Does this allow a person to vote in one location and rush to vote in a different location due to this time period? Also, think about at the close of the polls on Primary Election night, when as precinct chairs we need our tapes to ensure that anybody who attends our Precinct Convention had voted on Election Day if they did not vote early. Do we have to wait that much later for any attendees to perform the voter verification and that they voted in the Republican Primary?

**I would like to know if that is true for Denton county. I know it takes a very long time to sync EV to the ED poll pads.**

I don't know what issues she was speaking of, but were the "issues" because of countywide voting? Or, were they issues that can happen regardless of the method of voting? Our pollpads sync every 4 minutes.

So, if you are worried about a voter rushing to vote at a different voting location, what do you think happens with paper pollbooks? There's nothing to stop them then. In effect, if we didn't have poll pads to stop them and relied on old-fashioned paper pollbooks, someone could go vote at all 50 early voting sites!! They would get caught later, but the ballots are still cast and can't get retrieved....they would all count! So, this argument is a non-starter!

Move precinct conventions to a later date and the good list becomes a non-issue. It gives plenty of time to create good lists.

4. Some counties postpone their Precinct Convention for a few days. From speaking to friends in Dallas County, they said it puts the burden on the Precinct Chair to find a meeting place and that it could cost money they pay out of their own pockets. The most important issue that it reduces participation in your Precinct Convention, therefore, a possible loss of our Delegation to attend the GOP Convention.

**If we move to countywide ED, I don't believe conventions will not be able to be held. That was one reason we didn't want them. However with having so many shared sites it may be better if we didn't have them that night. We have discussed this and maybe we have the PC convention on the same day as the SD convention.**

**This is really not an Elections Administration issue, it's a party issue, but I will say....there are over 100 counties who are vote centers now and they manage to have precinct conventions. You can never convince me that if they can do it, we can't!**

5. I do understand Bobbie and Andy's perspective that the County should make every possible effort to increase voter participation, however, Early Voting has created confusion as to where to vote since the polling locations move around frequently and seem to never be the same from Early to Election Day. I told Bobbie that we have most likely increased the cost, too, from the hardware and software needs to make anywhere voting happen, since the poll pads have to be able to communicate to the Hart equipment the voter's precinct and perform the correct Ballot On Demand. We keep adding layers upon layers while costing the taxpayers more.

**Which is my wheel house:**

**In the past we have tried to have primaries in locations that we don't have to share. When the Dems come in to same location alot of times there is not enough room for both parties. So someone has to move. Usually us. There is only one government building not big enough and we have been blessed to request it first. Since we use a lot of non government buildings it is not a guarantee that we will be able to use that facility each time. Also the EA can't always get the same locations unless they strictly use schools and government buildings, which can't refuse. I believe the confusion will continue because city, school and primaries and all have different boundaries for each election.**

**I think the biggest cost is because our population is growing so much and have to have so many locations. Which is more equipment and staff. But having ballot on demand one more day isn't going to cost more.**

**Well, saying the locations are not the same from Early to Election Day is kind of obvious You don't have but about a fourth of the locations during early as you do election day. Also, the county is growing by 88 people a day....this means more voter precincts, which means more voting equipment, etc. It's just the cost of being one of the fastest growing counties in the United States.**

**Sounds like someone trying to make the case that all-paper, hand counted, etc would be cheaper. I seriously doubt it. I could write pages on the costs that nobody is thinking of because they have never done it. It's not a cost friendly as it sounds. Printing costs, delivery costs, personnel costs through the roof (who do they think is going to count 400,000 ballots with 40-50 races on them and the results have to be into the state within 24 hours....it would take hundreds of people – which creates its own security/integrity issues). There's a reason you don't have election officials asking for these things....it's because we aren't dealing in the theory of it, we live the reality of it, and know that it's not possible.**

**I would like to understand how it increases voter fraud?**

**Me too....because it doesn't!**

**The best way to prevent voter fraud is to have one day of voting.**

That would be impossible in a county our size. Do the math....175 polling locations, 600,000 voters. If 400,000 of those show up in a presidential election that's an average of 2,285 per site....average! More populated areas would be more than that. Once you get past about 1,200 a day it becomes a problem...double that and you have lines of angry voters.

1. The Hopper-Stuckey recount provided a lot of information post election. They do not separate the ballots, but store in secured bags with unique seals that are documented. Precincts and partisan ballots are co-mingled in a bag respective to the poll location. Elections Administrative only looked through the bags to break out the 36 precinct ballots specific to the HD-64 contested Republican race. And the sort was still not "clean."

Countywide originated in Lubbock County, TX in 2008 post the 2007 Legislative Session. Denton County did not start countywide polling for Early Voting until the 2013 timeframe to the best of my knowledge.

**Yes each location has a ballot bag that can not be opened unless court order ie recount. I assume that if we have vote centers the bag would contain ED as well as early and not have a separate bag. It did provide insight as I was part of it. It was very clean retrieval of ballots. Done but both attorneys watching. I was part of the group going through ALL the other bags making sure there were not any missed ballot and we didn't find ONE!**

I don't know what she means about the sort was not "clean". It was actually almost perfect. I don't know what she was expecting it to be.

Also, saying Denton County did not start early voting until 2013 is totally wrong. Early voting started in 1987 in Texas at the main voting location, but expanded to early voting sites in 1991.

2. Frank stated that it would take 105 days to handcount after a general election in response to his calculation that it took two+ days to pull HD-64 ballots from the involved 36 precincts.

If we returned to precinct only voting poll sites, it would have been a matter of pulling secured bags. Not sorting through 100's of thousands of ballots.

**I understand. Just a guess on his part. That was looking for specific ballots with specific races and not counting each race on every ballot.**

Again, that was for ONE RACE....some of our ballots have 40-50 races on them. Add to the mix the races that aren't just vote for one, but vote for multiple....Comparing the HD 64 to hand counting a full countywide race with dozens of races on each ballot is comparing apples to oranges. There is more than just a presidential race on a ballot!

The ballots would still have to be sorted because they have to be reported by precinct, so consolidated precincts would all have to be sorted. Even if the site had only one precinct, more than likely they also have sub-precincts which have to be sorted for reporting.

3. We have never had to sync from ED to EV in Denton County since we are provided hard copies of the EV spreadsheet and we run the tapes from the poll pads on ED to verify that people who attend their respective precinct convention 1. Voted and 2. Voted in their Party's primary. Syncing is an issue in counties that already have EV's and they are in violation of TEC due to exceeding the five-minute threshold.

**We may need to have a phone convo about this one. Don't understand how this has anything to do with a voter voting twice in short amount of time**

**This makes zero sense to me....and I've already responded to the 5-minute threshold.**

4. Participation is lost if you move the precinct convention from the precinct poll site location. People most likely will not want to drive miles away to go where the SD convention is held. You will also reduce your delegation to the GOP convention.

**Wonder what the numbers are for people who go to Precinct convention and don't go to SD. I can see that many probably don't go to state unless it is local.**

**The counties I spoke to about precinct conventions said when they moved to countywide voting, and moved their precinct conventions to a later date, they had higher participation. They also said they would not go back to the old way. Ask yourself, if countywide voting is a bad thing why aren't all of these counties going back to precinct based voting? That includes both red and blue counties....they don't go back!**

Andy Eads gave me ( Mellany) his solution to this issue and IMO, it was a good solution. When there are the major elections — primaries, municipal/school board, general, open the high schools as a major polling location. A voter would go to the high school that is within the feeder pattern where their precinct resides. Plenty of space and parking, too. Tuesdays the schools would have a teachers workshop day, as to not lose state funding, if money is the argument. LISD called off school this last election, so it should not be an issue.

Election Day, handmarked and handcounted ballots is the most verifiable and fraud-free system as proven prior to HAVA ushering in machine voting. And it saves millions of taxpayer money.

**This is a great solution if they call off school. It was great that the one ISD did that but others didn't. I am not a fan of using schools for the safety of the students. Also if school is in session there is not "plenty of space or parking". And you can't use schools for early voting again confusing the voters.**

**I think it's a great idea, but schools do not. Only LISD calls off school that day; none of the others do even after years of us asking them to do it. The answer is for the legislature to make election day a school holiday so it doesn't affect funding.**

# No denying the voting machines in Collin County — commissioners approve contract renewal

Collin County residents who've spoken out at commissioner court have raised concerns about voting machines. But the commissioners voted Monday to keep using them.

Collin County will continue using the same voting machines for another year despite objections from several members of the local Republican party.

The commissioners voted to approve the consent agenda for the meeting, including the renewal of the county's contract with the company that provides

its election machines until June 30, 2024. Multiple residents implored the commissioners to vote against the contract renewal during public comments, citing false claims about 2020 election fraud.

This isn't the first time people have shared concerns about the county's voting machines and election integrity. Mark Brugge was one of the citizens who spoke during public comments. He said Collin County residents have raised concerns about election integrity for a couple of years. He also said the Collin County Republican Party's chair told him 80% of the party's precinct chairs share that worry.

"The large percentage wants to get rid of them and a lot of them don't trust them," Berge said.

Abraham George, the Collin County Republican Party chair, told KERA [before the 2022 election](#) that while there may have been election fraud in other parts of Texas, there was no fraud in Collin County.

"We won every race," George said.

That includes county commissioners Susan Fletcher and Darrel Hale, who ran as Republicans in 2020 and won with more than half of the county's votes. The other county commissioners, Duncan Webb and Cheryl Webb, are also Republican. So is County Judge Chris Hill.

None of the commissioners officially commented on renewing the contract or the public comments during the meeting. But Commissioner Susan Fletcher asked the county administrator, Bill Bilyeu, to give an update on the recount of the May 6 election results.

Bilyeu said it took almost seven hours to recount the votes from 1,100 ballots by hand for one race.

"The outcome of the ballot, comparing it to what was run through the machines, was exactly the same," he said.

Public commenters at the meeting – and at past commissioners' court sessions – said that voting machines aren't as reliable or accurate as hand counting. Debbie Lindstrom, a Collin County Republican precinct chair, said that the machines are also illegal.

“They not certified properly, neither at the federal or the state level,” Lindstrom said.

The Texas Secretary of State’s Office concluded otherwise. The [2020 election audit report](#) made a point to include the dates the Texas secretary of state certified the election machines ahead of the vote in Collin County. The report also praised the county’s election systems, calling it “the model of how to run elections in Texas.”

But that didn’t reassure people with concerns. Barbara Isaacs, who’s spoken at commissioners’ court about election integrity off and on for years, still said the machines aren’t secure.

“I feel that you are disenfranchising the citizens that do not feel safe to vote on these machines,” Isaacs said to the commissioners
