On December 28, 2023, the Pennsylvania State Police (PSP) received your request for information pursuant to the Pennsylvania Right-to-Know Law (RTKL), 65 P.S. §§ 67.101 - 3104, wherein you state or request:

Pursuant to the Pennsylvania Right to Know Act, I hereby request the following records:

any and all documents, memos, text messages, presentations, calendar entries, and emails (including attachments) related to the unauthorized access to the Municipal Water Authority of Aliquippa discovered on Nov. 25. Please include any records from Nov. 25 to the date of this request's processing.

The requested documents will be made available to the general public, and this request is not being made for commercial purposes.

In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.

Thank you in advance for your anticipated cooperation in this matter. I look forward to receiving your response to this request within 5 business days, as the statute requires.

Under the RTKL, a written response to your request is due on or before January 4, 2024.

Under the provisions RTKL section § 67.902(b)(2), you are hereby notified that your request is being reviewed and the PSP will require up to an additional 30 days, i.e., until February 5, 2024, in which to respond to your request. Should your request be granted, the total for the estimated or actual fees owed, if any, will be included in our

subsequent response. The reason for requiring additional time for a final response is checked below:

- Compliance with your request may require the redaction of certain information that is not subject to access under RTKL.
- Your request requires retrieval of one or more records that are stored at a remote location.
- A response by the mailing date of this letter could not be accomplished due to bona fide staffing limitations. In particular, \_\_\_\_\_.
- Your request is under legal review, which is necessary to determine whether a requested record is a "public record" for purposes of the RTKL.
