Dear Colleague:

This letter supersedes the Committee's letter dated October 3, 2023. Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Uganda,¹ scheduled for October 4 to 11, 2023, sponsored by Fellowship Foundation (d.b.a. International Foundation). We note that this trip includes two days at your personal expense.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Office of House Security (OHS) for a safety and security briefing prior to your departure. OHS may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. Congressman Walberg has traveled to attend numerous National Prayer Breakfast gatherings in both Europe and Africa as requested by parliamentary organizing committees in each nation. He does this for the purpose of deepening relationships and strengthening the spiritual basis of many of those relationships. He is well known and deeply respected throughout Eastern Europe and Africa for his leadership and continues to connect with many of the key leaders in these the countries. The Congressman is interested in people and offers a special knowledge of African issues and desires to see the people in the region experience a generation of peace and harmony and spiritual development.

The Fellowship Foundation (d.b.a. The Fellowship Foundation is assisting the Ugandan hosts to provide organizational and relational support for the Uganda National Prayer Breakfast. The Foundation is providing the funds for Congressman Walberg's travel with no other entity or grant covering any portion of the cost. The Uganda National Prayer Breakfast seeks to broaden and deepen relationships and positively impacts a more non-partisan atmosphere among national leadership, parliament and in local communities throughout Uganda.

Transportation to lodging arrangements have been arranged by family. Congressman Walberg will spend the evening with family.

October 6, 2023

All Day – Personal Time.

Congressman Walberg will spend the day recovering from travel with their family. No formal programming arrangements have been made for this day.

22:00 – Check in at the hotel, Kampala Serena, Kampala, Uganda.

Congressman will be transported to the hotel by family. He will spend the evening at the hotel to prepare for the subsequent day of programming beginning early in the morning.

October 7, 2023

8:00 – 9:30 – Breakfast with Chair and MP Hon. David Bahati, Kampala Serena

Congressman Walberg will meet with the Honorable David Bahati to go over the Congressman's role in the Prayer Breakfast. Mr. Bahati will provide updates on the Ugandan Parliament. They will also discuss how their two nations may strengthen their ties.

9:30 – 10:00 – Transportation from Kampala Serena to Uganda House of Parliament

The Fellowship Foundation has arranged for Congressman Walberg to be transported to the Uganda House of Parliament for subsequent meetings.

10:00 – 11:00 – Meeting with Uganda Prayer Breakfast Organizing Committee, Uganda House of Parliament

Congressman Walberg will meet with the Organizing Committee to reaffirm the Congressman's role. They will also conduct a rehearsal of the run of show for the Prayer Breakfast. Congressman Walberg will briefly greet and thank the Organizing Committee for their efforts. They will also engage in prayer together, as the Congressman is a former Pastor and member of the Prayer Caucus.

11:30 – 13:00 – Round Table Discussion with Members of Parliament

Congressman Walberg will engage in a Round Table style discussion with additional Members of Parliament to discuss the role of faith and stewardship in governance. They will also discuss how to become better leaders for the people they represent. Congressman Walberg will lead conversations on climate stewardship, commerce, and energy as a member of the Energy & Commerce Committee in the House of Representatives. Thank you for your business.**IMPORTANT INFORMATION****1.) TRANSPORTATION OF HAZARDOUS MATERIALS:**

Federal law forbids the carriage of hazardous material aboard the aircraft, in your luggage, or on your person. A violation can result in 5 years imprisonment and penalties of \$250,000 or more (49 U.S.C5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives and radioactive materials. .

2.) AIRCRAFT DISINSECTION:

Disinsection is permitted under international law in order to protect public health, agriculture and the environment. The World Health Organization and the International Civil Aviation Organization stipulate two approaches for aircraft disinsection– (1) spray the aircraft cabin with an aerosolized insecticide while passengers are on board or (2) or spray or treat the aircraft's interior surfaces with a residual insecticide (residual method) while passengers are not on board. Under the Chicago Convention, which governs international civil aviation, a country could impose a disinsection requirement should they perceive a threat to their public health, agriculture or environment. Accordingly, travelers are advised to check with their travel agent or airline reservations agent when booking flights or if they have questions about their final destination's policy. .

3.) FORBIDDEN DANGEROUS ITEMS EXAMPLES:

Paints, lighter fluid, fireworks, tear gases, oxygen bottles and radiopharmaceuticals. There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in your luggage and certain smoking materials carried on your person. Note: Spare batteries and fuel cells are not permitted in checked or hold baggage. These items MUST be packed in carry-on baggage. If your carry-on bag is gate checked, the spare batteries and fuel cells must be removed and carried in the cabin. For more information on
