1. WS117679: 5 minute call from Robey to CHS.
2. WS117680: 50 minute call (3 way between Baltimore CHS, Detroit CHS, and Robey)
3. Third call from Robey this morning recording not yet collected from CHS.
4. Fourth call from Robey after the 1:00 press conference (CHS not in a position to record with family)
  1. Robey directed CHS to throw his 300 blackout rifle into a lake.
  2. Robey directed CHS to abandon his truck and get a rental and get a hotel
  3. Robey directed CHS that all coms will now be on signal
  4. Robey asked to meet in person with CHS soon.
