SECOND DECLARATION OF TERRY LYNN NICHOLS

Pursuant to 28 U.S.C.§1746 and based upon personal knowledge I, Terry Lynn Nichols, do hereby certify, verify and state under penalty of perjury as follows:

1. I am currently an inmate at United States Penitentiary Administrative

Maximum Facility ("ADX") at Florence Colorado and my federal registry number is 08157-031. I am housed in "D-Unit" at ADX.

- 2. On November 8, 2007, I spoke with Ms. Sudlow about video conferencing capabilities at ADX. Ms. Sudlow is an employee of the Federal Bureau of Prisons assigned as one of the team members for D-Unit.
- 3. On November 8, 2007, I asked Ms. Sudlow if ADX had a video conference room where inmates could make court appearances and give depositions. Ms. Sudlow's response was: "Yes, we do."
- 4. During December of 2003 and January of 2004, I was incarcerated in the Oklahoma County Jail in Oklahoma City, Oklahoma awaiting trial on State of Oklahoma criminal charges. During that period of time, I was visited by Michael Selby, who held him self out to me as an attorney from Missouri.
- 5. Mr. Selby was accompanied on his visits with me by one of my defense attorneys, Rod Uphoff.
- 6. Mr. Selby approached me with a plea bargain or deal. Mr. Selby told me that he was not employed by the United States Department of Justice, but that he was speaking for and with the authority of the United States Department of Justice, and from the highest level within the Department of Justice.

- 7. Mr. Selby said that his meeting with me was an "off the books" operation so that if anyone found out about the purpose of his visits with me, the Department of Justice could and would deny any and all knowledge of Selby and the offer. Mr. Selby then told me that if I would agree to three things or conditions, I would not have to stand trial on State murder charges.
- 8. According to Mr. Selby, the Department of Justice could prevent the State prosecution from going forward by not releasing evidence to the State prosecutors and by not allowing FBI agents and other federal employees to testify in the State case.
- 9. The first of the three things I was asked by Mr. Selby to do as part of this plea deal was: Admit to having made a telephone call to the FBI on April 18, 1995, warning about the plan to bomb the Murrah Building. This was the first I had ever heard of such a telephone call having been made. And I told Mr. Selby that as well as the fact that I had not made that telephone call.
- 10. The second thing I was asked to do was to implicate my brother, James Nichols in criminal activity. This I refused to do because it was not true.
- 11. The third and final thing I was asked to do was to disclose the location of the box of explosives (*i.e.*, tubes of nitromethane, which forms part of the binary explosive Kinestik) that I had taken from Roger Moore's home in Arkansas. This was

the same box of explosives recently discovered at my Herington, Kansas home and seized by the FBI.

- 12. That box of nitromethane was addressed to "Robert Miller," which was Moore's alias. I also had no doubt that Moore's fingerprints were on that box and/or those explosives. In addition, Tim McVeigh told me that Moore had supplied him with the explosive Kinestik.
- 13. According to a Memorandum prepared by McVeigh's defense counsel,

 McVeigh had used this Kinestik as a detonator for his bomb. McVeigh said that when

 Moore furnished the Kinestik Moore had told McVeigh that he knew McVeigh "would

 copy (In)

 put them to good use." A true and correct eop of that Memorandum is attached hereto as

 The memorandum itself I learned of in June 2005. McVeigh getting

 Exhibit 1. the Kinestik from Moore and using it in his bomb I knew of in 1994.
- 14. These foregoing facts linking Moore to the Murrah Building Bombing led me to believe that Mr. Selby and/or the Department of Justice wanted this evidence to prosecute Roger Moore. Consequently, I responded by telling Mr. Selby that I could give him Roger Moore.
- 15. Mr. Selby's reaction to my offer, however, was not what I had expected. Mr. Selby essentially said no deal. Mr. Selby told me that Roger Moore was "untouchable."

16. Finally, I am ready and willing to participate in the video tape deposition that the United States District Court has allowed Jesse C. Trentadue to take in the above captioned matter. As for the FBI's security concerns, since my arrest on April 21, 1995 to present, there has not been single incident of me becoming violent or threatening anyone.



On December 12, 1995 at approximately 8:49 a.m., I met with Tim Meveigh at the FCI El Reno in El Reno, Oklahoma.



I asked Mr McVeigh to tell me again, the circumstances on how he and Andy met. Mr Meveigh Stated that he had been worken a booth at a gun show and that Andy just showed up. Mr McVeigh Stated that the general conversation throughout the gunshow was the incident in waco, Texas. Mr Meveigh stated that he and Andy spoke briefly about the waco incident and that almost immediately, Andy called for two of his companions to join him at the booth with Mr Mevelen.

I asked Mr Maveigh to tell me the names of the other people working the booth with him. Mr McVeigh immediately told me that the booth belonged to Roger Moore (aks: Bob Miller) and that he was only helping him. Immediately after telling me this, Mr McVeigh quickly told me that he had rented a very small section of Mr Moore's booth where he sold his own items. *Note that this is the first time that Mr McVeigh acknowledged that Andy was accompanied by two other men when they met and, it is also the first time that Mr Meveigh mentioned that he was working with Roger Moore when he met Andy Straussmier.



The expression on Mr McVeigh's face was that of anger. Mr McVeigh stated that if Mocre ever decided to testify against him, that there was enough evidence available to sink Roger Moore. 
I asked Mr McVeigh if Terry Nichols ever bought "Kinestiks" from Roger Moore and Mr McVeigh replied that Terry was never around when the purchases were made. I told Mr McVeigh that I found it totally impossible to believe that Terry Nichols and Roger Moore never became acquainted with each other. Mr McVeigh immediately replied that Terry Nichols and Roger Moore did speak immediately replied that Terry Nichols and Roger Moore did speak on the telephone but that to his recollection they had only one on the telephone but that to his recollection they had only one conversation. I looked at Mr McVeigh and smiled then told him that he was full of shit.

*Note that in my September 30, 1995 interview with Roger Moore at the Sands Hotel and Casino in Las Vegas, Nevada, Mr Moore at the Sands Hotel and Casino in Las Vegas, Nevada, Mr Moore at the had never heard the voice of Terry Nichols. Mr Moore also stated that he did converse with the person who robbed him for several minutes but that the robber did most of the him for several minutes but that the robber did most of the talking. I taked Mr Moore that if he had the opportunity to hear talking. I taked Mr Moore that if he had the opportunity to compare the voice of the Terry Nichols today, would he be able to compare it to the robber's voice. Mr Moore immediately replied that he did not think that he would be able to identify the voice at all.

I told Wr McYeigh that Roger Moore told me that he was glad that the FBT did not search his house the day after the bombing because if they had done so, that they would have found more weepons in his home than were found at the Davidian Compound in Waco, Texas. Mr McVeigh immediately replied that the FBI would have found cases of "Kinestiks."

Mr McVeigh stated that Roger Moore and his girifriend, Karen Anderson, purchased approximately 100,000 VHS blank tapes for the purpose of copying Triple-X films and then selling them at the gun shows for \$5.00 each. Mr McVeigh stated that the tapes are kept under the counter and that a list of the films is kept to one side under the counter and that a list of the films is kept to one side for people to review prior to the purchase. Mr McVeigh stated that to his knowledge, Roger Moore and Karen Anderson still sell these pirate pornography movies.

Mr McVeigh stated that he once sold a "White Power" shirt to Hoger Moore. Mr McVeigh stated that he had previously bought the shirt from



I told Mr McVeigh to expect Marife Nichols to testify against him. I reminded Mr McVeigh that Marife and Terry Nichols had a family.
