Good afternoon Mr. Trentadue,

I'm contacting you about the FOIA request you made for records concerning Roger Moore/Operation Punchout. As you probably recall, the FBI located approximately 30,000 pages that are potentially responsive to your request. I just wanted to let you know about the potential waiting time for a request of this size. Once requests go over a certain size, usually in the 50-100 page range, they become increasingly complex, greatly slowing down the time required for processing. Generally the larger the file, the longer it takes to process. Given our current workload and staffing levels, it may be a very long time before you would begin to receive material from this request.

We contact folks with requests of this size to see if there might be a way to possibly narrow the scope of the request. Is this something you might be willing to consider? I can help you decide how to reduce the scope. We can narrow the request by date, or if you are looking for something specific, we can approach it that way.
