Ms. Wyer:

I am writing in hopes of avoiding another *FOIA* law suit against the FBI. This potential suit involves a July 29, 2016 request that I submitted via e-mail to the FBI for documents from the BOMBROB Major Case related to Timothy McVeigh and/or Richard Lee Guthrie's Jr.'s involvement with the Aryan Republican Army, ARA, Mid-west Bank Bandits and/or Mid-west Bank Robbers. A copy of that *FOIA* request is attached. That same day, July 29, 2016, the FBI acknowledge via e-mail its receipt of that request. A copy of that acknowledgment is also attached.

On August 31, 2016, the FBI notified me that it had located 36,795 pages of responsive documents, and that the cost for producing them was \$1,135.00. I was also asked by asked the Bureau to agree to pay the costs of production, which I did by letter dated September 6, 2016. The Bureau's August 31, 2016 letter and my September 6, 2016 response are likewise attached.

On April 5, 2017, I was again contacted by the FBI and asked to pay ½ of the \$1,135.00 production cost. On April 12, 2017, I agreed and provide the ½ payment. A copy of my response and the check that I sent to the FBI are attached.

I was supposed to receive the documents under the Bureau's expedited *Interim Release Policy* whereby responsive documents are released on a CD in 500 page increments/segments as processing is completed. I am writing to you because despite repeated requests to the Bureau, I have not received a single document.

It has now been over 5-years since I submitted that *FOIA* Request. I would appreciate it if you would follow up with your client and asked them to immediately produce the documents. Otherwise, I will be forced to commence another law suit to obtain them.
