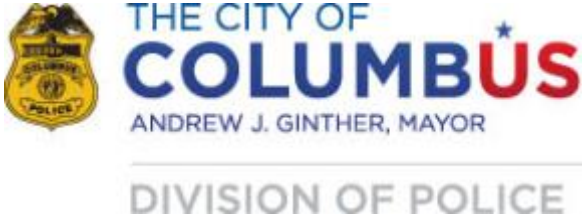

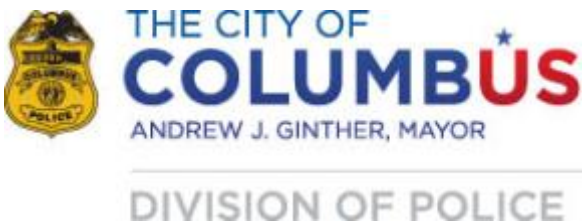
Good morning,
