Over the last several months, members of the Jewish, Muslim, Arab, and Palestinian communities have faced a surge in violence and violent threats targeting individuals and community spaces. The Justice Department remains vigilant in combating hate crimes that target individuals based on their religion, race, color, ethnicity, or national origin.

To continue bringing together stakeholders to support our shared goal of preventing, disrupting, and prosecuting illegal acts motivated by hate-fueled Antisemitic, Islamophobic, anti-Arab, and anti-Palestinian sentiment, these 30-minute webinars will feature speakers from the Justice Department, including Assistant Attorney General for Civil Rights Kristen Clarke (Civil Rights Division), Deputy Director Paul Abbate (FBI), and Director Justin Locke (Community Relations Service).

Speakers will provide an overview of what the Civil Rights Division, FBI, and Community Relations Service have been doing to bolster community safety. Specifically, the webinars will present the current threat environment, direct stakeholders to critical safety resources, and allow stakeholders an opportunity to ask questions.
