This concerns your request to the Tennessee Valley Authority (TVA) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, dated February 13, 2023. You requested "all records related to the Johnsonville Aeroderivative Combustion Turbine Project." Your request has been assigned tracking number 23-FOI-00080.

The scope of information you have requested is extremely broad and general. The FOIA and TVA's FOIA regulations (18 C.F.R. § 1301) state that requesters must describe the records sought in sufficient detail to enable agency personnel to locate them with a reasonable amount of effort. Further, FOIA does not require agencies to conduct wide-ranging, "unreasonably burdensome" searches for records.

Before we can begin processing your request or make a determination regarding your request for a fee waiver, we need you to more closely define or provide more detailed information on the type of records you are seeking.

We welcome the opportunity to work with you to clarify your request so that we may begin processing. FOIA requests are not considered received and no work will be started until all procedural issues are settled.
