This is a request under the Freedom of Information Act (5 U.S.C. § 552).

Summary of Events (The "Incident")

On September 20, 2023, members of the Islamic Republic of Iran's delegation departed the Millennium Hilton New York Hotel located at One UN Plaza, New York, NY 10017. Between 9:15 p.m., and 10:30 p.m., during which time, a member of the Iranian delegation commenced an altercation with Mr. Kian Amani, an Iran International journalist (Iran International is a subsidiary of Reach Media LLC). The member of the Iranian delegation in question made bodily contact with Mr. Amani and attempted to forcibly take away Mr. Amani's phone.

Document Request

I request that a copy of the following document(s) be provided to me:

1. Any and all reports or documents about the Incident (regardless of who created the report or document).
2. Any and all statements made to the Department of State or obtained by the Department of State about the Incident.
3. Any and all photos, videos, audios, electronic files and recordings which pertain in any way to the Incident.
