SIR, ON SEPTEMBER 16, 2010 THURSDAY, DERRICK RAY ROSE WAS ARRESTED BY THE CARROLLTON COUNTY SHERIFF DEPARTMENT AND PLACED IN THE CARROLLTON COUNTY DETENTION CENTER.

SEPTEMBER 17, 2010 FRIDAY, DERRICK ROSE WAS PLACED IN THE GRANT COUNTY DETENTION CENTER ON A BENCH WARRANT. ALL BOOKING PROCEDURES WERE FOLLOWED BY THE BOOKING OFFICER DEPUTY ADAM WALTERS.

SEPTEMBER 18, 2010 SATURDAY AT APPROXIMATELY 0944 HRS. AN INMATE CARLOS TORRES IN CELL D-85 SET OFF THE SCREAM ALARM SHOUTING "I'M GOING TO KILL MYSELF" SGT. TROY HALE WAS NOTIFIED OF THE SITUATION AND TOOK IMMEDIATE ACTION TO SECURE THE SAFETY OF THE INMATE. SGT. HALE INSTRUCTED DEPUTY KOLE MC DONALD TO LOCATE A SINGLECELL UP FRONT TO LODGE INMATE TORRES IN ORDER TO PLACE HIM ON A ONE ON ONE HIGH WATCH. THE CONTROL ROOM OPERATOR DEPUTY ADAM WALTERS CALLED FOR A WATCH TOUR IN MAX CELLS, DEPUTY MC DONALD WAS BUSY WITH INMATE TORRES AND COULD NOT DO THE CELL CHECK AT THAT TIME.

AT APPROXIMATELY 10:30 AM DEPUTY EDWARD HIRST BEGAN HIS ROUTINE MAXIMUM SECURITY WATCH TOUR IN CELL BLOCK D-07. DEPUTY HIRST CHECKING THE CELLS APPROCHED CELL D-05 LOOKED INSIDE AND SAW INMATE ROSE HANGING BY A BLUE SHEET TIED TO THE VENT IN THE CEILING. DEPUTY HIRST CALLED "CODE BLUE" SGT. TROY HALE, AND THE MEDICAL NURSES RAE AND TAMRA RUSHED TO THE CELL IMMEDIATELY. SGT. HALE ENTERED THE CELL FIRST AND OBSERVED INMATE ROSE HANGING WITH A BLUE SHEET AROUND HIS NECK, HIS TOE'S TOUCHING THE FLOOR, AND HIS BACK FACING THE DOOR, WITH THE NURSES FOLLOWING, SGT. HALE HELD INMATE ROSE UP WHILE THE NURSE UNTIED THE KNOT AND REMOVED THE SHEET FROM AROUND INMATE ROSE NECK. SGT. HALE AND THE MEDICAL STAFF STARTED C.P.R.

CONTROL ROOM OPERATOR DEPUTY WALTERS CALLED 911 AND FOR AN AMBULANCE THEN PLACED THE JAIL ON CODE YELLOW. SUPERVISORS WERE NOTIFIED OF THE INCIDENT, THE KENTUCKY STATE POLICE WAS NOTIFIED AND BECAME THE LEAD INVESTIGATORS.

CPL. ANGELA YOUNG TOOK VIDEO OF THE C.P.R. ACTIVITIES AND CELL D-05.

DEPUTY JAMES KEATON RESPONDED TO THE LOCATION AND ASSISTED WITH LEADING THE KENTUCKY STATE TROOPERS AND PARAMEDICS TO CELL D-05. THE MEDICAL PARAMEDICS ASSISTED SGT. HALE WITH DOING THE CHEST COMPRESSION. SGT. HALE CONTINUED TO PERFORM CPR INTO THE AMBULANCE AND TRAVELLED WITH INMATE ROSE TO THE HOSPITAL CONTINUING CPR UNTIL THEY REACHED THE HOSPITAL AND WAS RELIEVED BY THE EMERGENCY ROOM DOCTOR.

IN SUMMARY, DURING THE BOOKING PROCEDURE INMATE ROSE DID NOT DISPLAY ANY SIGNS OR SYMPTOMS OF SUICIDE TENDENCIES, INMATE ROSE WAS NOT UNDER THE INFLUENCE OF ALCOHOL OR DRUGS.

LODGING OF INMATE ROSE WAS FOLLOWED IN ACCORDANCE WITH THE OPERATIONAL PROCEDURES. INMATE ROSE RAISED NO FLAGS OF SELF HARM WHEN LODGED IN HIS CELL.

INMATE ROSE DISPLAYED AGITATION CONCERNING HIS ARREST AND WAS TALKED TO BY THE PRE-TRAIL OFFICER.

THERE IS NO VIOLATION OF GRANT COUNTY DETENTION CENTER RULES AND REGULATIONS OR OPERATION PROCEDURES, ALL DEPUTIES PERFORMED THEIR DUTIES IN A RESPONSIBLE AND PROFESSIONAL MANNER.
