
On March 25, 2024, the Defendant filed a written plea of not guilty by reason of insanity. This same date, the State filed a motion to obtain a second opinion evaluation and requested the Court designate the Southern Ohio Forensic Evaluation Services (SOFES) to conduct this second evaluation pursuant to R.C. 2945.371.

Upon motion of the State, and for good cause shown,

**IT IS HEREBY ORDERED** that SOFES shall conduct a psychiatric examination of Defendant's mental condition at the time of the offense(s) charged.

**IT IS FURTHER ORDERED** that SOFES, on or before **April 26, 2024**, shall complete this examination, prepare and provide a written report setting forth the examiner's findings, the basis for said findings, and the examiner's opinions concerning the Defendant's mental condition at the time of the offense(s) charged. This report shall be submitted to the Court only, **via fax, at 513-732-7987**, and the Court will distribute it to counsel of record.

**IT IS FURTHER ORDERED** that as the Defendant is incarcerated, the evaluation shall take place at the Clermont County Jail.
