SUMMARY

On 02/27/2024, I was dispatched to a threats complaint in the Town of Blue Mounds, County of Dane, and State of WI. The caller stated that while at work, she received a threats call from someone from Texas, who told her to kill herself and that he would kill her. The caller advised that the individual sounded to be in their twenties. I spoke with the caller via phone.

INITIAL INFORMATION

On Tuesday, 02/27/2024, I was employed as a Deputy Sheriff for the Dane County Sheriff's Office. I was assigned to work the 3:00 p.m. to 11:00 p.m. shift out of the West Precinct as Willy 3. I was dressed in my full Dane County Sheriff's Office class B uniform, and operating fully marked squad #40.

INCIDENT INFORMATION

On Tuesday, 02/27/2024, at approximately 4:04 p.m., I self-assigned a threats call at Ridglan Farms in the Town of Blue Mounds, County of Dane, State of WI. The caller, who was later identified verbally as Pamela Burke, informed Dispatch that while at work, she received a call from someone from Texas who threatened to kill her and told her to kill herself. Pamela told Dispatch that the caller sounded to be in their twenties.

I called Pamela and asked her what was going on. She stated that she got two calls from the same individual, threatening harm to herself. She stated that she wanted to report it. Pamela stated she got one call on Friday afternoon at approximately 1:07 p.m. Pamela stated that she picked up the phone and individual on the other end, who was a younger male, was rambling on about how he was upset about what goes on at Ridglan Farms. Pamela stated she then hung up on this individual.

Pamela stated they then received a second call and Pamela did not answer it and let it go to voicemail/answering machine. Pamela stated that on the voicemail, the individual stated, why did you hang up on me bitch. He also stated something to the effect of, I'm going to fucking kill you and you should just kill yourself. Pamela played the voicemail for me and it goes on to more of the same. The individual is very upset about what goes on at Ridglan Farms and

threatens harm to Pamela.

Pamela stated she wasn't going to call, but her coworkers convinced her to. Pamela then gave me the phone number that had been used to call her, and I informed Pamela I would try to call the number and see what happens. I then told Pamela to call Dispatch if any other threats occur. Pamela stated she would. This ended my contact with Pamela.

ATTEMPTED CONTACT WITH INDIVIDUAL

I then called the phone number that Pamela had given Dispatch and I and was unable to reach anybody, and the phone went directly to voicemail.
