Hi Roger,

Thank you for following up. ICAN is interested in records related only to the pandemic which is why ACTIV (Accelerating COVID-19 Therapeutic Interventions and Vaccines) is a search term and why we explained that the request was related to the cited interview of Dr. Francis Collins.

I would imagine there would not be many responsive documents related to Lupus as: (i) the dates are fairly limited to the past 5 months (April 17, 2020); (ii) the searches are limited to 12 specific people; and (iii) there are only 3 search terms to be used in conjunction with the Hydroychloroquine/HCQ/Plaquenil terms that *do not* specifically limit the search to something COVID-related: preclinical OR pre-clinical OR WG. If there are in fact many work groups or preclinical-related documents dealing with lupus and not COVID from these individuals during this time period, it would be helpful to know that so that we can discuss next steps. However, I feel that limiting our search at this time with additional search terms will only complicate things and risk relevant documents not being captured for very little pay off.

Please advise and let me know if I can offer any other information. I appreciate your assistance.

In reference to NIH FOIA case number 54934, the issue is that you ask for expedited processing related to COVID-19, but then seek records that do not restrict the search to that topic. That is why it influences our decision on approving expedited processing. Hydroychloroquine (or HCQ or Plaquenil) are used to treat lupus, and NIH conducts lupus research. To finalize our determination and to speed our search for responsive records, we would need to know that you are interested in records related to the pandemic, as opposed to, e.g., lupus, and your request must include specificity.

Request 54933:

- 1. Yes, where the request mistakenly says "FDA" please correct to NIH. Thank you.
- 2. Please search the following 12 individuals' records: Francis Collins; Anthony Fauci; Gary Gibbons; James Anderson; Marc Charette; Christine Colvis; Joshua Fessel; Clint Florence; Judith Hewitt; Samantha Jonson; Elizabeth Ottinger; and Antonella (Tony) Punturieri.

Request 54934:

1. The search terms you mention (pre-clinical, preclinical, WG) should only be hit upon if the document also hits upon

one or more of the terms "hydroxychloroquine" OR "HCQ" OR "Plaquenil."

2. I am not sure what you mean by: "In order to move forward with a new determination for expedited processing in this case, the request should be amended to require various permutations of the term COVID-19." There are no search terms that we requested that involve the phrase "COVID-19" and so no need to have different permutations.

The terms we would like searched in the listed individuals' emails are: (ACTIV OR preclinical OR pre-clinical OR WG) AND (hydroxychloroquine OR HCQ OR Plaquenil)

As explained: These search terms should capture any emails that contain one or more of the terms within the first parenthetical *in addition to* one or more of the terms in the second parenthetical. For example, if an email contains the term "preclinical" *but does not contain* "hydroxychloroquine" or "HCQ" or "Plaquenil," it would not be responsive.
