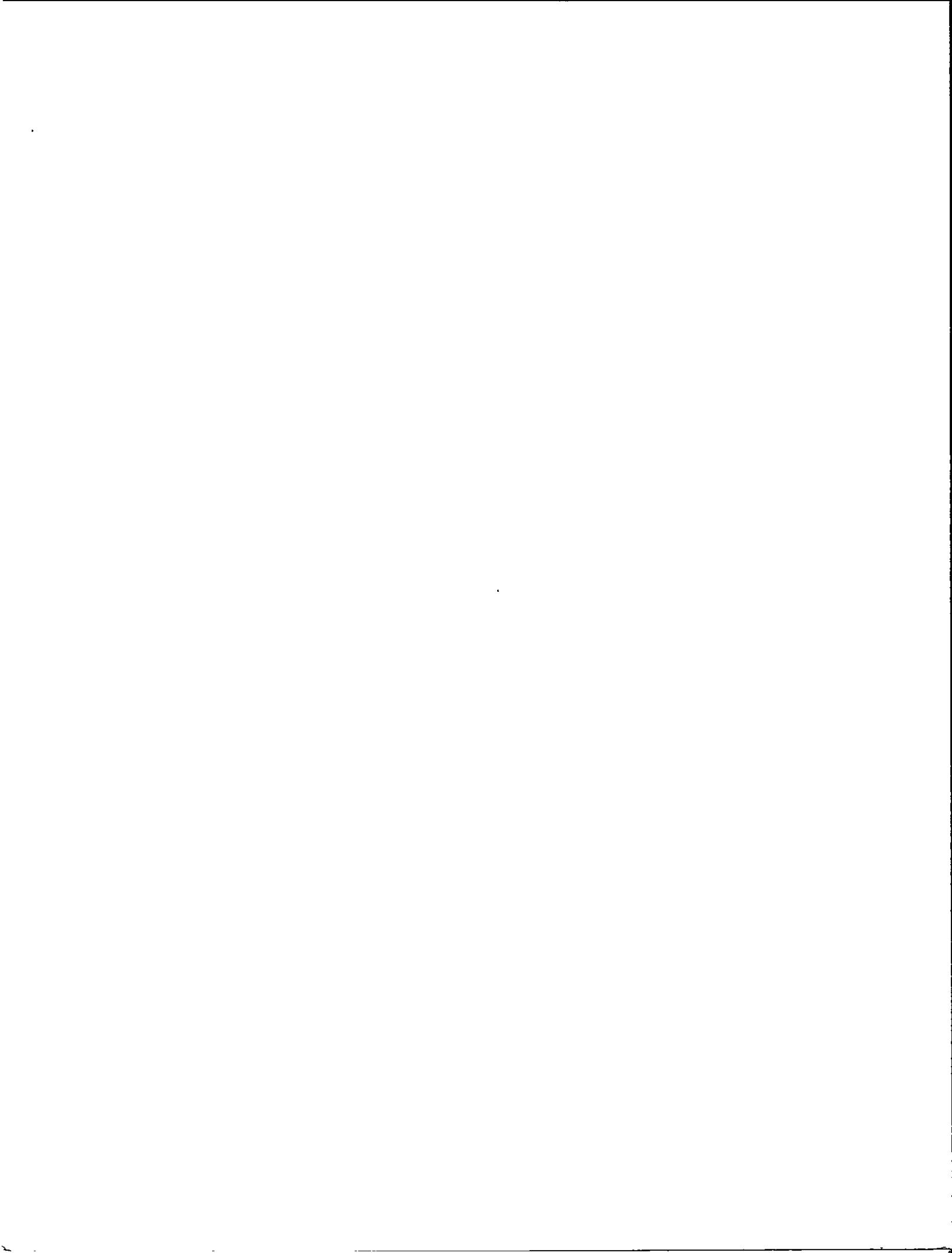

His Medal of Honor was awarded in April 8, 1898 for action while assigned to the 4th U.S. Cavalry in the 1886 Geronimo campaign. Please include any available supporting documents and correspondence in addition to the citation.

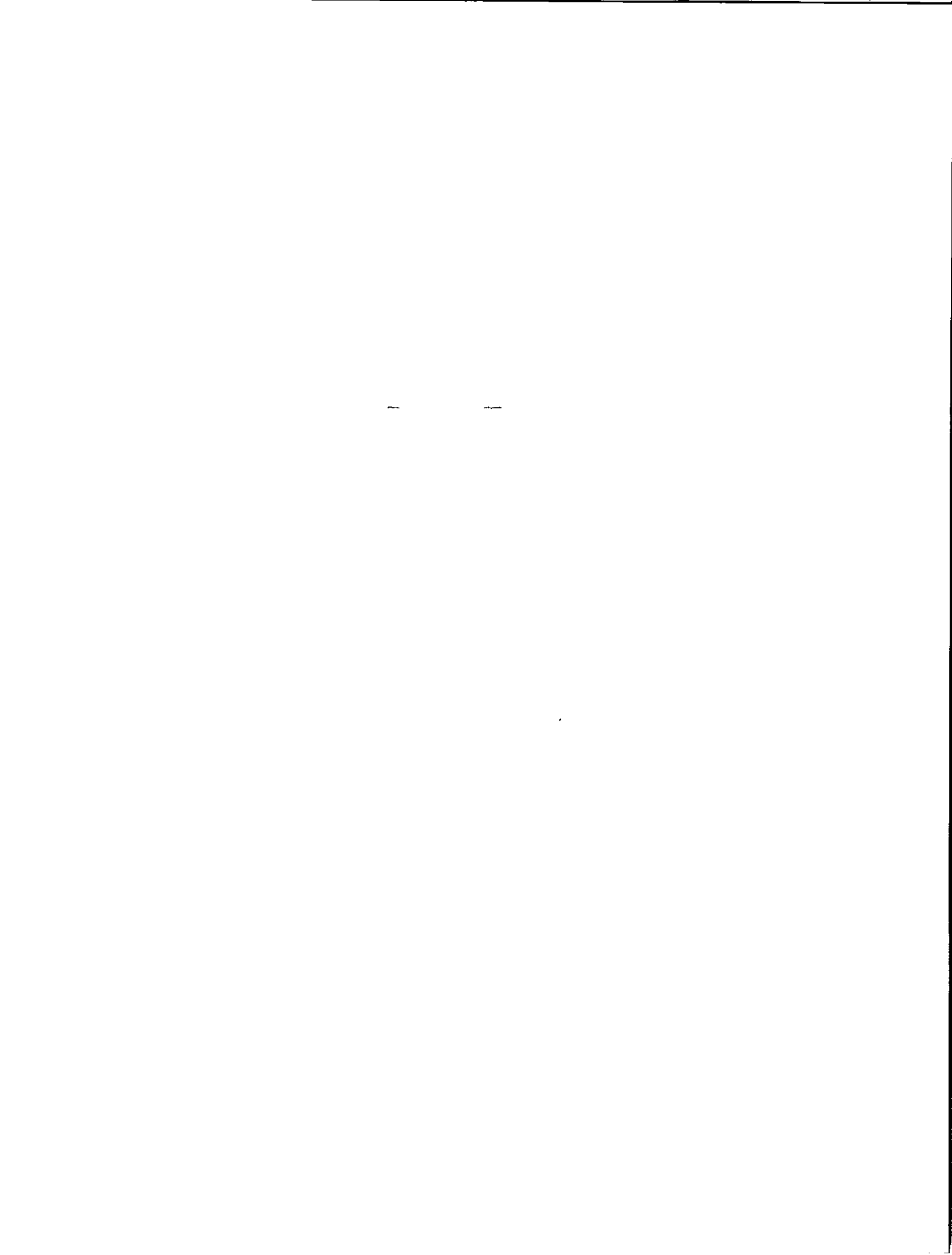
