REASON FOR CONTACT:

ON OCTOBER 12, 2015 AT ABOUT 7:55AM, ARRESTING OFFICER POOLE, #4865, RESPONDED TO A STABBING CALL, INVOLVING THE ARRESTED PERSON AT 8500 WALNUT HILL LN, DALLAS, DALLAS COUNTY, TEXAS

CHARGE 1: MURDER SEC. 19.02 (B) (1) F/1

ON OCTOBER 12, 2015 AT APPROXIMATELY 7:55 A.M. ARRESTED PERSON JOHNSON, THOMAS APPROACHED AN UNIDENTIFIED COMPLAINANT WHO WAS JOGGING WHITE ROCK CREEK TRAIL AT MARKER #227. THE LOCATION IS UNDER A BRIDGE AT 8500 WALNUT HILL LN.

THE ARRESTED PERSON THEN STRUCK THE COMPLAINANT IN THE HEAD MULTIPLE TIMES WITH A LARGE BLADED KNIFE. THE COMPLAINANT FELL TO THE GROUND. THE ARRESTED PERSON FLED THE SCENE.

THE ARRESTED PERSON THEN APPROACHED WITNESS HAGEN, JASON AND ASKED TO USE HIS CELL PHONE TO CALL 911. THE ARRESTED PERSON CALLED 911 ON WITNESS HAGEN'S CELL PHONE AND STATED "AN UNKNOWN INDIVIDUAL WAS LAYING DOWN WITH A SWORD IN HIS HEAD AND NOT MOVING."

DALLAS FIRE RESCUE #37 AND ENGINE 28 RESPONDED TO THE SCENE AND FOUND THE COMPLAINANT LAYING ON THE GROUND WITH A LARGE BLADED KNIFE IN HIS HEAD. DALLAS FIRE RESCUE IMMEDIATELY TRANSPORTED THE COMPLAINANT TO PRESBYTERIAN HOSPITAL FOR MEDICAL ASSISTANCE.

ARRESTING OFFICER POOLE, MICHAEL, #4865, WAS DISPATCHED TO 7803 FAIR OAKS AVE TO WHITE ROCK TRAIL MARKER #222. ARRESTING OFFICER POOLE #4865 THEN CALLED WITNESS HAGEN ON THE CELL PHONE TRYING TO FIND THE CORRECT LOCATION. WITNESS HAGEN ANSWERED HIS CELL PHONE AND SPOKE WITH ARRESTING OFFICER POOLE, #4865, AND ADVISED THAT THE CRIME SCENE WAS ACTUALLY AT WHITE ROCK CREEK TRAIL MARKER #227 WHICH WAS UNDER THE BRIDGE AT 8500 WALNUT HILL LN.

ARRESTING OFFICER POOLE #4865 WENT TO LISTED LOCATION AND OBSERVED DALLAS FIRE RESCUE #37 LEAVING WITH THE COMPLAINANT TO PRESBYTERIAN HOSPITAL. ARRESTING OFFICER POOLE, #4865, OBSERVED THE ARRESTED PERSON SITTING NEXT TO A CONCRETE PILLAR.

AS ARRESTING OFFICER POOLE, #4865, WALKED UP TO THE SCENE THE ARRESTED PERSON STATED "I NEED TO TALK TO YOU." ARRESTING OFFICER POOLE, #4865, STATED TO THE ARRESTED PERSON TO HOLD ON ONE SECOND SO HE COULD SPEAK WITH DALLAS FIRE RESCUE PERSONNEL.

AS ARRESTING OFFICER POOLE, #4865, WAS TALKING TO FIREFIGHTERS ON DALLAS FIRE RESCUE ENGINE #28, WITNESS HAGEN ADVISED THAT THE ARRESTED PERSON HAD RAN UP TO HIM AND WANTED TO USE HIS CELL PHONE TO CALL THE POLICE. WITNESS HAGEN ALLOWED THE ARRESTED PERSON TO USE HIS CELL PHONE TO CALL THE POLICE. THE ARRESTED PERSON CALLED 911 AND ADVISED THAT AN UNKNOWN WHITE MALE WAS LYING ON THE GROUND WITH A SWORD IN HIS HEAD. THE ARRESTED PERSON GAVE THE DESCRIPTION OF THE LOCATION OF WHERE THE COMPLAINANT WAS ON THE TRAIL. THE ARRESTED PERSON THEN DIRECTED WITNESS HAGEN AND WITNESS LAWRENCE, JONATHAN TO THE LOCATION AND TO THE COMPLAINANT'S BODY.

DALLAS FIRE RESCUE #37 ARRIVED AND QUICKLY TRANSPORTED THE COMPLAINANT TO PRESBYTERIAN HOSPITAL. ARRESTING OFFICER POOLE, #4865, THEN WENT TO SPEAK WITH THE ARRESTED PERSON AND ASKED HIM WHAT HE COULD DO FOR HIM. THE ARRESTED PERSON STATED "I JUST COMMITTED CAPITAL MURDER, I JUST COMMITTED CAPITAL MURDER." ARRESTING OFFICER POOLE #4865 THEN ASKED THE ARRESTED PERSON WHAT HE MEANT, THE ARRESTED PERSON STATED "IT'S LIKE WHEN YOU DON'T WAKE UP."

ARRESTING OFFICERS POOLE #4865 AND NEWHOUSE, JEFFERY #8929 PLACED THE ARRESTED PERSON

IN HANDCUFFS FOR OFFICER SAFETY. ARRESTING OFFICERS POOLE #4865 AND NEWHOUSE #8929 RAISED THE ARRESTED PERSONS TO HIS FEET AND ARRESTING OFFICERS NOTICED BLOOD ON HIS PANTS. THE ARRESTED PERSON WAS PLACED IN NORTH EAST PATROL PADDY WAGON.

WITNESS DAVENPORT, BRANDON ADVISED HE WAS RIDING HIS BICYCLE ON THE WHITE ROCK CREEK TRAIL WHEN HE OBSERVED AN INDIVIDUAL WEARING A RED HOODIE STRIKING THE COMPLAINANT IN THE HEAD WITH A LARGE KNIFE. WITNESS DAVENPORT STOPPED A SAFE DISTANCE BACK AND CALLED 911. ARRESTING OFFICER POOLE #4865, AND ARRESTING OFFICER NEWHOUSE #8929 SECURED THE SCENE.

ARRESTING OFFICER POOLE #4865 NOTIFIED THE HOMICIDE UNIT AND CRIME SCENE ABOUT THE INCIDENT. CRIME SCENE AND THE HOMICIDE UNIT PROCESSED THE CRIME SCENE. ARRESTING OFFICER NEWHOUSE, #8929, TRANSPORTED THE ARRESTED PERSON TO JACK EVANS HEADQUARTERS FOR QUESTIONING BY DETECTIVES.

WITNESS DAVENPORT SPOKE WITH DETECTIVE MONTENEGRO #6991. WITNESS DAVENPORT STATED TO DETECTIVE MONTENEGRO #6991 THAT HE OBSERVED A SILHOUETTE OF THE ARRESTED PERSON STRIKING THE COMPLAINANT SEVERAL TIMES ABOUT HIS HEAD.

DETECTIVE MONTENEGRO, #6991, ISSUED MIRANDA WARNING TO ARRESTED PERSON. THE ARRESTED PERSON VOLUNTARILY WAIVED HIS RIGHT TO REMAIN SILENT AND AGREED TO TALK WITH THE DETECTIVES. THE ARRESTED PERSON CONFESSED TO THE COMMISSION OF THIS OFFENSE.

THE ARRESTED PERSON THEN WAS TRANSPORTED AND PLACED IN LEW STERRETT JAIL BY ARRESTING OFFICERS POOLE #4865 AND TALLEY, BENJAMIN #9605. THE ARRESTED PERSON WAS IDENTIFIED BY AIS #2934915. #JI55 AND TLETS REVEALED NO PRIOR MURDER CONVICTIONS.

THE COMPLAINANT WAS TRANSPORTED TO THE DALLAS MEDICAL EXAMINER'S OFFICE AND HAS NOT BEEN IDENTIFIED AT TIME OF REPORT.

THE ARRESTED PERSON HAS THE FOLLOWING PRIOR FELONY CONVICTIONS:

1. ON JANUARY 9, 2015, IN THE 204TH DISTRICT COURT IN DALLAS, THE ARRESTED PERSON PLED GUILTY TO UNAUTHORIZED USE OF A VEHICLE AND WAS SENTENCED TO 4 YEARS PROBATION AND A \$1500 FINE.
2. ON JANUARY 9, 2015, IN THE 204TH DISTRICT COURT IN DALLAS, THE ARRESTED PERSON PLED GUILTY TO BURGLARY OF A HABITATION AND WAS SENTENCE TO 4 YEARS PROBATION AND A \$2000 FINE.




