COUNCILMEMBER THOMAS HOSTS 2nd ANNUAL DEED RESTRICTION WORKSHOP

Houston, TX, April 27, 2024—Deed restrictions are recorded agreements that limit how an individual piece of land may be used by its owners. In their simplest form, deed restrictions are exactly what they sound like: legally binding restrictions the landowner must abide by. When implemented well, deed restrictions are invaluable tools used to protect home values in residential neighborhoods and to restrict unwelcome businesses from moving into areas where they are not wanted.

Tiffany D. Thomas, Houston City Councilmember for District F, Chair of the city's Housing & Affordability Committee, and a staunch advocate for affordable housing, will lead a workshop aimed at helping homeowners, neighborhood champions, and community leaders understand the opportunities and limitations of deed restrictions; tools and tips to protect their homes from fraudulent contractors; and estate planning resources available to protect and plan for the future.

Thomas has been actively addressing the issue of short-term rentals in Houston. These rentals have caused concerns due to their misuse, including disruptive parties and criminal activities.

Meanwhile, Houston's civility ordinance, which was created in 2002, prevents anyone from sitting, sleeping, or laying their possessions on city sidewalks between 7 a.m. and 11 p.m. There are certain situations where the ordinance does not apply. This regulation aims to maintain order and safety in public spaces. Participants will gain more information regarding the current ordinance and how it's being implemented.
