Upon reading and filing the affirmation of Assistant District Attorney Christopher Conroy, dated April 25, 2024, and the exhibits annexed thereto, and good cause having been shown on the record before the Court, it is hereby:

ORDERED that pursuant to Judiciary Law § 750(A)(3), defendant Donald J. Trump show cause before the Supreme Court of the State of New York, County of New York, the Honorable Juan M. Merchan presiding, located at 100 Centre Street, Part 59, in Manhattan, on the 1st day of ^{May} ~~April~~, 2024, at 2:15 PM, or as soon thereafter as counsel may be heard,

why this Court should not issue an order granting the following relief:

1. holding defendant in criminal contempt of this Court, and imposing a fine of \$1,000 pursuant to Sections 750(A)(3) and 751(1) of the Judiciary Law, for defendant's willful violation of the Court's April 1, 2024 Decision and Order on the People's Motion for Clarification or Confirmation of An Order Restricting Extrajudicial Statements, by virtue of a statement defendant made to the media in the hallway of 100 Centre Street, outside the door to Supreme Court of the State of New York State County of New York Part 59, on April 22, 2024 at approximately 12:40 P.M. after court adjourned for the day; and

2. holding defendant in criminal contempt of this Court, and imposing a fine of \$1,000 pursuant to Sections 750(A)(3) and 751(1) of the Judiciary Law, for defendant's willful violation of the Court's April 1, 2024 Decision and Order on the People's Motion for Clarification or Confirmation of An Order Restricting Extrajudicial Statements, by virtue of an interview defendant gave on April 22, 2024 at approximately 6:00 p.m. to a program called Just The News, No Noise, which is broadcasted on a network called Real America's Voice; and
3. holding defendant in criminal contempt of this Court, and imposing a fine of \$1,000 pursuant to Sections 750(A)(3) and 751(1) of the Judiciary Law, for defendant's willful violation of the Court's April 1, 2024 Decision and Order on the People's Motion for Clarification or Confirmation of An Order Restricting Extrajudicial Statements, by virtue of an interview defendant gave to a program called "Action News" which is an ABC news affiliate in Pennsylvania, on April 23, 2024 which aired at approximately 5:56 p.m.; and
4. holding defendant in criminal contempt of this Court, and imposing a fine of \$1,000 pursuant to Sections 750(A)(3) and 751(1) of the Judiciary Law, for defendant's willful violation of the Court's April 1, 2024 Decision and Order on the People's Motion for Clarification or Confirmation of An Order Restricting Extrajudicial Statements, by virtue of a press event defendant held at 49th Street and Park Avenue here in Manhattan today, on April 25, 2024, at approximately 6:35 a.m.; and
5. granting such other relief as the Court deems just and proper; and it is further


ORDERED, that copies of this Order to Show Cause and Affirmation of Christopher Conroy, shall be served personally on defendant and on Todd Blanche, counsel for the defendant, and the defendant in Supreme Court of the State of New York, County of New York Part 59 on or before April 25, 2024, and that such be deemed due and sufficient service; and it is further

ORDERED, that any answering papers shall be served on the New York County District Attorney's Office by email to Assistant District Attorney Christopher Conroy, at conroyc@dany.nyc.gov, and filed with the Court according to the Protective Order and applicable Court directives governing the filing of materials, so that they are received in the District Attorney's Office on or before 5:00 P.m. April 25th 2024.
