Chain of Command History






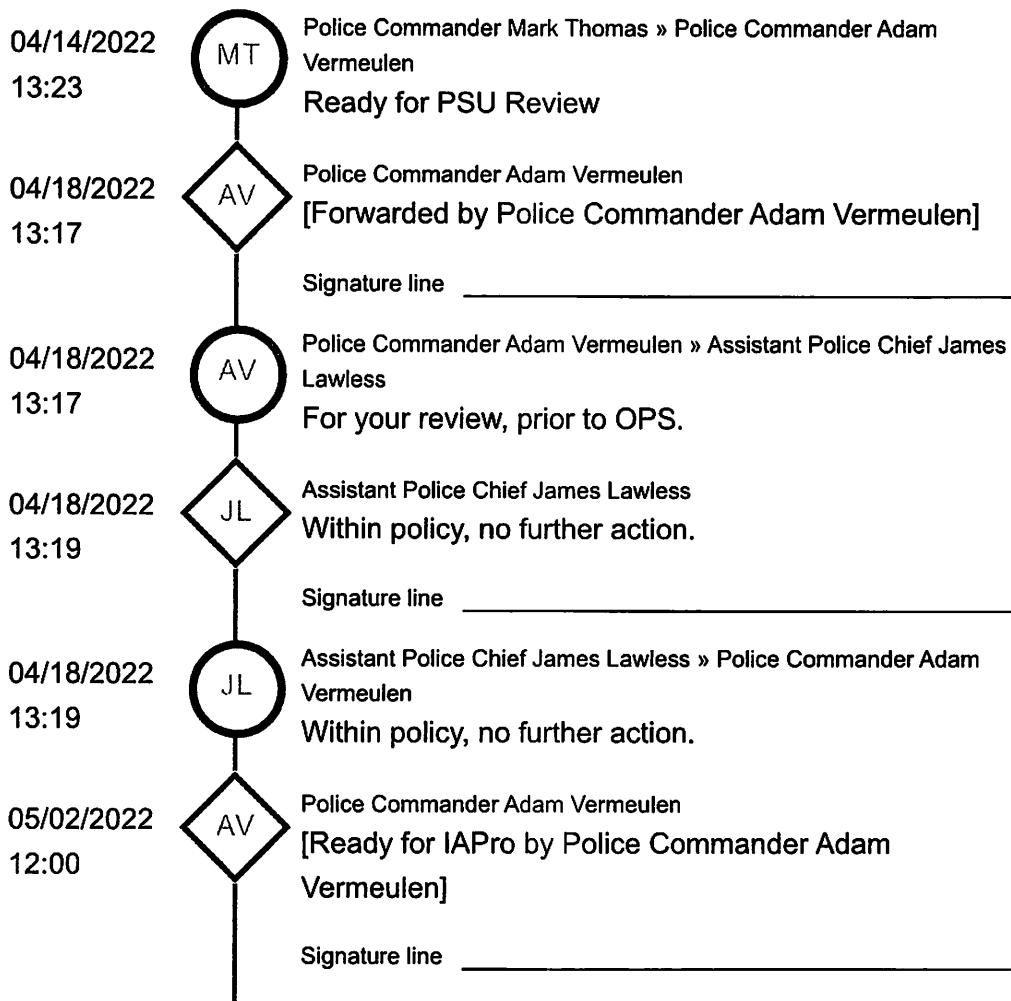

AUTHORITY:

I, Alicia Cikauskas, am a Custody Officer with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 1635 Grove Street within the city limits of Marysville, Snohomish County, Washington.

ELEMENTS OF CRIME/INCIDENT:

STATEMENTS:

On 03/11/2022 at approximately 0915 hours, I Custody Officer (C/O) Alicia Cikauskas (MP0210) was working in the booking area when Inmate (I/M) Cody Tyler (date of birth 09/09/1992) was brought into the jail for a booking. I was working on entering the citation when I heard I/M Tyler begin to refuse directives given by Officer Allen (MP0158) to remove his shoes. After several attempts to have I/M Tyler remove his own shoes, he was escorted by Officers Allen and Morton (MP0110) to the padded holding cell in booking. I saw I/M Tyler begin to tense up his muscles, actively resisting the escort, so I followed to assist Officers Allen and Morton. Once control was gained of I/M Tyler, I moved to remove his shoes, socks, pants and cut off his t-shirt. I/M Tyler was then handcuffed and I left the cell so Officers Allen and Morton could continue a forced strip search.

OFFICER ACTIONS:

Removed Inmate Tyler (DOB 09/09/1992) shoes, socks, pants, t-shirt during forced strip search.
