Officer Assignment: I, Kristen Ehr, am a commissioned police officer in the State of Washington and employed by the City of Marysville, County of Snohomish. I was on patrol on today's date and time, in the area described above, within the city limits of Marysville, in a fully marked police vehicle with emergency lights, siren and decals and in full police uniform complete with badge and shoulder patches. This incident was captured on my department issued Axon body-worn video camera, which was activated and running at the time of this incident, and was uploaded to Evidence.com. Below is a summary of the footage captured by my body worn camera.

On the above date and time I responded to a report of transients that were refusing to leave Jennings Park at 6915 51<sup>st</sup> Ave NE, Marysville, WA, a city owned park. There was a report that there was a kids camp being held at the park today and park employees had asked some transients to leave the park. The transients refused to leave the park when asked by the employees.

I arrived on scene and contacted two park employees in the park office. They told me that they asked the two males to move out of this part of the park. The employee told me that one of the subjects had a shopping cart. The employee described the males as white and in their 20's and one had curly brown hair. The employees told me that they had asked the subjects to leave the park, the subjects refused, and that they wanted them trespasses from the park.

I walked around the park and I saw a shopping cart full of items near the red barn in the park. I then walked the pathway on the south side of the red building. Two white males came walking back up the pathway. One of the males said that the shopping cart was his. It was explained to the males that we were contacting them because they had been told by park employees to leave the park and they refused. One of the males was later identified by other officers as Elliot Luckenbach. I asked the other male what his name was multiple times and refused to give it to me. He said he would just leave and refused to give me his name. I told him that he



was being detained because he refused to leave earlier when the park employees asked him to, so he needed to identify himself. The male refused to identify himself. He was told that if he did not identify himself he would be under arrest for obstruction. Ofc Allen then detained the male in handcuffs because he was obstructing us by refusing to give his name multiple times. After the male was in handcuffs he was verbally identified as Aleksander Senchenko. I then took Senchenko back to my patrol car in the Marysville Historical Society parking lot at 6805 Armar Rd near the park. I verified that it was him through his DOL photo on my mobile data computer in my car. Senchenko came back with a misdemeanor warrant out of Marysville. The warrant was confirmed. Another officer issued Luckenbach a notice of trespass from Jennings Park and he was released from the scene. I issued Senchenko a trespass notice from Jennings Park. Senchenko told me that he understood it and I wrote in custody on the signature line.

Senchenko was under arrest for Obstructing a Law Enforcement Officer (RCW 9A.76.020) because he refused to identify himself multiple times even after being given a warning that he would be arrested if he continued to refuse. This hindered and delayed our investigation because we had to keep explaining why we were contacting him and asking him to identify himself. Senchenko was also under arrest for his warrant out of Marysville that had been confirmed.

When I went to search Senchenko incident to arrest he had a small bag strapped around his shoulder. The bag had no buckles to undo the strap, so Ofc Allen grabbed one of Senchenko's arms while I undid one of the handcuffs to remove the bag. After I removed the bag I went to put the handcuff back on and Senchenko pulled away from us before I could put it back on, and with one handcuff still on his wrist started running away. Senchenko ran back to the park that he had been trespassed from with Ofc Allen's handcuffs. Other officers and I then got in a foot pursuit with Senchenko as he ran back to the park. Another officer caught up with Senchenko and got him on the ground and had grabbed his arm. I grabbed Senchenko's legs because he was still trying to get back up. I told Senchenko to get on his stomach and he did so. Another officer then got the handcuffs back on Senchenko.

I then searched Senchenko and his bag incident to arrest. During the search incident to arrest I found what I recognized from my training and experience as drug paraphernalia including tin foil with burn marks, tooters, and meth pipes. From my training and experience I know that tooters are homemade pipes that are used to smoke narcotics off some kind of platform like the tin foil I found. Narcotics are placed on the tin foil and heated up and smoked. The narcotics leave

a burnt residue on the tin foil when they are heated up. I observed these burn marks on some of the foil I found. One of the pieces of foil still had part of what I recognized from my training and experience as a blue fentanyl pill partly burnt and stuck to the foil. I also found what I recognized from my training and experience as two meth pipes from the tube with a bulbous end with a hole in it to put narcotics through and smoke. Additionally I found a small baggie with what I recognized from my training and experience as multiple blue fentanyl pills. I found nothing else of evidentiary value during the search incident to arrest.

In addition to the charges of Obstructing a Law Enforcement Officer (RCW 9A.76.020) and the warrant as described above Senchenko was also under arrest for Resisting Arrest (RCW 9A.76.040) and theft in the third degree (RCW 9A.56.050). Senchenko resisted arrest when he pulled away and ran away after he had been placed under arrest for obstructing and his warrant. Senchenko told us that he ran away because he had the drug paraphernalia. Senchenko was under arrest for theft in the third degree because when he ran away he stole Ofc Allen's handcuffs and ran away with the cuffs. Additionally, Senchenko is being charged with Criminal trespass in the second degree (RCW 9A.52.080) because when he ran away he ran back onto the property that he was trespassed from.

After I finished the search incident to arrest I placed Senchenko in the back of my patrol car and read him his Miranda Rights from my department issued Miranda Card. Senchenko told me that he did understand his rights and did not want to talk to me. I did not ask Senchenko anymore questions.

I then transported Senchenko to the Marysville Jail to be booked on the above charges. A copy of Senchenko's citation for the above charges was left with his belongings at the jail. A copy of the trespass notice was also left in his belongings at the jail. I also issued Senchenko his first drug referral for the drug paraphernalia and narcotics that I found during the search incident to arrest. I wrote in custody on the signature line and a copy was left with his belongings at the jail.

I then booked the drug paraphernalia into Marysville Evidence for destruction.

**Officer Assignment:** I (Officer Allen) was assigned to the Marysville Police Department Patrol Division on the above date and time. My assignment on this day was as the MP0084 unit acting as a Field Training Officer (FTO) for Ofc Ehr. I was wearing the standard Marysville Police Department patrol uniform and driving a fully marked Marysville Police Department patrol car equipped with emergency lights, siren and decals. This incident was captured on my Axon body worn camera.

**Officer Action:** On 7/22/22 at approximately 0852hrs Ofc Ehr responded to a nuisance complaint at Jennings Park west (entrance) located at 6915 Armar Rd in the city of Marysville, WA. Marysville City Park employees had notified the police department of transients who had possibly set up a camp at the park and that there was to be a scheduled children's camp in that area today.

Ofc Ehr responded to the location and contacted the park employees who told her that they observed a disturbance involving two transients. They stated that the transients were associated with a red shopping cart filled with items. The transients were asked to leave and they had concerns that the transients were still in the area. We were notified that there was a scheduled children's camp in that area today and that there would be obvious safety issues with transients in the area.

The area pointed out by the park employees was a Red Barn next to the Marysville Historical Society building located at 6805 Armar Rd. This location's property is connected to the park. As Ofc Ehr conducted a foot patrol for the subjects a red Target shopping cart was located on the north side of the Historical Society. The shopping cart was full of someone's personal property to include a clothes washing machine on top.

There is a foot path next to the building where I have contacted transients that goes along the edge of the park. Ofc Ehr did a check on the path and we contacted two males. I asked the males if the shopping cart belonged to them and a male, later identified verbally as Elliot Luckenbach stated the shopping cart belonged to him. Both males were escorted to the top of the trail. I notified the males that the park employees had asked us to contact them as they had previously been asked to leave.

Luckenbach identified himself verbally to Ofc Ehr and the second male refused to identify himself. He started asking me questions and I notified him to direct his questions to Ofc Ehr as well as give her his identifying information. The male refused to identify himself multiple times even after being warned that he would be placed under arrest if he refused. The male continued to not identify himself after my warnings. Because the male refused to give his information I notified him that he was under arrest and I placed him in handcuffs (double locked, checked for fit) for obstructing police officer.

After he was placed under arrest he identified himself verbally as Aleksandr Senchenko. A DOL check on him returned with a misdemeanor warrant out of Marysville Court for possession of drug paraphernalia. Ofc Ehr had the warrant confirmed and shipped. He was notified he was under arrest for his warrant. Ofc Ehr completed and issued a 7 day trespass notice for Senchecko. She notified him that he was not allowed to go onto the park property for 7 days or he would be arrested for criminal trespass. Because he was in handcuffs she signed "In Custody" on the signature line.

Senchenko was wearing a messenger bag that needed to be removed. Ofc Ehr had to remove a handcuff in order to remove the messenger bag and as soon as she released Senchenko's right hand Senchenko pulled away forcefully and started running into the park he had just been trespassed from while wearing my handcuffs on his left wrist. A foot pursuit ensued and I unholstered my department issued Taser while chasing him on foot. Senchecko was tackled to the ground by Ofc Wiseman and I flipped the safety switch on my Taser doing a draw and direct on Senchecko while placing my Taser red dot on his back. I gave him verbal commands to stop there and if he moved I would Tase him.

As soon as he stopped struggling I rehandcuffed him. Ofc Ehr searched him incident to arrest and found drugs (suspected Fentanyl) and drug paraphernalia on his person. He was escorted back to the patrol vehicles where Ofc Ehr completed her investigation and I went back to my FTO duties observing Ofc Ehr. See Ofc Ehr's report for further information.

**Assignment:** At the time of this incident, I, **Officer Wiseman**, am a fully commissioned Police officer assigned to the Marysville Police Department, Patrol Division. I was wearing an authorized Marysville Police Department uniform complete with a cloth badge. I drive a fully marked Marysville Police Department Patrol vehicle equipped with emergency lights and sirens. On the above date, I was wearing a Body Worn Camera (BWC), S/N X60A3234R. The narrative below is a summary of the call; see BWC for any specific details.

**Actions:** On the above date and time, I responded to assist other units with a nuisance call at Jennings Park. While in route, Officer Schreck requested that I “step it up” so I responded priority to the call.

As I was arriving, it was announced that one subject was detained and incoming units could slow. I found the other officers out with two subjects. They had one male detained, whom they had already identified as Aleksandr Senchenko. I was able to identify the other male as Elliot Luckenbach. Other officers ended up taking Senchenko into custody for a warrant. I was asked to complete a trespass form for Luckenbach and I did, see case file for the copy of it.

After Luckenbach had been released, I was busy trying to get the cigarettes from Senchenko to give to Luckenbach, with permission from him when other officers released the handcuffs of Senchenko to remove a satchel style bag from his person. As soon as one handcuff was released, Senchenko pulled away from their grasp and began running eastbound. I caught up to him as other officers yelled commands for him to stop. As I wrapped my arms around him to tackle him, we both began to trip on a concrete curb and fell to the ground. On the ground, I was able to obtain a top mount position initially and gather his left arm, pinning it behind his back until others could re-apply the handcuffs. I did not see any injuries or hear of any for Senchenko.

This was the extent of my involvement in the case.
