On the above date at approximately 0315 hours, myself and officer Buell were preparing breakfast, corporal Stewart was in the booking area where inmate DIALLO, Aminata was temporarily housed as she came in under the influence and somewhat uncooperative. Corporal Stewart requested Officer Buell and I to come to the booking area to assist him.

When I got to the booking area Corporal Stewart had DIALLO by her left arm and was escorting her out of the holding cell where she was housed, Officer Buell was retrieving the restraint chair from the storage closet. As I approached and took control of DIALLO's right arm Corporal Stewart was telling DIALLO that because she had made claims that she was going to hurt herself she would be placed in the restraint chair and put under 15 minute observation. The incident was already occurring as I entered the booking area so I did not think to activate my BWC, I only thought of it most of the way through the restraint chair application at which time I noticed that Cpl. Stewart and Officer Buell already had there's activated.

While placing DIALLO into the restraint chair she was compliant, as we were finishing securing DIALLO in the restraint chair she ripped her right hand back and out of the wrist restraint and began to shout. She was yelling something about her belly hurting and that she needed a blanket for her belly. Once her right hand was re-secured in the restraint she was rolled into the padded cell and started on a 15 minute check.

- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 601 Delta Ave within the city limits of Marysville, Snohomish County, Washington.
- BWC: At the time of this incident I was wearing my department issued Body Worn Camera (BWC). The camera was activated and recording. The video footage was later uploaded to Evidence.com as evidence.

ELEMENTS OF CRIME/INCIDENT:

At approximately 0245 hours, Officer Stuver finished BAC processing on his DUI subject (Diallo) and turned her over to our custody to be booked into jail. We were informed that her blood alcohol level was over twice the legal limit, but not high enough to constitute a clear to book. I arrived shortly after the booking process began which is when I activated my BWC. During the booking process, Diallo was being less than cooperative by stating that we (Corporal Stewart and I) were rushing her and not giving her a chance to use the phone. We stated multiple times that we needed to book her in to jail first and then we would be more than happy to let her use the phone.

Diallo stated that we were judging her by her skin color. After we denied her claim, she insisted that we brought up race first and that we were being racist. She then said she felt that we were dangerous and she did not feel comfortable around us, demanded a female officer be present. We did not have any female officers available so we placed her in the holding cell so that her booking could be finished by female custody staff when day shift arrived that morning at 0600.

After approximately 20 minutes of being in the holding cell, Diallo started yelling out that she was having stomach pains. We asked what the cause of her stomach pains were and she told us that she had fibroids and needed to go to the emergency room immediately. She was unwilling to give us any more information and just kept yelling at us that she needed to go to the hospital. We told her this was not a reason to be transported to the hospital.

At approximately 0330, I was in the kitchen with Officer White preparing Breakfast for the inmates. By radio, Corporal Stewart requested our assistance in booking... Upon arriving in booking, Corporal Stewart asked me to grab the restraint chair since Diallo was threatening to hurt herself and was wrapping her blanket around her neck. I activated my BWC and grabbed the chair. Corporal Stewart, Officer White, and I secured her in the restraint chair without incident. After being safely secured in the restraint chair, Diallo pretended to fall unconscious. Corporal Stewart placed ammonia inhalants under her nose to be sure and she quickly jolted her head back. We then placed the restraint chair, with Diallo secure in it, into one of the padded cells. She was placed on suicide watch where we would physically check on her every 15 minutes.

Approximately 20 minutes later, Corporal Stewart and I tried to give her water. We activated our BWC before entering the cell. We unstrapped her right arm from the restraint chair so that she could drink the water herself. She was repeatedly yelling and gagging like she was going to puke. She was still complaining about her stomach pains and said that she needed her medication. After asking multiple times what medication she took, she finally told us Tylenol. I went to the medical exam room to retrieve Tylenol and then let her take it with her water.

After she was finished with her water, she placed her right hand through the strap on the restraint chair. Corporal Stewart gently tightened the strap down to the tightness it was at prior to releasing it. She suddenly screamed out in pain saying that we were hurting her hand with the strap. We inspected her hand and could see no visible injuries. We then closed her back into the cell.

At approximately 0415, Corporal Stewart called Officer Schreck from patrol to assist us in letting Diallo use the restroom. Before entering the cell I activated my BWC. Corporal Stewart and I worked on releasing the restraints and Diallo was still complaining about stomach pains, but this time informed us that she was menstruating. Officer Schreck assisted Diallo in using the restroom and I grabbed a couple feminine pads for her to use. After finishing using the restroom, Diallo complained of the mark on her arm being caused by the strap from the chair when we tightened it down. An image was taken of the mark with the handheld Guardian Spartan device.

We determined that Diallo was no longer trying to hurt herself, so we did not place her back into the restraint chair. Per policy she can still not be taken off of suicide watch until determined safe to do so by a mental health professional, so she stayed in the padded cell with only a mattress and a suicide blanket. I asked if she was hungry and wanted any food but she

would only respond with "I want to see my lawyer." Diallo remained on 15 minute checks until we were relieved by day shift at 0600.

- BWC: At the time of this incident I was wearing my department issued Body Worn
 Camera (BWC). The camera was activated and recording. The video footage was later
 uploaded to Evidence.com as evidence.

ELEMENTS OF CRIME/INCIDENT:

DIALLO, Aminata wrapped blanket around her neck and stated she was going to hurt herself. DIALLO was taken out of holding cell 1 and placed in the Emergency Restraint Chair to prevent further self-harm.

STATEMENTS:

DIALLO, Aminata was booked on a new DUI. During the DUI process DIALLO was unaware where she was at. DIALLO thought she was in Mount Vernon. DIALLO displayed up and down emotional behavior during the process. DIALLO's blood alcohol was over two times the legal limit.

Once Officer Stuver left and the booking began, DIALLO was argumentative from the start. She was demanding to use the phone. I was attempting to explain the booking process to her so she would have an understanding of what we needed to do. During my explanation, she started to talk over me. At this time, she stated she was feeling threatened by me and she wanted to be recorded. At her request I activated my BWC and showed her the blinking red light on the top to prove it was on. With the BWC recording, she stated she didn't feel comfortable with me helping her. I told her that was fine and told her booking Officer Buell could take over assisting her. She was not satisfied with that suggestion. She then stated she wanted a female officer

here. I told her we did not have any at the moment. She started demanding multiple female officers. I again told her we did not have any female custody officers on duty and there was nothing we could do about it. I told her the oncoming day shift had two female officers working. I told her we could postpone the completion of the booking until they come on shift. She agreed and I escorted her to holding cell 1. At this time, I de-activated my BWC.

When DIALLO was placed in the holding cell she was still wearing her own sweatpants and a stocking cap. I initially gave her one blanket, but she began to demand a second blanket because she was cold. I gave DIALLO a second blanket hoping it would help her go to sleep and stop being disruptive. While in holding cell 1, she began to yell that she needed to go to the ER. I asked her what her complaint was and she stated it was her abdomen and fibroids. She kept saying it was an African women issue because it was too cold in the room. I looked up fibroids on the internet and found that a large portion of females that suffer from them are African American females. The internet also said that fibroids are not fatal and are most common brought on by stress.

At approximately 0325 I was notified by Corporal Burtis that DIALLO had taken one of her blankets and started wrapping it around her neck. I radioed for Officer Buell and Officer White to come to booking and asked them to get the Emergency Restraint Chair. I went over to holding cell 1 and I could see DIALLO's foot standing on her toilet seat with one end of the blanket under it. At this time she had the blanket around her neck and appeared to start pulling the other end. Main control immediately opened the holding cell and as soon as DIALLO saw me come in, she quickly sat on her mat. I grabbed the blanket and unwrapped it from her neck. As I was unwrapping the blanket, she stated she was going to hurt herself. I placed DIALLO in an escort position and walked her into the booking hallway. I was not able to activate my BWC until we began to place her in the Restraint Chair.

At approximately 0335 DIALLO was placed in the Restraint Chair. At this time, all BWC's were activated. After we placed her in the chair, we reassessed the restraint straps so none of them were cutting off circulation. We also explained to her why she was placed in the chair. DIALLO wanted to say it was our fault for her actions. I explained we would check on her every 15 minutes because that is what our suicide watch policy states. All interaction we had with DIALLO following her being placed in the chair was recorded by our BWC. At one point DIALLO stated she needed water. I requested Officer Buell to assist me giving her water. During the water interaction, she began to scream and gag as if she was going to throw up. She also stated she needed her medication. Officer Buell was able to calm her down enough to ask what medication she takes. She stated she takes Tylenol for her abdominal pain. We asked her if she would like some Tylenol. Since it is not a prescription medication, we are allowed to give Tylenol to her. Officer Buell went to medical and got her two Tylenol. DIALLO was able to take the Tylenol. As I was tightening the strap to her right wrist, she began to scream that I cut her. I stopped to examine her wrist to see if there was any injury. I did not see any new injury.

DIALLO began to say she needed to go to the bathroom. I looked on my new world mobile agency roster to see if Officer Schreck was available to help us since DIALLO was only

comfortable with female officers. Officer Schreck came over to the jail and I explained to her that DIALLO was only comfortable with female officers. We took DIALLO out of the chair and told her Officer Schreck was going to assist her with going to the bathroom. At no time did DIALLO tell us that she was having female problems. In the bathroom, DIALLO told Schreck she need a feminine pad. DIALLO was trying to say we were not giving her feminine products. I told DIALLO she needed to be specific about things because as a male officer we do not always know what female inmates need.

After Schreck escorted DIALLO out from using the bathroom she was much calmer and was displaying more rational behavior, because of that we officially took DIALLO out of the restraint chair at 0435. We told her if there was any more self-harm attempts she would be placed back in the chair. I also told DIALLO she was still on suicide watch and we were going to have our department social worker come and talk to her before she was taken off the watch.

At 0555, Officer Maner and Officer Parrish arrived for duty. I gave them a pass down regarding DIALLO not being changed out yet because she didn't feel safe around male officer. I shared with them the sequence of events that occurred. A short time later, Corporal Saint Denis came on shift. I gave him the pass down about DIALLO being on suicide watch. I told him the same thing I told Maner and Parrish about her not being changed out yet. I asked Saint Denis if he would be able to get in contact with social work Rochelle Long to come and give DIALLO a mental evaluation.

Once she was done, I escorted her to the DUI processing room. At that time, Diallo appeared to be cooperating with Officer Stuver so I returned to the jail.

Once Officer Stuver completed his processing, Diallo was brought into booking. I was assigned to the jail control room at the time and had no further direct interaction with Diallo. However, given her demeanor and behavior, I continued to monitor her cell via camera from the control room.

At approximately 0235, I observed Diallo on her cell camera appear to wrap her blanket around her neck in what looked to be an attempt at self-harm. I advised Corporal Stewart of the situation and staff on the floor removed the blanket and placed her in the restraint chair.

During the booking process, Diallo was being less than cooperative by stating that we (Corporal Stewart and I) were rushing her and not giving her a chance to use the phone. We stated multiple times that we needed to book her in first and then we would be more than happy to let her use the phone.

Diallo stated that we were judging her by her skin color. After denying this claim, she insisted that we brought up race first and that we were being racist. She then said she felt that we were dangerous and did not feel comfortable around us and demanded a female officer be present. We did not have any female officers available so we placed her in the holding cell so that her booking could be finished by female custody staff when day shift arrived that morning at 0600.

After approximately 20 minutes of being in the holding cell, Diallo started yelling out that she was having stomach pains. We asked what the cause of her stomach pains were and she told us that she had fibroids and needed to go to the emergency room immediately. She was unwilling to give us any more information and just kept yelling at us that she needed to go to the hospital. We told her this was not a reason to be transported to the hospital.

At approximately 0330, I was in the kitchen with Officer White preparing Breakfast for the inmates. Corporal Stewart requested our assistance in booking over the radio. Upon arriving at booking, he asked me to grab the restraint chair as Diallo was threatening to hurt herself and was wrapping her blanket around her neck. I activated my BWC and grabbed the chair. Corporal Stewart, Officer White, and I strapped her in without incident. After being strapped in, Diallo pretended to fall unconscious. Corporal Stewart placed ammonia inhalants under her nose to be sure and she quickly jolted her head back. We then placed her inside the padded cell in the restraint chair and placed her on a 15 minute check suicide watch.

Approximately 20 minutes later, Corporal Stewart and I tried to give her water. We activated our BWC before entering the cell. We unstrapped her right arm from the restraint chair so that she could drink the water herself. She was repeatedly yelling and gagging like she was going to puke. She was still complaining about her stomach pains and said that she needed her medication. After asking multiple times what medication she took, she finally told us Tylenol. I went to the medical exam room to retrieve Tylenol and then let her take it with her water.

After she was finished with her water, she placed her right hand through the strap on the restraint chair. Corporal Stewart gently tightened the strap down to the tightness it was at prior to releasing it. She suddenly screamed out in pain saying that we were hurting her hand with the strap. We inspected her hand and could see no visible injuries. We then closed her back into the cell.

At approximately 0415, Corporal Stewart called Officer Schreck from patrol to assist us in letting Diallo use the restroom. Before entering the cell I activated my BWC. Corporal Stewart and I worked on releasing the restraints and Diallo was still complaining about stomach pains, but this time informed us that she was menstruating. Officer Schreck assisted Diallo in using the restroom and I grabbed a couple pads for her to use. After finishing using the restroom, Diallo complained of the mark on her arm being caused by the strap from the chair when we tightened it down. An image was taken of the mark with the handheld Guardian device.

We determined that Diallo was no longer trying to hurt herself, so we did not place her back into the restraint chair. Per policy she can still not be taken off of suicide watch until determined safe to do so by a mental health professional, so she stayed in the padded cell with only a mattress and a suicide blanket. I asked if she was hungry and wanted any food but she would only respond with she wanted to see her lawyer. Diallo remained on 15 minute checks until we were relieved by day shift at 0600.
