Officer Assignment: I, Amanda Stewart, am a commissioned police officer in the State of Washington and employed by the City of Marysville, County of Snohomish. I was on patrol on the above date and time, in the area described above, within the city limits of Marysville, in a fully marked police vehicle with emergency lights, siren and decals and in full police uniform complete with badge and shoulder patches. This incident was captured on my department issued Axon body-worn camera, which was activated and running at the time of this incident, and was uploaded to Evidence.com.

On the 12/17/2022 at approximately 1830 hours I arrived on scene of a reported assault call. I was the fourth Officer on scene and walked into the front door of the residence to see Officer Wiggins, Officer Herrera and Sergeant Carlile contacting a male in the kitchen of the residence. As I entered the kitchen Officer Wiggins and Sergeant Carlile were attempting to detain the male (who was later identified as Fred Lopez DOB: 02/26/1970). The male was screaming and yelling, tensing up his body resisting and not complying with commands to place his hands behind his back. I approached to help detain the male. Officer Wiggins had one handcuff placed on the subjects left hand and was attempting to cuff the second. The male began to yell stating that we needed to let him go, and that he had a hurt wrist from surgery. Sergeant Carlile requested that we place the male in handcuffs in the front of his body, using two sets of cuffs. The male was yelling not only profanities but also derogatory language pulling away from us the whole time.

We attempted to move the male outside of the house and to the front porch, during this time there was constant resistance from him. Fred when outside asked to sit down. While attempting to have Fred sit on the front porch, he fell to the floor kicking and screaming, shaking his fists continuing to yell derogatory comments at me and the other Officers.

Officer Herrera went inside and established that we had probable cause to arrest Fred for assault 4 DV, against both his wife (Veronica) and his brother in law (Randolph).

Fred continued to resist while attempting to walk him to our patrol car after informing him he was under arrest for assault 4 DV. It was then radioed to dispatch to request custody staff come to the scene to assist with the arrest.

Shortly after the request was made, the custody staff arrived, and after a large amount of resistance from Fred, we were ultimately able to get him placed into a wrap device and placed into the back of the patrol vehicle.

This ends my involvement with this case. Nothing follows.

I, Officer Wiggins #0195, am a commissioned police officer in the State of Washington, County of Snohomish and employed by the City of Marysville. On the above date and time, my assignment was as a patrol officer. I was wearing an authorized Marysville Police Department patrol uniform. I was driving in a Marysville Police Department patrol vehicle equipped with emergency lights, and siren. I am equipped with a body worn camera that was on and activated during this event. All video was uploaded to Evidence.com.

On Saturday December 17 at approximately 18:28 hours I responded to a report of a physical domestic violence situation at 5514 78th AVE NE. The Reporting Party, Ruiz, Kristy A DOB 2-24-1985, had called 911 reporting that her parents were fighting and that his step-father had been drinking.

I arrived on scene with Officer Herrera and the Reporting Party let us enter the home. I observed a male who I immediately recognized as being extremely intoxicated sitting at the counter in a kitchen yelling at a female—there was the smell of alcohol present in the home as well. I told the male, later identified as Lopez, Fred 2-26-1970, that at this time were detaining and not arresting him. I placed Fred's right hand in a handcuff and Fred became very agitated and started yelling profanity. Officer Herrera was attempting to place Fred's left arm behind his back, but he constantly pulled away from her. I managed to pull both of Fred's arms behind his back and he complained of having a wrist problem. We allowed Fred to be handcuffed in front of him due to his complaint and we did so with two pairs of handcuffs. We told Fred we would walk him outside and he continued pulling away from us and yelling profanity and other derogatory language.

Now with two additional officers on scene, we managed to get Fred outside of the home notwithstanding his constant resistance. Fred then asked to be sat down and we let him sit on the porch of his home. Fred was still visibly angry; he fell to the floor and was pulling away from us and yelling at us. Officer Herrera went back into the home and spoke with the parties involved and determined that we had Probable Cause to arrest Fred for Domestic Violence Assault in the Fourth Degree. Officer Herrera learned that Fred had assault both his wife, Lopez, Veronica A DOB 12-21-1962, and his brother-in-law Contreras, Randolph DOB 12-11-1963 who had been visiting them from Arizona. Officer Herrera learned that Fred had been yelling at Veronica, came into contact with her, and shoved her. Contreras attempted to separate Fred from her and Fred punched him—reference Officer Herrera's supplemental report for further details. Veronica and Contreras both completed written statements.

The Reporting Party, Ruiz, completed a written statement form as did her son Ruiz, Anthony DOB 3-25-2007.

Fred continued to resist us after we informed him that he was under arrest for assault. We put out over the radio to have our Custody Staff come on scene with the wrap. Custody Officers arrived on scene and, after a great deal of resistance from Fred, we were able to get him placed in the wrap device and then placed him into the back of a custody transport vehicle.

Custody staff transported Fred to the Providence Medical Center for a clear to book and I went there as well. I read Fred his Miranda Rights Verbatim off of a state issued card and he refused to acknowledge them. Fred was evaluated and cleared from the hospital.

After Fred was discharged, Custody staff transported him to the Snohomish County Jail and I followed them there.

Fred was booked into the jail on two counts of Assault 4 DV and for one count of resisting Resisting Arrest.

Nothing further.

Officer Assignment: I, Derek Carlile am a commissioned police officer in the State of Washington and employed by the City of Marysville. On this date and time I was assigned as 85S with the Marysville Police Department. During the incident I was wearing my clearly identified police uniform and vest with patches on. I was also driving a fully marked police vehicle.

This incident was captured on my body worn camera and the footage has been uploaded to evidence.com. My narrative is a summary of the events as I perceive them and does not contain a full account. Feel free to review my BWC footage for a more detailed understanding of the events.

Officer Action: On 12/17/2022 around 1828 hours I responded to an Assault 4 DV that was reported at 5514 78th Ave NE in Marysville, WA. The reporting party was identified as Kristy Ruiz. In the notes of the call it read, "parents are fighting, glass all over floor, step dad HBD, swearing."

Upon arrival I could hear yelling coming from inside the residence. I entered the home and observed Officer Herrera and Officer Wiggins attempting to place a male in handcuffs. Alcohol was all over the floor and the male was clearly intoxicated as the smell of liquor came off his breath as he yelled at officers on scene. The male was screaming very loudly and actively resisting the two officer's attempts to detain him. The male was quite large and was able to overpower the

two officers who were telling him to put his hands behind his back and attempting to detain him in handcuffs. The male continued to be actively resistant by using his entire body and arms to push the officers around from side to side making it difficult to place him in handcuffs. I told the officers to attempt to use two sets of cuffs as his back was quite wide and he was complaining about having had a broken wrist in the past. The attempts to put two cuffs on the male and detain his hands behind his back didn't work either. Eventually we were able to get the male's hands in front of him and cuffed with two pairs of handcuffs.

All attempts to calm the male down were unsuccessful as the male continued to actively resist us. He would not listen to our verbal directions at all. Due to the escalation of the male's behavior we attempted to escort him out the front door. As we did this the male started using his entire body weight as a means to stop our progress. He attempted to go to his knees a number of times. Each step we took toward the front door the male actively resisted even more and flailed his arms and hands around causing added danger for me and the other officers who were attempting to escort him out of the residence.

Once we did reach the front door the male started pushing harder and flailing arms and his hands more in an attempt to get away from us. In fear that the male would strike us or assault us in some way, we escorted the male down to the ground on the front porch. He used his hands to push up against us in an attempt to resist our control tactics. He tried getting up multiple times and no matter how many times we asked him to stop he just continued fighting against us. I sat on his butt to keep his hips pinned to the ground as he was very strong and wouldn't stop trying to get back up to his feet.

We ended up calling for the jail to come assist us with the Wrap device as the male continued to actively resist and fight against us no matter how much we tried to de-escalate him. When the jail staff arrived the male was escorted off the deck and up the driveway to the road to be placed in a custody transport vehicle to be transported to the jail. Once again the male fought us every inch of the way. At first he tried to drop to the ground using all his weight, as dead weight against the officers who were escorting him. Once we reached the custody vehicle, he

kicked his feet up against the exterior of the custody vehicle to stop us from getting him into the back seat of the vehicle to be transported to Jail. The male was told numerous times that he was under arrest for assault 4 DV.

Once we did get him in the back seat he laid across it and grabbed with his hands on the driver side door frame to make it impossible for me to shut the door without smashing his hands. We had to pull him back out of the patrol vehicle and place the Wrap on him. He fought us once again while applying the Wrap.

Once the Wrap was applied we placed the male into the back of a jail custody vehicle and transported him to Providence ER where he was eventually cleared for booking into Snohomish County Jail for two counts of Assault 4th Degree DV and Resisting Arrest.

The male who was arrested was eventually identified as Fred Lopez 02/26/1970. Other officers remained on scene and collected statements from victims and witnesses about the incident. Randy Contrares 12/11/1963, Fred's brother in law wrote in his statement, "He started to call my sister a bitch I kept asking him to stop calling her a bitch and cunt very beligerent he socked me in the bace (possibly face or back) as I was trying to get him off my sister."

It should be noted Randy and Veronica A. Lopez 12/21/1962 didn't want to press charges against Fred as this is the first time he has ever been like this. Veronica is Fred's wife and Randy is Veronica's brother.

When I returned to the PD I uploaded my body worn camera footage to evidence.com and had it added to the case.

This ends my involvement in the case.

ASSIGNMENT

I, Officer Herrera, am a fully commissioned Police Officer assigned to the Marysville Police Department in the capacity of a Patrol Officer. On the above date and time, I was wearing an authorized Marysville Police Department (MPD) uniform complete with patches, a badge, and riding in a fully marked Marysville Police Department patrol car equipped with emergency lights, siren and decals. A body worn camera has been issued to me and was worn during the duration of the contact.

INVESTIGATION

On the above date and time, I was dispatched to a DVP at 5514 78th Ave NE, Marysville, WA. The call came out from Ruiz, Kristy A (DOB 2/24/85) stating her parents were fighting and there is glass all over the floor from her step dad who had been drinking.

I arrived on scene with Officer Wiggins. I was let into the house by a family member. I could clearly hear a male yelling from the kitchen and announced Marysville Police. Once I entered the kitchen, I noticed alcohol all over the floor and could smell it. Officer Wiggins walked behind the male who was later identified as Lopez, Fred (DOB 2/26/70) and attempted to detain him with handcuffs while he was sitting down in the kitchen. I grabbed Fred's left arm to assist in detaining Fred and Fred resisted. Fred told me he had previously broken his left wrist and I was told to move his hands to the front and double cuff so we did not injure his wrist.

Fred was actively resistant and unstable as he could not stand up without swaying. Fred was taken outside and placed on the ground as he was not complying. A wrap from custody was requested and Fred was detained until the Custody Officers arrived. I went back into the residence to develop probable cause.

Kristy had received a call from her son asking to be picked up because he did not want to be home. Kristy came home and her step father, Fred was arguing with her mother Lopez, Veronica A (DOB 12/21/62). Veronica's brother Contreras, Randolph (DOB 12/11/63) is in town from Arizona. Randolph stated Fred was calling his sister profanities and he kept telling him to stop calling her those names. Fred then punched Randolph in the back as he was trying to get him off Veronica. I developed probable cause for Assault 4 on Randolph. Veronica told me Fred had been pushing her and I developed probable cause for Assault 4 DV.

I handed out statement forms that were returned to me. Veronica and Randolph did not want to press charges or be victims of the assault. Once Custody Officers arrived, Fred was placed in a wrap and transported to Providence Regional Health Center. Fred was later booked into Snohomish County Jail.

End of report.

AUTHORITY:

I, De Maramed, am a Custody Officer with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia and body worn camera.
- On the above date, I was working within the Marysville Jail located at 601 Delta Ave within the city limits of Marysville, Snohomish County, Washington.

On the above date and at approximately 1900 hours, I, OFC Maramed, along with CPL Burtis, responded to 5514 78th Ave NE to assist patrol in taking Fred Lopez into custody. Per the call log, Fred Lopez was HBD and very verbal. In the background could be heard Fred Lopez agitated and shouting. Patrol officers on scene had asked for assistance from the jail to WRAP Lopez.

Upon my arrival, my BWC was activated. Several neighbors were watching the scene, some had approached the scene, while traffic continued back and forth on the street, presenting a dynamic and changing environment. Several patrol officers had Lopez seated in front of the residence, restrained in the front with double handcuffs, and were attempting to explain the situation to him and keep him calm. Lopez was visibly intoxicated, and continued to shout and protest against his arrest. I assisted in moving Lopez to our vehicle, however during the escort he was passively resistant, trying to fall to the ground and get out of our control. Throughout, he was shouting obscenities and remained highly agitated.

We attempted first to secure him in our vehicle without having to use the WRAP. We got Lopez into the vehicle, however he resisted our efforts to close the doors. Due to his actions, which escalated the situation, he was removed and placed on the ground, while we worked to secure him in the WRAP. Throughout, he was actively resistant, trying to push us off him and fighting our attempts to transition his arms to be handcuffed behind him. He was also continuing to shout obscenities at us, indicating his breathing was unobstructed.

Once he was sufficiently restrained, he was rolled up to a seated position to allow the WRAP to be completely secured, and to ensure his breathing continued to be unobstructed. He was then

successfully placed into our vehicle, and with OFC Wiggins following, I transported him to Providence for a clear to book.

During the transport, Lopez began vomiting uncontrollably, and alternated between begging to be released and shouting obscenities and threatening me. At Providence, with the help of hospital security, he was taken to Room 110, where medical staff administered sedatives. He was partially removed from the WRAP and placed in hospital soft restraints, and finally passed out under the effects of the sedatives.

I cleared the hospital at approximately 2100, and returned to the jail. End of Report.

I, Michael Burtis, am a Custody Corporal with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 601 Delta Ave.
 within the city limits of Marysville, Snohomish County, Washington and wearing an issued body-worn camera.

ELEMENTS OF CRIME/INCIDENT:

On 12/17/22 at approximately 1851, Marysville Police Officers were on scene a physical domestic call involving an intoxicated subject who was fighting with family. Officers on scene requested jail staff assistance as the suspect, identified as Fred Lopez (DOB 2/26/70) was resisting arrest. Officer Maramed and I responded to the scene and once we arrived with the WRAP, I activated my body worn camera. We made contact with officers escorting Lopez out of the house. Due to an alleged wrist injury, officers had double cuffed Lopez in the front. Officer Maramed assisted patrol officers with escorting Lopez to the street. Once at the jail transport vehicle, officers attempted to secure Lopez in the car, but he continued to resist, using his hands, feet and legs to block us from getting him in the car.

After several attempts and multiple officers, we were still unable to completely secure him in the vehicle. Lopez was the removed from the vehicle and placed on the ground so that officers could deploy the WRAP restraint. Lopez continued to resist as 6 officers struggled to gain his compliance. I was able to deploy the leg portion of the WRAP and secure it as Lopez resisted.

Due to the design of the WRAP, Lopez's hands needed to be secured behind his back. Part of upper portion of the WRAP restraint is a ring that secures to handcuffs to keep the harness in place. Without it, the subject will have additional mobility, thus rendering the WRAP ineffective. If the hands are in front, the subject can then lean forward and begin to remove the wrap restraint, presenting a risk to their own safety as well as that of officers.

After several more minutes of Lopez struggling as officers attempted to apply the WRAP, we were able to get his hands behind his back. Lopez at that point used his hands to grab onto my hand, squeezing and pulling on my fingers as I maintained control of his right wrist. Once his other hand was brought back, we were able to successfully re-apply the 2 sets of handcuffs. As I applied the handcuff to the free hand, I double locked it and checked for tightness. The handcuffs were secured to the D-ring on the WRAP and Lopez was lifted to a seated position where the remainder of the straps were secured. Lopez was then lifted into the vehicle for transport.

During the extent of the incident, Lopez continued to physically struggle and resist our efforts to restrain, escort, place him in the vehicle and apply the wrap. He grabbed onto multiple officers throughout the process. He was also verbal, hurling insults and derogatory remarks at staff the entire time. Officers made multiple attempts to de-escalate and gain compliance, maintaining a calm demeanor and requesting the same from Lopez. The odors of alcohol and vomit were apparent as officers dealt with Lopez. Due to his apparent level of intoxication, Lopez was sent to the hospital for a clear to book. During the incident, it was discovered that Lopez was bleeding from the left elbow. No officers appeared to be injured.

Officers Maramed and Wiggins transported Lopez to Providence ER for a clear to book where Lopez continued to resist, yell and cause a disturbance. Officer Maramed advised me at 1934 that Lopez was transition out of the WRAP restraint and was secured to the hospital bed with soft restraints. They were assisted by hospital security staff. Medical staff gave Lopez a dose of Ativan which was unsuccessful. Later, he was given a dose of Haldol which was successful in calming Lopez down.

Once cleared at the hospital, Lopez will be booked at Snohomish County Jail for Assault 4DV and Resisting Arrest.
