INCIDENT/CRIME: Assault 3, Assault 4, Intimidating any administrator, teacher, classified employee or student by threat of force or violence (RCW 28A.635.100)

DATE OF OFFENSE/REPORT: Tuesday January 4, 2022 about 11:46 hours, overcast 38 degrees.

NARRATIVE:

I (<u>Officer A.D. Wiersma 0052</u>), am a fully commissioned Police officer assigned to the Marysville Police Department, School Resource Division located within Snohomish County, in the State of Washington. I was wearing a full police uniform with patches and driving a fully marked police car.

On Monday January 3, 2022 at about 11:08 hours, I was contacted by Marysville Getchell High School Assistant Principal Craig Brewster who stated that they had a fight at the school and requested me to respond. I arrived at the school and contacted Mr. Brewster and Dean of Students Jessica Miko. They advised that over the last few weeks that students RCW 7.69A.030(4) and a few other of their friends have been trying to get student RCW 7.69A.030(4) to join their little friend group. They stated that RC did not want anything to do with them so the group started threatening to beat him up over texts, snap chat, and other social media platforms.

Mr. Brewster and Mrs Miko advised that today they found out about this when had someone walk him to his class because he was concerned about getting jumped. They stated that after class was over was waiting for him outside the classroom and attacked rew and the fight started. They advised that class on that floor of the building and had no reason to be at the location other than to see rew out. They advised that they had already expelled and that rew was in the unoccupied assistant principal office. I asked them if they knew what rew wanted to do about the situation and if they were going to handle this just at the school level. They stated that they did not know what he wanted to do. I went to talk to

I told RC what I was told and he stated that was correct and that RC swung first. I asked him if he wanted to pursue charges and he stated that he did not. I explained to

him that he was allowed to defend himself and also explained to him when defending himself becomes assault. I told him that this does need to stop and to let someone know if it continues.

I advised Mr. Brewster and Mrs. Miko what I had been told and that RCW did not want to pursue charges and he wanted it handled at a school level. I then cleared the call Marysville Police Incident number 2022-0000276.

On Tuesday January 4, 2022 at about 11:46 hours, I received a phone call from Marysville Getchell High School front office reception secretary Brooklyn Stevenson. She stated that they needed my there now and that they was a big fight happening. She called 2 more times when I was en route and stated that this had to do with the fight yesterday and that she thought they were by the gym located in the E/F building. I requested School Resource Officer King to join me who had to clear another call to do so. I requested his assistance because Mrs. Stevenson's voice was excited she was talking fast and it appeared to me this was going to be a big situation and I did not know how many people I was going to have to deal with.

I arrived at the school and went to the Gym I did not see anyone fighting. I saw a male school employee walking in the area and school security Cindy Barry. She asked if I was there for the fight and was told that the parties involved were in the main office (Building D). I advised Officer King that I did not locate anything and that the players were in the office. He stated he would meet me at the office. I walked to the office and came into the building D from the upstairs west door and contacted Mr. Brewster as he was standing by the door that I came in. He stated that they just had female student assault 2 employees and possible some others and was trying to assault another student. As I was standing there Mrs. Stevenson called me again and stated in a hurried and excited voice, "We need you in the office NOW." I told her I was already in the office by Mr. Brewster's Office she stated, "You need to come around the corner now she's out of control" and hung up.

I rounded the corner and several staff were standing in the area of the entrance door and pointing and stating she assaulted them and a female student was walking away from them toward me and the stairs that go down to other classrooms and several exits from the building. At this time I knew I had probable cause for assault on staff members and I did not know if she was still trying to find another student or students to fight. I told the female to stop and she looked at me and continued to walk past me. I told her to stop and she was not free to leave and that I was investigating an assault and I reached out to grab onto the back of her jacket. She immediately turned and started punching me. I was later advised that the students name was 16 year old

made contact with my chest with her fists and hands several times. I was able to block her hands from hitting me in the face. I told her to knock it off and she continued to hit me. She did not back away from me but continued toward me hitting me. I grabbed her hands and wrists and she started kicking me. It was obvious to me that she was not trying to get away but trying to hurt me. She kicked me several times making contact with my legs. She tried several times to kick me in the groin but I was able to hold her back far enough to keep her from kicking me in the genitals. I told her she was under arrest for assault 3 and for other accounts of assault. I told her if she continued I would put her in handcuffs.

RCW continued to try and hit and kick me. I was able to maintain a grip of her wrists and moved her to the ground. Once on the ground she continued to kick up at me as she was on her back and I was holding her wrists. I got on the radio and requested Officer King to pick it up. She made contact with my legs several times. I then heard a bunch of yelling coming from the Principal's Office which is located between the main entrance and the reception desk.

I hear a male voice yelling, "Get the fuck off of her." I looked up and saw several people coming toward me. I saw a male later identified to me by staff as student RCW

He was yelling at me and coming toward me and appeared to me that he was swinging his arms trying to get around staff to get at me. I placed my left knee and shin on RCW lower stomach and hip area and held her right arm across her body with my left hand. I radioed "Code 2" and got prepared to kick and fight the male if I had too. It sounded to me like there was several people yelling and coming toward me that I may have to fight. All the while RCW continued to try and hit and kick me. I yelled at them to stay back. I yelled at them several times to back up. I saw the group people start to move away and turned my focus back onto RCW who at one point had tom my covid medical mask off of my face.

I rolled RCW onto her stomach as she continued to try and hit and kick me and I lost control of her left arm. I gave her directions several times to stop and that she was under arrest. All the while she continued to try to hit and kick me. I got her right arm behind her back and she held her left hand under her body as she was now on her stomach and I was holding her to the ground. I told her to put her hands behind her back and she yelled your hurting me and I am trying. I told her I was going to let her up a little bit so she could move her hand behind her. As I did she tried to roll over and tried to kick with her legs again. I got her hand behind her back and placed her into hand cuffs and she continued to kick her legs. I checked the handcuffs for fit and double locked them. I told her if she calmed down I would roll her over and have her sit on the chair. She continued to yell and try and kick me as I rolled her to her side.

Officer King had now arrived. He helped me roll her to her side and we lifted her up and put her in the chair as she now tried to kick Officer King and I. We made her sit down and she immediately tried to kick us and stood up. We told her to sit down and pushed

on the top of her shoulders lowering her to the chair. She tried to kick Officer King who got control of one of her legs and I held her other foot down to the ground with my foot. Officer Taylor and Sgt. Tolbert had also arrived.

RCW was directing her anger and focus on me so I asked Officer King if he was good and Sgt. Tolbert to watch her so I could walk away to see if she would calm down. I heard Sgt. Tolbert ask several times if she was hurt and if she wanted aid. She did not want aid and was not injured. I did so and Sgt. Tolbert called recW parents and I went to talk the staff and find out more about what happened.

I was briefly told that RCW had been assaulted in the bathroom by the gym by

RCW friend RCW 7.69A.030(4) (who is friends of RCW 7.69A.030(4) boyfriend RCW yellow who was suspended the previous day for assaulting RCW yellow while (RCW Y.69A.030) blocked the door and watched to make sure no one would come in. The fight was broken up and everyone was brought to the office.

RCW was is Mrs. Miko's office with the door closed completing a statement about the fight.

While RCW was completing his statement I was told RCW ran to the Mrs. Miko's Office Door and tried getting in to get at RCW I was told that they thought she was going to break the window she was hitting it so hard. I was told that secretary Maxine Vallerie tried to get her to stop and was punched and pushed to the floor. I was told that Para Educator Jeremy Corcoran – Clark tried to help and was punched by RCW in the face and head several times and he was cut on the face and was bleeding so went to the nurse's station to get looked at. I was told that is when just seconds before I got there. I was told that RCW was still in Mrs. Miko's office and RCW did not get at him.

I advised Sgt. Tolbert what I had learned and I called Denny Youth Center to see if they would take RCW on a booking for 2 counts of Assault 4 on school staff and 1 count of Assault 3 for attacking me. I explained that this was an ongoing assault from yesterday. I explained to him what happened. He checked RCW and advised me that she does not point out and could not be booked. He asked me if I wanted him to check to see if he could get a judges override and I said I wanted him to check. Joe who I had been talking to from Denny Youth Center called me back. He stated that the judge denied the override. He stated that since RCW was probably going to be expelled that the students would be separated and the judge was just wanted to make sure they were separated. I asked for some clarification. He stated that if RCW 7.69A.030(4) would have gotten to the other student, RCW then it might be different. I asked him if it mattered that the student assaulted 2 teachers and a police officer to try and get at the student. He stated that the judges concern was that they were separated and if she is expelled they would be.

I informed Sgt. Tolbert what I had been told and that I could not get permission to book this time. He asked me what the school was going to do with her. I checked with Mr. Brewster and he stated that she was getting emergency expelled. I let Sgt. Tolbert know this and stated that RCW could be released to her mother and the handcuffs could be removed if she was calmed down enough. I went to get statements and gather more information.

A short while later I was advised that guardian, Rozette Benavides was there. I spoke briefly with her before Officer King brought her in to speak to RCW 7.69A.030(4) who was now in the principal's office with Officer King and some others. She was also out of handcuffs. I explained to her what had happened and that I was completing a report for charging with a least assault 3 for assaulting me and probably 2 other counts of assault for assaulting the 2 staff members. I showed her the picture of Mr. Corcoran – Clark which showed the bruising and cut on his left cheek (I had received the picture via text from School Security Mrs. Barry.) Officer King then went in with her to talk to RCW 7.69A.030(4)

I spoke with school secretary Maxine Vallerie. Mrs Vallerie told me that she saw quickly enter the Dean of Students, Mrs. Miko's office. She stated that she went over to the office because was yelling a screaming at his was in the office writing a statement. She stated that she told was sitting down and she refused to leave. Mrs. Vallerie stated that she put her arm between said don't hit me. She stated that she told her that she did not hit her. She stated that she told her that she did not hit her. I saw that Mrs. Vallerie was wearing a wrist brace of some kind. I asked her if she was hurt and she paused. Then looked at me and stated no she was fine. She stated that she was shaken up a bit. Mrs. Vallerie completed a statement. I asked her if she wanted to pursue charges and she was hesitant at first. I then stated that I was filling charges for the assault on me and she stated the she would.

I went and spoke to Dean of Students Jessica Miko. She stated that there was in fight in the bathroom that was broken up by Jeremy Corcoran – Clark one of their coaches and a para educator. She stated that the involved parties, RC n and RCW 7.69A.030(4) were brought to the office. She stated that RCW was in her office completing a statement and she stepped. She stated that she thought the door was locked but it was not. She stated that RCW went into her office and started punching and hitting She stated that RCW did not hit her back because she was a girl. Mrs. Miko

stated that staff members Maxine Vallerie and Jeremy Corcoran – Clark intervened. She stated that they were both assaulted and Mr. Corcoran – Clark was cut in the face. Mrs. Miko stated that they got out of her office. She stated that when she was walking toward her office she heard yelling and a loud noise like a window or door was being hit.

Mrs. Miko stated that she tried to get to calm down who was now outside her office yelling and hitting the windows and door. Mrs. Miko stated that to calm down and she yelled get out of my face and went toward the exit. I asked Mrs. Miko to complete a statement about the incident yesterday and the one today which she did.

I spoke to Para Educator and Football Coach Jeremy Corcoran – Clark. I could see that he had about a 1-2 in cut on his left cheek that had been bleeding. I could see that his cheek was starting to change color and it looked swollen. Mr. Corcoran – Clark told me that he was helping out with lunch in the E/F building (the building the gym is in). He stated that he saw RCW 7.69A.030(4) and RCW 7.69A.030(4) beeline toward the bathroom. He stated as soon as they got to the bathroom he realized there was a commotion and something going on. He stated that when he got there RCW was in the doorway blocking it and keeping him from going in. Mr. Corcoran – Clark stated he saw 2 students on the floor fighting so he barged his way past RCW who he had to push because RCW was trying to keep him from entering.

Mr. Corcoran – Clark stated he was able to break up the fight and RCW was respectful to him. He stated that and RCW still wanted to fight. He stated that chest bumped him and threatened him. He stated that got up into his face a stated he was going to get his and chest bumped him. Mr. Corcoran – Clark stated that they were able to get RCW and RCW to the office. He stated that RCW has threatened him in the past and he was done with this. He stated that he wanted to have them charged and he wanted a protection order put in place.

Mr. Corcoran – Clark stated that he went to the main office to write his statement about the fight. He stated that when he was doing this a female student (RCW), went into Mrs. Miko's office and started assaulting the student RCW who was in there. He stated that Mrs. Vallerie stepped in and tried to get RCW to stop. He stated he saw hit and then push Mrs. Vallerie causing her to fall to the ground. He stated that he attempted to grab by the waist to move her out of the office. He stated that she grabbed something and hit him in the face with it cutting his cheek. He stated that she punched him several more times in the head before he was able to get her out of the office and close the door.

I asked Mr. Clark if he wanted to pursue charges of assault and he stated he did. He stated that he also wanted to pursue charges for RCW threatening to hurt him and kill

him. I asked him to complete a statement which he did. I was given 2 statements written by him. One was about the fight the bathroom and the other about the fight in the office.

I spoke to Security Officer Cindy Barry. She stated that there was a fight in the bathroom at the E/F building and those students were escorted to the office. She stated that she collected statements from 4 boys who witnessed the fight. She stated that she also took a picture of Mr. Corcoran – Clark injury. Mrs. Barry provided me with the photo via text message and she gave me the statements from students;

RCW 7.69A.030(4)

I went and spoke to RCW who was still in Mrs. Miko's Office he was working on completing a statement. I asked him what happened. He stated that he was in the bathroom showing his friends his hair clippers he got for Christmas. He stated that RCW 7.69A.030(4) walked into the bathroom. He stated that RCW got in his face and punched him in the head. He stated that RCW took the first swing. He stated that a fight ensued and when Mr. Clark was breaking up the fight RCW assaulted him.

I asked him what happened in the office. He stated that he was completing a statement when burst in and started hitting him and yelling at him. I asked if he was injured and he stated no. I asked him if was involved in the fight in the bathroom and hit him. He stated no he was by the door. I asked him if he wanted to pursue charges and he stated that he did not. He completed 2 statements one about the fight in the bathroom and then one about what happened in the office. These statements were later provided to me by Mrs. Miko.

In his statement about the office he wrote that come in yelling at him, "What's wrong with you" and started hitting him. He wrote that Mr. Clark tried getting her off of him and she pushed him and then Mrs. Vallerie came in because of the screaming. He wrote that they were both trying to calm her down but she was acting all crazy.

I spoke to reception secretary Brooklyn Stevenson. She stated that there was fight in the bathroom between RCW 7.69A.030(4) was also there. She stated that several staff responded to the bathroom. She stated that RCW 7.69A.030(4) were brought to Principal Zimmerman's office. She stated that when RCW was walking past she heard him say something about going after coach Clark for putting his hands on him.

Mrs. Stevenson stated that RCW and Mrs Vallerie were in Mrs. Miko's office when barged in. She stated that Mrs. Vallerie tried to get in between RCW 7.69A.030(4) pushed her to the ground. She stated that Mr. Clark went to

help and when he was trying to remove from the office she was punching, scratching, hitting and kicking him. She stated that he received a cut on his cheek and later went to the nurse's office to get it taken care of. Mrs. Stevenson stated that Coach Clark was able to get from out of Mrs. Miko's office. She stated that RCW 7.69A.030(4) was still kicking at the window and door and so she called me again. Mrs. Stevenson completed a statement.

I spoke to Para Educator Christina McCormick who was also in the main office reception area. She was completing a statement about the fight in the bathroom. She stated that she was in E/F building heading to the A building (which is located south of the E/F building) when she heard a commotion by the bathroom. She stated that she looked through the door and saw Coach Clark and RCW in a heated conversation. She stated that she saw RCW chest bump Clark several times and told him he was "going to get it." She stated that RCW left the E/F building and she ended up talking to some other students who witnessed the fight in the bathroom until admin arrived. Mrs. McCormick completed a statement.

I was asked by Mrs. Miko if I wanted the statements that RCW 7.69A.030(4) wrote for them and I stated I did. She then asked if I wanted the student statements from the fight yesterday and I stated that I did. She went and got copies of the statements for me. She gave me statements from RCW 7.69A.030(4) and from the following from the fight on January 3; RCW 7.69A.030(4) (student) and Shannon Grandbois (teacher.) Mrs. Miko also gave me a 3 hand written pages of what look like her notes about the incident on 1/3/2022. There was also a statement from RCW 7.69A.030(4)

I got ahold of Marysville School District Director of Security Gregg Dennis via telephone as he was doing some work from home. I let him know what had happened and asked him if he could check his video as there is a camera on the wall. He checked his cameras. He stated that he could currently see me. I walked to where most of my interaction with recw occurred and he stated that he could not see any of the area with the carpet. He stated that he could see her walk past me and me reach out to her then we go off camera. He stated that you later see someone come out of Mr. Zimmerman's principal office and go toward where I was last seen on camera. I asked him if I could get a copy of the footage he did have. He stated that he would work on it and get it to me but would not be in the office until at least Monday (2/10/2022.)

I cleared the school and returned to the Office to work on my report. While at the office at about 15:22 hours, I received a phone call from Mr. Dennis. He stated that he had received 3rd hand information from Mrs. Stevenson that RCW 7.69A.030(4) and RCW house looking for him wanting to fight him. He provided me with RCW 7.69A.030(4) I went to the area

and did not locate anyone. I did not see any lights on in the residence and was not sure if anyone was home. I later cleared the call.

On January 5, 2022 at about 09:09 hours, I received a phone call from Mrs. Stevenson. She stated that had changed his mind and now wanted to pursue charges and talk to me. She requested that I come to the school to talk to him. I went to the school and advised Mrs. Stevenson that I got her message yesterday and conducted an area check but did not locate anyone. I then went and met with RCW 7.69A.030(4) was in Native Liaisons Office with Amy Sheldon who was present during our conversation.


stated that he changed his mind. He stated that after school yesterday he got a ride home with his mom. He stated once at home his friend RCW 7.69A.030(4) asked if he wanted to go to "Share Tea" located on the reservation. He stated that they went and soon received phone calls from a few friends stating that RCW 7.69A.030(4) were looking for him to fight him. He stated he was told they were at his house. RCW stated that his mom then called him and told him that the boys were at the house looking for him. He stated that his mom told them he was not there to which they responded he told us he would be here. She stated that they eventually left.

stated that they have now posted on social media a video of his house with statements written under it. He showed me the video's and the statements. The statements written in the video were, "Yall boys too pussy when we pulled up you wasnt on shit" and "Come get up wimme Ima step on all 3 yall We just pulled up to your crib an you're a no show yall lil boys pussy." He stated that RCW snap user name is RCW 7.69A.030(4) He stated that the postings were under user name. He also showed me a screen shot of his ring camera of RCW on the front step. RCW 7.69A.030(4) was expelled December 13, 2021 for aggressive behavior where he tried to get at another student and had to be held back by staff.) RCW stated that he was done with this and they are now coming to his house. He stated that he was scared for his safety and feels he needed to pursue charges.

I wrote 7.69A.030(4) statement for him and then read it to him. I asked him to let me know if I got anything wrong or missed anything. I then read and explained the perjury statement to him and he signed the form. He also e-mailed me some of the videos and the screen shot of Isaiah outside his house. I told him that he needs to keep staff informed if this does not end and I was going to forward charges on the crimes I could for various people. I asked him why this has all started. He stated that he was friends with them all and also friends with another group of kids. He stated that RC and them told him he had to choose between them or the other group and not both. He stated he chose his current group and this has been going on ever since. He state that this was so stupid.

I asked him if he was injured and he stated that he had a scratch under his eye and his right hand was swollen. I saw the small scratch under his left eye and saw that the back of his right hand was swollen. I took photos of his eye and hands.

On January 5, 2021 I continued to go through the statements that I had received.



fought then Clark came in to break the fight up and expected got in Clarks face and tried fighting him"

Witness student RCW 7.69A.030(4) wrote: "Today 01/04/22 I was in the boy's bathroom on the EF building with some friends looking at haircut equipment and som kid with Braids started pushing and yelling at RCW 7.69A.030(4) and the Kid with Braids dropped their bags and started throwing punches. Clark then tried to break up the fight and RCW Started pushing and getting in Clarks face."

In reference to the fight that occurred between RCW 7.69A.030(4) on January 3, 2022

Teacher Shannon Grandois wrote:

RCW 7.69A.030(4) was asked Repeatedly to stop and wouldn't. Mr. Haven physically restrained RCW and Mr. Edenholm blocked RCW 7.69A.030(4) pushed him aside and attacked him again.

RCW as corralled into Edenholms office where he proceeded to punch the glass of Edenholms door and yelled profanity.

ace yelling so RC yells back then RCW 7.69A.030(4) RC yells back then RCW hits back to protect himself they start fighting and teachers come in and try to break up the fight but RC wont stop, also I pulled my phone out when RC was in his face in the beginning I had a feeling it was gonna happen because a couple of days ago RC posted on his story he will fight RC but I didnt know when it was going to happen, everything just happened so fast. I think this all happened because RCW 7.69A.030(4) drifted from the friendgroup because he found other friends and I think RCW probably felt hurt or betrayed RCW left so RCW started beef with him."

rote: "I walked outside of 1st period from Ms. Lima'shistory class on top floor of C building and Rew vas waiting outside of my classroom to fight me. he got in my face saying 'I'll keep that same energy' then he put his hands on me and threw first punch."

The pages of notes that I received basically describe the same thing.

When I came into work on 1/6/2022 I had received an email from Marysville Getchell High School Principal Richard Zimmerman dated 1/5/2022 07:48. He was forwarding an email that he had received from RCW Which read;

"Here is the statement from the student who was detained.

Richard Zimmerman Principal Marysville Getchell High School Make it a Great Day the Charger Way!

This has been going on for two months and it started off with RCW alking about another student trying to get them to fight and causing a whole problem that doesn't need to escalate RCW told L RCW from Pilchuck telling RCW 7.69A.030(4) that he is going to fight him and letting me know what is going on and RCW 7.69A.030(4) cousin RCW 7.69A.030(4) that they are going to end up "running my ones" with RCW 7.69A.030(4) as soon as RC came back to school from the suspension finding out RC is the one talking all this nonsense to other guys saying they want to fight him when RC is the one who wanted fight RCW 7.69A.030(4) and RCW 7.69A.030(4) so it has been happening for a quite a while"

I am sending this case to Snohomish County Juvenile Prosecutor's Office for the following charges:

RCW 7.69A.030(4)

DOB 4/15/2005:

-Assault 4 for assaulting RCW 7.69A.030(4) on January 3, 2022 outside the class room.

-Stalking for several threats toward RCW 7.69A.030(4) posted on social media and going to his residence to find him to get him to fight on January 4, 2022.

RCW 7.69A.030(4) DOB 10/19/2005:

- -Assault 4 for punching and hitting RCW 7.69A.030(4) while he was completing a statement in the office on January 4, 2022
- -Assault 4 for punching and pushing School Secretary Maxine Vallerie on January 4, 2022
- -Assault 3 for hitting school Para Educator and Coach Jeremy Corcoran Clark with an object and cutting his cheek and for repeatedly punching, hitting and kicking him on January 4, 2022 in the office.
- -Assault 3 for punching, hitting, and kicking myself School Resource Officer A.D. Wiersma on January 4, 2022.

-Resisting Arrest on January 4, 2022

RCW 7.69A.030(4) DOB 01/04/2007:

- -Assault 4 for punching and hitting RCW 7.69A.030(4) on January 4, 2022 in the bathroom.
- -Obstructing a Law Enforcement Officer for trying to get at me and yelling at me School Resource Officer A. D. Wiersma to let her go and focus my attention on him in an attempt to help keep RCW from being arrested.

RCW 7.69A.030(4) DOB 5/6/2005:

- -Assault 4 for being complicit by being the lookout and keeping people from entering the restroom so his friend RCW 7.69A.030(4) could assault RCW 7.69A.030(4) on January 4, 2022.
- -Intimidating a classified school employee by threat of force or violence by blocking the door way, chest bumping, threatening, and trying to get Para Educator and Coach Jeremy Corcoran Clark to fight on January 4, 2022 by the bathroom. (Mr. Corcoran Clark is also requesting a protection order to be put in place.)

RCW 7.69A.030(4) **DOB 01/30/2005:**

- -Stalking for several threats toward RCW 7.69A.030(4) posted on social media and going to his residence to find him to get him to fight on January 4, 2022.
- On Thursday January 6, 2022 at about 10:20 hours, I called the phone number for father, Shaun Bagley and Legal Guardian social worker Michelle Tiffany answered. She advised she was his legal guardian and his social worker but dad's phone number was 425 508-2907 and her email was mtiffany@tulaliptribes-nsn.gov. I advised her that I was forwarding charges for for stalking and recommend that he has no contact with and not contact him.
- I then called 7.69A.03 father Joseph Raymond at 425 238-8745 a female answered and I asked if it was Brandy (who is listed as a guardian) and she stated no you have wrong number. I asked for Joseph and RC and got the some reply she was going to hang up on me and I stated that I was Officer Wiersma with Marysville Police. She stated that she does not know who those people are and gets phone calls and messages for them all the time. She stated that she has tried calling the school district to get them to remove the number but it has not worked. She stated that this has been going on for 2 years and so screens her calls but was expecting a call so happened to answer. I told her I would talk to the director of security to see if we could get the number removed. I was not able to get ahold of Joseph Raymond or any guardian.

I called director of security Gregg Dennis and let him know about the wrong number.

I then called mother, Jennifer Reynolds at 425 321-4121. We talked about the charges and the situation. She stated that he was doing well and getting his grades up but he has been struggling since sports ended. I offered that we can be a support when we can but the behavior has to stop and maybe this will be a wake-up call. I told her that he should not have any contact with RCW or post anything about him. I advised her she could request a copy of the report from the Marysville Police Department public records request.

I then called Jennifer Witter, RCW 7.69A.030(4) mother at 206 379-5939. We talked about the situation and the charges and why RCW was being charged even though he did not actively assault the other student. Jennifer did not understand everything and I suggested that she request the case report from Marysville Police Records. I tried to explain the totality of the situation I told her that bottom line is the behavior has to stop and that we will be a support where we can to help RCW succeed.

This report will be sent to the Snohomish County Juvenile Prosecutor for Charging.
