AUTHORITY:

I, Nicholas Buell, am a Custody Officer with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 1635 Grove Street within the city limits of Marysville, Snohomish County, Washington.

ELEMENTS OF CRIME/INCIDENT:

At approximately 0220 hours, Officer Taylor brought in Caleb Taylor for a new Disorderly charge. As Caleb made his way to the booking door, I activated my body-worn camera. During intake, Caleb's behavior was constantly switching between compliant and non-compliant. I would ask him for his sweatshirt/socks/belt, and instead of handing them to me, he would stuff them under the bench he was sitting on. His reason for doing this was because he didn't understand what I wanted from him because "He does not speak Chinese" despite the fact I was speaking English same as him.

After getting Caleb into his uniform and getting through the medical questions, he argued with us about how he was supposed to speak to a bail bondsman. We gave him as much info as we could and attempted to let him use the phone. After he could not compose himself on the phone, we escorted him to the isolation cell, where he proceeded to donkey kick the door repeatedly. After securing him inside the cell, I deactivated my body-worn camera.

After approximately one hour, Caleb asked when he was going to use the phone again. I told him that he ruined his opportunity and his response was "I am going to kill myself by biting myself and I won't even feel it because I am drunk." After this response, I looked at the isolation cell camera and Caleb did indeed appear to be biting at his wrists. Corporal Stewart decided it was now time to place Caleb into the WRAP device to restrain him from further self-harm. I have voluntarily been placed into the WRAP in previous training and know from experience that the device is not painful, but is good at restricting excessive body movement.

This is especially useful for subjects who are physically resisting or attempting self-harm. Officer David Taylor also responded to the jail to assist us in applying the WRAP. Upon Officer Taylor's arrival, I activated my body-worn camera. Before opening the cell door, Caleb said "it's gone" (referring to having eaten his entire hand). Caleb had his mattress and blanket blocking the cell door and window but we could see he was standing in front of the door by watching the cell camera.

After opening the door, Corporal Stewart was able to bring Caleb down to the floor and onto his stomach. I knelt onto the back of Caleb's thighs to control his legs while Officer White applied the hobble to his ankles. Officer Taylor held his arms which enabled me to place him into handcuffs. Despite Caleb's previous claim, his hand was entirely intact. After double checking the tightness of the handcuffs and double-locking them, we placed Caleb onto the lower portion of the WRAP device that Officer Gibbs had retrieved and placed down for use.

Caleb was constantly making moaning noises as we applied the WRAP, but did not appear to be resisting. After fully applying the WRAP, we placed Caleb back into the isolation cell and set him in the corner so he could lean against the wall and then closed him inside. I deactivated my body-worn camera after he was secure in the cell. We then started a 15 minute check log for Caleb for as long as he was restrained. He quickly squirmed his way over to the door and began hitting his head against it repeatedly. We then placed him in the furthest corner from the door but he again made his way back over to bang his head. After this attempt, Officers White and Gibbs placed a cushioned helmet on Caleb to protect his head.

At approximately 0400, Corporal Stewart was able to arrange for the Snohomish County Jail to receive Caleb as we did not have the necessary resources to house him for an extended period of time. Before approaching his cell door to remove him, I activated my body-worn camera. As we opened his cell door, he was propped against it still hitting his head so he tipped over through the doorway. After sitting him back up, Corporal Stewart and I both grabbed an arm while Officer White grabbed his feet, and we carried him down to the sally port where we placed him into the back of our transport vehicle and buckled him in. After closing the vehicle door I deactivated my body-worn camera. Officer White and Officer Gibbs then transported Caleb and his belongings to the Snohomish County Jail.

AUTHORITY:

I, Rebekah Gibbs , am a Custody Officer with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 1635 Grove Street within the city limits of Marysville, Snohomish County, Washington.

ELEMENTS OF CRIME/INCIDENT:

On the listed date at approximately 02:20 TAYLOR, CALEB was brought into the Marysville Jail by Officer Taylor MP0182 to be booked on a charge of Disorderly Conduct. Officer Buell pat searched Caleb and removed his hand cuffs. Caleb was then instructed to sit on the booking area bench. Officer Buell asked Caleb what size shoes he wears and Caleb refused to answer, only saying that he would not repeat himself. Officer Buell requested Caleb's shoes and socks and gave him a jail uniform and jail shoes to change into. Caleb was directed into the bathroom so he could change privately. When Caleb came back out he was asked by Corporal Stewart to sit on the booking area bench to answer some questions. Caleb replied with a question, asking what his bail was. Corporal Stewart advised that we did not yet know, we needed to ask him the booking questions to start getting him booked in. Caleb became argumentative again, saying that he would not answer our questions until we told him what his bail was. Caleb also said that he could not understand us because he does not speak Chinese. At no point in time was anyone in the booking area speaking Chinese. Corporal Stewart convinced Caleb to answer our questions to get him through the booking process so that we could get him on the phone to call a bail bondsman. I was able to ask all of the COVID and medical questions required without issue. Corporal Stewart then finger printed Caleb. Caleb sat back down on the booking area bench once the fingerprints were finished and demanded that we give him the number to a bail bondsman to call. Corporal Stewart advised Caleb that we have a list of companies he can call right next to the phone and we are unable to recommend any one company. Caleb became agitated at this, yelling at us nonsensically. Officer Buell advised Caleb that he can either use the phone or go into his cell. Caleb asked for 30 seconds to think about it, which he agreed to. Caleb then got on the booking area phone

and made one phone call. Caleb was unable to get through on the phone and requested to use his cell phone to text a bail bondsman. Caleb was told under no circumstance was that an option. Due to Caleb's agitated behavior he was then directed into the padded safety cell. Caleb proceeded to kick the door repeatedly and loudly.

At approximately 3:20 Caleb put his blanket over the safety cell window and yelled out that he "is going to kill himself". He stated he was going to bite himself, and that he was so drunk he would not even feel it and proceeded to bite his wrist. Corporal Stewart decided for Caleb's safety he needed to go into The Wrap or the restraint chair. We decided to put Caleb in The Wrap. Corporal Stewart noticed that Officer Taylor was still in the building and requested him to come back up to the jail to assist us in wrapping Caleb. Once Officer Taylor arrived, Corporal Stewart asked Caleb to remove his blanket from the window. Caleb wrapped the blanket around himself and Corporal Stewart directed him to place his hands behind his back and turn to face the wall. Caleb did not comply. The decision was made to open the cell door and go in to restrain Caleb, Corporal Stewart went into the cell and was able to pull Caleb forward and assist him to the ground. Officer White grabbed ahold of Caleb's feet and Officer Buell and Officer Taylor took ahold of Caleb's arms. Officer Buell placed Caleb into handcuffs, gauged for fit, and double locked. Officer White then placed the ankle restraint onto Caleb. During this entire process Caleb was moaning and making inappropriate sexual comments to the officers restraining him. Caleb was lifted by Officer's White, Buell, and Taylor and placed onto the knee/leg restraint portion of The Wrap. Then the harness portion of the wrap was applied to Caleb. Caleb was carried back into the padded safety cell and placed into the right corner so that he could be propped up into a sitting position. A 15 minute check log was started and we were monitoring Caleb on the safety cell camera.

At approximately 3:30 Caleb began to hit his head against the safety cell door. Officer White moved Caleb back into the far corner of the safety cell to get him to stop hitting his head on the door. Within approximately 30 seconds of being moved, Caleb had shrimped his body back over to the front of the safety cell and resumed banging his head on the door. Corporal Stewart made the decision to move Caleb to a facility that would be better equipped to handle Caleb's behavioral issues. While Corporal Stewart called SCORE jail and Snohomish County Jail to see who would accept Caleb, Officer White grabbed the department defensive tactics foam protective helmet and placed it on Caleb's head. Corporal Stewart, Officer White, and Officer Buell then carried Caleb in The Wrap down to the sally port and placed him into the back of the Explorer. I went to the opposite side of the car and pulled the ankle restraint on his feet to pull Caleb all the way through so that he was seated appropriately in the car. Corporal Stewart secured Caleb with the chest portion of the seatbelt and Officer White and myself transported Caleb to the Snohomish County Jail.

ASSIGNMENT:

- During this incident, I was wearing an approved Custody Corporal uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 1635 Grove Street within the city limits of Marysville, Snohomish County, Washington.

ELEMENTS OF CRIME/INCIDENT:

At approximately 0220 hours, Officer Taylor brought in Caleb Taylor for a new Disorderly Conduct charge. During the initial intake Taylor began to exhibit uncooperative behavior. When Officer Buell would give him instructions to do something, he would say he did not understand and when Taylor would reply back he would look away from Buell as he spoke. He made a comment about not understanding because he does not speak Chinese, which did not make sense because we were speaking English to him. When Buell would ask him for his property Taylor would not hand it to Buell, but purposely drop it on the ground or shove it behind the booking bench.

After Taylor was changed into his uniform and was able to get through the jail medical questions he demanded to use the phone. I reminded him the phone is a privilege not a right. I told him he could use the phone after we got his fingerprints done. Before using the phone, he asked who he needed to call to bail out. I informed him we are not able to give him any recommendations for bail companies. He did not like my answer and began to argue why we were not able. I told him to stop arguing with us if he wanted to use the phone. Taylor was able to get on the phone and attempt to call someone. After he could not compose himself on the phone, we escorted him to the isolation cell. Immediately after being placed in the cell he began to donkey kick the cell door.

After approximately one hour, Taylor asked Buell when he could use the phone again. Buell told Taylor he would not be using the phone any more tonight because he already ruined

his opportunity. Taylor responded by saying, "I am going to kill myself by biting myself and I won't even feel it because I am drunk." Because of the self-harm statement I made the decision to utilize our WRAP restraint system and have Taylor placed in it to restrain him from any further self-harm. I have voluntarily been placed into the WRAP in previous training and know from experience that the device is not painful, but is good at restricting excessive body movement. This is especially useful for subjects who are physically resisting or attempting self-harm. I called for Patrol Officer Taylor to come up to the jail to assist us with putting Taylor into the wrap. We could see Taylor put his mattress in front of the door and he was holding his blanket over the window to obscure our vision into the cell.

At this time I turned my BWC on to record the event. Before I opened the door I gave verbal commands for Taylor to turn around and put his hands behind his back. Taylor replied by saying, "you will need to come in here with force." As I was opening the door, I could see that Taylor had his head covered by his blanket. I took that opportunity to grab him and pull him forward and escort him to the ground. As he was laying in the prone position, Officer Taylor and Buell secured him in handcuffs and Officer White secured his ankles with the WRAP hobble. After double checking the tightness of the handcuffs and double-locking them, we placed Taylor onto the lower portion of the WRAP device that Officer Gibbs had retrieved and placed down for use.

After fully applying the WRAP, we placed Caleb back into the isolation cell and set him in the corner so he could lean against the wall. We then started a 15 minute check log for Taylor for as long as he was restrained. He quickly squirmed his way over to the door and began hitting his head against it repeatedly. We then placed him in the furthest corner from the door but he again made his way back over to bang his head. After this attempt, we placed a cushioned helmet on Taylor to protect his head.

I called Snohomish County jail to see if they could accommodate Taylor at they're facility. The booking Sergeant said they would take him. As we opened the cell door, he was still propped up against it hitting his head so he tipped over through the doorway. Officer Buell and I sat him back up. Officer Buell and I grabbed under Taylors shoulders while Officer White grabbed the ankle hobble and we carried him down to the sally port where we placed him into the back of our transport vehicle. I secured Taylor with the shoulder belt as good as I could. Officer White and Officer Gibbs then transported Taylor and his belongings to the Snohomish County Jail.

AUTHORITY:

I, Daniel White, am a Custody Officer with a limited commission by the City of Marysville, WA.

ASSIGNMENT:

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 1635 Grove Street within the city limits of Marysville, Snohomish County, Washington.

ELEMENTS OF CRIME/INCIDENT:

On the above date at approximately 0220 hours a male subject identified as TAYLOR, Caleb was brought into the jail to be booked on a disorderly conduct. Upon entering the facility TAYLOR was immediately verbally resistant and not complying with the directives that officer Buell was giving him as part of the initial intake process. Any time an officer would ask him a question or give him a directive he would state "I can't understand what you're asking because I don't speak Chinese." When in fact, none of the officers involved were speaking Chinese. After the intake medical questions were asked of TAYLOR he was instructed to change out into a jail issued uniform by Officer Buell, after he changed into the uniform Cpl. Stewart was able to get his fingerprints. Once his fingerprints were done he requested to use the phone in an attempt to post bail. TAYLOR began to escalate his behavior when officers told him that we could not recommend any bond companies.

The decision was made based on TAYLOR's escalating behavior to remove him from the phone area and place him in the isolation cell, TAYLOR complied with our directives initially but quickly deteriorated his behavior and within minutes of the door being closed he began donkey kicking the door and attempting to obstruct both the camera and the window on the door so that we would not be able to observe his actions while in the cell. Shortly after he stated "I'm going to kill myself! By biting myself!" TAYLOR then proceeded to place his wrist area into his mouth, as his back was to the camera I am unable to confirm if he was actually biting himself at this time. The decision was made by Cpl. Stewart to place him in the WRAP restraint. Cpl. Stewart called over the radio asking Ofc. Taylor to return to the jail to assist if needed.

Once Officer Taylor arrived in the jail we all activated our body worn cameras, Cpl. Stewart, Officer Buell, Officer Taylor, and myself all approached the door to the isolation cell.

TAYLOR was still attempting to obstruct our view of him by propping the mattress against the door and covering the window with his blanket. Cpl. Stewart directed him to step back from the door and place his hands behind his back. He stated something to the effect of "you'll have to come with force." Cpl. Stewart opened the door and escorted TAYLOR to the ground, once TAYLOR was on the ground I took control of his feet Cpl. Stewart and Officer Buell were getting Taylor into hand cuffs while secured his feet with the hobble portion of the WRAP, once he was handcuffed and hobbled the three of us carried TAYLOR facedown out of the isolation cell where officer Gibbs had laid out the leg portion of the WRAP. We finished securing TAYLOR into the WRAP and then carried him back into the isolation cell and placed him in the corner. Shortly after we exited the isolation cell TAYLOR wiggled over to the door and began banging his head on the door. I entered the cell again and moved him to the back corner of the cell away from the door. As I was exiting the cell TAYLOR stated "lets race!" and flopped onto his side and began to wiggle back toward the door.

The decision was made to move TAYLOR to another facility, Cpl. Stewart called Snohomish county jail and made them aware of the situation, they said that they would take TAYLOR. Officer Gibbs and I prepared to transport TAYLOR.

Cpl. Stewart, Officer Buell, and myself carried TAYLOR down to the sally port and placed him in the back of the transport vehicle. Cpl. Stewart secured him as best he could with the seatbelt. Shortly after the transport was underway TAYLOR had managed to wiggle the seatbelt loose enough that he began hitting his head on the partition.

Once we arrived at county, county deputies met us in the sally port with the restraint chair in order to wheel him into the facility. I assisted county deputies with getting him out of the explorer and then handed custody of TAYLOR off to them.
