She was currently wearing a cast with a broken wrist, so officers were unable to apply handcuffs. Officer Gibbs and I loaded the restraint chair into the jail van and we responded to the scene, arriving at approximately 2045 hours. I activated my BWC as we unloaded the chair from the van and wheeled it into the back yard where Kaylee (the female subject) was located.

As we approached I observed two officers keeping Kaylee restrained to a chair with her right hand handcuffed to the chair, as her left arm was in the cast. I (Officer Roberts) work for the city of Marysville in the county of Snohomish. I am assigned to the Marysville Police Department Patrol Division. On the above date and time I was assigned as a beat car. I was wearing the standard Marysville Police Department patrol uniform and driving a fully marked Marysville Police Department patrol car equipped with emergency lights, siren and decals. I was wearing my department issued body worn camera from Axon. All video footage has been uploaded to evidence.com.

**Officers Action:**

I was dispatched to a verbal domestic at the above location. The RP and one of the victims, Elaine Jensen, called to report her daughter, Kaylee McCann, was detoxing and trying to light the residence on fire. Elaine further told the call taker that nothing was currently burning and that Kaylee had scratched her hand. Kaylee was described as a white female wearing a blue tank top and grey capris. Kaylee was last reported to be in the backyard.

Officer K. Stuver and I arrived on scene. We observed one female standing in the backyard and another one sitting. We entered the backyard. The female standing was Elaine. The one sitting was Kaylee. Kaylee was wearing a neck brace and a cast on her left arm. It was later discovered that Kaylee was a passenger in a collision on 7-19-2022. She sustained injuries from the collision. A metal rod was placed in her right leg, her left radius was broken and she had spinal issues. Upon contacting Kaylee, she stated she would attack Police and make them shoot her. Kaylee was sitting in a chair had was in a weakened state due to her injuries. Therefore, two units stayed with her and made sure she did not stand up. These Officers were K. Stuver and N. Brevig. Refer to their supplemental reports for further information.



While the two units restrained Kaylee, I spoke with Elaine. Elaine told me that Kaylee has a substance abuse problem. She handed me a small plastic bag of blue and round pills inscribed with "30 M". I recognized these as counterfeit Percocet 30 pills manufactured with fentanyl. Elaine told me about the collision Kaylee was involved in on Tuesday. She described the injuries to her. She further explained that since the collision and surgery, Kaylee was taken to Ideal Options in Mount Vernon for drug treatment. The physician that saw Kaylee prescribed some pills and made a plan to have her phase off of fentanyl and onto suboxone. The plan was for Kaylee to stay with Elaine and Chad in the meantime. Today, Elaine and Kaylee had an argument where Kaylee threatened to leave the home. Elaine told her that would not be a good idea given her current medical state. Kaylee became enraged and threatened to burn the house down. She also threw multiple bottles of water in the downstairs of the home. She further dumped a bottle of perfume on the ground. Kaylee threatened to burn down the home and activated a blue lighter. She held it underneath the siding of the house. Elaine stated some of the siding caught on fire. It was a small flame. I asked Elaine if the black burn marks on the siding I could see was where this occurred. She told me yes. Elaine put out the fire and then tried to take the lighter out of Kaylee's hand. During this altercation Elaine received a scratch from Kaylee. Elaine also stated the scratch could have been from an altercation at the sliding glass door with Kaylee. She was unable to narrow down when the scratch happened.

I spoke with Chad and he stated he was at work and came home to the incident occurring. He stated Kaylee was throwing things around the downstairs. He did not get directly involved except for yelling. During my interviews with Elaine and Chad, the Officers restraining Kaylee had to consistently apply a low level of force to keep her restrained. She continuously tried to stand up and move. I could hear bits and pieces of the conversation between her and the Officers. She was ordered multiple times to stop moving and to stop trying to get up. She continued to tell them no and made comments about fighting them. I also heard the Officers tell her they did not want her to be hurt any further given her current state. I developed probable cause to arrest Kaylee for assault 4 DV and malicious mischief 3 DV, and harassment DV.

It was determined we would likely need the jail van and assistance to arrest Kaylee and transport her safely. Custody units were called to the scene to assist. I asked Chad and Elaine to go back into their home to prevent Kaylee from trying to start a verbal altercation. Chad and Elaine went back inside of the residence. I was then made aware by Ofc. Stuver that Kaylee had scratched him. This added one charge

of assault 3 to the charges I already had probable cause. I observed Ofc. Stuver had Kaylee's right arm behind her back at one point in a wrist lock to prevent her behavior. I told Kaylee she was under arrest and told her to listen to the two Officers restraining her. She declined. I grabbed statement forms and a DV pamphlet out of patrol car for Elaine and Chad. I explained the statements and pamphlet to them. They gave me medications prescribed to Kaylee to take to jail with her.

I went back to Kaylee and Ofc. Stuver told me she elbowed him in the groin. This added another assault 3 charge for Kaylee. Kaylee then tilted her head back and stopped responding to Officers. Aid was called to the scene to evaluate her at this point. The jail van arrived on scene and brought a chair to restrain Kaylee in. Kaylee told Ofc. Stuver and I that she wanted to die. She removed her neck brace and attempted to hit her head against the chair and the side of the house. Ofc. Stuver did his best to hold her head in place and prevent this. Shortly after, Kaylee reached for my firearm and placed her hand on top of the retention device for my holster. I quickly moved her arm away and told her to stop. The custody units came to the backyard with the chair and we physical picked Kaylee up and placed her into the chair. We secured her into the chair and the aid crew came and talked to her. They placed her neck brace back onto her.

Kaylee was lifted into the back of the jail van. I read Kaylee her Constitutional Rights from my state issued card verbatim. Kaylee did not respond when I asked if she understood. She opened her eyes and mumbled something. I took this as an invocation of her rights. She was transported to the Snohomish County Jail by custody units and Ofc. Stuver inside of the jail van. The county jail was unable to take Kaylee due to her suicidal statements. She was transported to Providence Hospital for a clear to book. At some point, it was determined that Kaylee would be unfit for booking due to the requirements by the county jail. These requirements were that she be free to move and use the restroom without assistance. That was likely not possible due to her injuries from the collision on 07-19-2022. Because of her suicidal statements, Kaylee was involuntarily committed to Providence Hospital. A copy of the involuntary commitment paperwork was faxed to Providence.

I am forwarding charges to the Snohomish County Prosecutor on Kaylee for assault 3 (two counts), assault 4 DV, harassment DV, malicious mischief 3 DV, and resisting arrest.

On July 23<sup>rd</sup> 2022 at about 1957 hours I was dispatched to a physical domestic assault at 12712 44<sup>th</sup> AVE NE in Marysville WA. Dispatch advised that the reporting party's daughter was detoxing and currently has a lighter, attempting to light the house on fire.

I arrived on scene and observed multiple subjects in the backyard, I proceed into the backyard where a female who was sitting down wearing a neck brace (later identified as Kaylee McCann 10/1/2002) shouted at myself and Officer Roberts something to the effect of we needed to be ready to shoot her because she was going to fight us.

I proceeded behind the chair Kaylee was seated in as she continued making threats to fight myself and other officers and insisting that we were going to fight her. I attempted to ask Kaylee what was going on but she berated and threatened me without cease. Ofc. Roberts informed me that we had established probable cause for Assault 4 DV as well as Malicious Mischief. At that point I advised that we likely wanted to summon the jail van with the chair as Kaylee was continuing to make threats about fighting police and it was unlikely she could be handcuffed due to a large cast on her left arm.

At one point Kaylee attempted to get up and I instructed her not to. Kaylee still tried to stand up, at which point I grabbed along of her right arm and placed it behind her back. Kaylee writhed in the chair trying to turn and face me while still threatening myself. Kaylee used her finger nails to claw into the skin on my right hand that was attempting to hold her in place. Kaylee drew blood from the front of the thumb on my right hand from where her finger nail dug into my skin. Additional marks and scraping were visible on my right palm.

Kaylee stated she was not going to try and get up and requested I let go of her and she complained that my wrist hold was hurting her neck. I let go of Kaylee and moments later she again tried to get out of the chair. Kaylee had been informed by multiple officers that she was

under arrest and that she needed to remain seated. I had to again place Kaylee in a wrist twist control hold behind her back.

Once more, Kaylee calmed down and was let go of. Kaylee then became irate that nobody would light her cigarette and which point she swung her left elbow around the back of the chair and elbowed me in my groin, where her elbow made contact with my genitals causing minor pain and discomfort. Kaylee was now informed she was under arrest for Assault 3 for striking me. Kaylee became immediately apologetic stating she did not intend to strike me, I informed Kaylee that the entire incident was on body camera and was not up for dispute.

Kaylee then decided to strip off her neck brace and throw it across the lawn. Kaylee declared that she wanted to die and that she was going to "re-break" her neck. Kaylee then began to thrash her head around at which time I grabbed ahold of the top of her head and the bottom of her chin and attempted to hold it in place while we awaited the custody van. After several moments of trying to thrash her head out of my grip her body went limp. I checked Kaylee's pulse and confirmed she was breathing. I informed Kaylee that I could feel her pulse and was watching her respirations as her chest rose and fell, and that she cannot pretend to be dead. Kaylee then woke up and reached her arm toward Officer's Robert's gun belt where she placed her hand atop of the holster containing his duty firearm. Kaylee was once more restrained.

Eventually the Marysville Police Custody van arrived and Kaylee was transferred into the restraint chair. I transported Kaylee from the Marysville Jail to the Snohomish County, the Snohomish County jail requested a medical clearance from Providence Hospital for booking. I transported Kaylee to Providence Colby Hospital. Along with Kaylee, we remained in the hospital for nearly 6 hours. A decision was made to change Kaylee's status to an involuntary commitment. I was nevertheless not permitted to leave the hospital by the charge nurse 'Kathy' who also voiced her opinion that she did not think it was right that we were now involving Kaylee. I explained to Kathy that Kaylee had made consistent suicidal statements and is not fit for booking at any jail. Kaylee was left in the care of Providence Colby Hospital.

**AUTHORITY:**

I, Rebekah Gibbs, am a Custody Officer with a limited commission by the City of Marysville, WA.

**ASSIGNMENT:**

- I am currently assigned to the Detention Division of the Marysville Police Dept.
- During this incident, I was wearing an approved Custody Officer uniform, including department patches, badge and Custody insignia.
- On the above date, I was working within the Marysville Jail located at 601 Delta Ave within the city limits of Marysville, Snohomish County, Washington.

**ELEMENTS OF CRIME/INCIDENT:**

On the listed date at approximately 20:15 patrol officers on scene at a physical domestic call requested a jail unit to bring the restraint chair to safely transport the female, MCCANN, KAYLEE, that they had in custody. We were advised that Kaylee was in a car accident 4-5 days prior and had a neck brace, arm cast on her left arm, and metal rods recently placed in her right leg. We were also advised she was suicidal, making comments about wanting to hurt herself or have police officers shoot her, as well as being assaultive towards officers and had grabbed for an officer on scene's gun. Myself and Officer Buell responded to the scene of the call at 12712 44<sup>th</sup> Ave NE Marysville WA 98271 with the restraint chair and once arrived were advised to standby as Kaylee was pretending to be asleep and not following any commands. At this time my body worn camera was activated. After a few minutes she was alert again and we brought the restraint chair into the backyard where she was hand cuffed to a chair and being restrained by 3 officers. I grabbed Kaylee's right arm and removed it from the handcuff attached to the chair, Officer Buell grabbed Kaylee's legs, Officer Roberts grabbed Kaylee's left arm, and Officer Stuver supported Kaylee's head as we transferred her into the restraint chair. I and Officer Buell placed the restraints on Kaylee's ankles, waist, wrists, arms, and shoulders. We made sure a finger could still fit between the restraints and Kaylee's body. We also made sure that the restraint over the left arm on her cast was not putting too much pressure on the injury. An aid crew on scene then evaluated Kaylee prior to transport. Kaylee was then moved to the jail van and put into the rear compartment using the lift. I rode in the back of the van with Kaylee to the Marysville Jail where Officer Buell was relieved by Officer Stuver as driver of the jail van. Officer Stuver and I then transported Kaylee to the Snohomish county jail due to her felony charges. Once at the Snohomish county jail, Kaylee was evaluated by the facility medical staff

and it was requested that we get a clear to book from Providence Medical Center due to Kaylee's injuries stemming from the recent car accident. At this time my body worn camera was deactivated. Officer Stuver and I then transported Kaylee to Providence Emergency Department. Again, I rode in the rear compartment with Kaylee in the restraint chair. We arrived at the emergency department at approximately 22:00 and were directed to wait in an alcove until we could be checked into a room. At approximately 23:30 Kaylee was removed from the restraint chair and allowed to use the restroom. She was unable to walk and needed assistance using the toilet so I and a female Everett Police Department officer were able to help escort her into the restroom and assist her in removing her pants and underwear so she could use the toilet. When finished, Kaylee was then placed back into the restraint chair. For the duration of our stay with Kaylee at Providence Officer Stuver and Myself constantly rotated Kaylee's limbs out of the restraints. She indicated that she had a lot of pain from her injuries so we allowed her to remove her right leg for most of the duration of the stay and be propped up on a stool for comfort. Her waist restraint was also loosened to relieve the pressure on her incision and a blanket allowed to be placed under her for comfort. Kaylee was also given blankets to support her neck and around 02:00 07/24/22 was given water and a sandwich from hospital staff. At approximately 00:00 07/24/2022 the patrol Sergeant on duty determined that Kaylee would be involuntarily admitted to the hospital due to her mental health and not booked into the county jail. The paperwork was submitted to the hospital staff and at approximately 03:15 07/24/2022 Kaylee was given a bed by hospital staff and we were cleared to leave. Her medications were given to hospital staff prior to us leaving the facility.
