• As of Monday, the City of Houston and bp have a tentative agreement in place.

Now awaiting signatures from both sides – Mayor Turner and William Lin – which is likely to take place later this week.

• Once signed, agreement will go to Houston City Council for final approval at a July 22 meeting (though it could first go public on July 16-17, when the Council agenda is first published).

• After Council has approved, the City of Houston and bp will issue a joint press release and further amplify news in our own channels and with key stakeholders as appropriate.

• The four-year MOU calls for bp to make a \$2M grant to the City to help with implementation of the City's Climate Action Plan.
