



In July 2019, the UK's former clean growth minister Claire Perry was appointed "president" of the 2020 UN climate talks. Perry left her energy and climate brief to take on the role as part of a UK government reshuffle, after Boris Johnson was elected prime minister by Conservative Party members. As energy and climate minister, Perry championed the "powering past coal alliance," a coalition of national and local governments and businesses committed to phasing

out unabated coal power, together with Canadian environment minister Catherine McKenna.

Perry introduced a clean growth strategy to decarbonise the UK economy, including heavy industry, and backed the introduction of a net zero emissions target. At the same time, she defended government support for fracking, in the face of protests.
