Sir, myself and Max are currently following up on the task that you gave regarding the Palestinian Americans and their affiliation with Standing Rock Sioux Tribe. Sir currently there are two groups sponsoring Palestinian Americans to travel to Standing Rock, North Dakota. The first group is called the Palestinian Youth Movement (PYM) They currently describe themselves as a "transnational, independent, grassroots movement of young Palestinians in Palestine and in exile worldwide as a result of the ongoing Zionist colonization and occupation of our homeland" On September 16 2016 The Palestinian Youth Movement stated "We, the Palestinian Youth Movement - United States Branch, stand in solidarity with Standing Rock Sioux, the Great Sioux Nation, and our other Native sisters, brothers, and siblings in the fight against the Dakota Access Pipeline (DAPL)" The PYM is currently in Standing Rock and currently we are monitoring any internet chatter that they produce. Sir the second group is called Samidoun which describes itself as the "Palestinian Prisoner Solidarity Network" most of its members are currently in Israeli custody currently staging a hunger strike or stating they are freedom fighters fighting for human treatment of Palestinians. The Samidoun released a statement regarding the situation in Standing Rock saying "Palestinian Prisoner Solidarity Network expresses its strongest support for the Sioux nation and Native resistance in confronting the Dakota Access Pipeline and defending indigenous land from ongoing threats and attacks on the land and environment. We stand in solidarity with the Camp of the Sacred Stones, the 2,200-mile run by indigenous youth and all other ongoing efforts to stop the pipeline and similar destructive projects" Sir it is my assessment that the **Samidoun** is the more radical group of the two and I am working with Max to find out who are the key players. I will keep you updated on the Intel we collect.
